MINUTES

CARA Monthly Meeting May 10, 2013

The meeting was called to order at 8:00 pm by KB1NYY, Roger. The Pledge of Allegiance was recited and the business of the evening was started.

The Treasurer reported a balance of \$10,096.22 in our account. Motion was made and seconded to accept this report and this was unanimously accepted.

There was a letter from Air Force MARS requesting to have an information table at our Hamfest in Sept. Joe, AB1DO will contact and co-ordinate with them.

Discussion of the future of Capers, our newsletter. The present editor has submitted a request to retire his position. Notice will be given in the next Capers and also on the upcoming CARA nets for a new editor.

N2MWD from Carmel, NY. was welcomed as the newest member of CARA.

Report from the Nominating Committee was given and also noted that they are

still accepting nominations for all positions. Voting will be at the June meeting.

The main business of the evening was given by Dan, W1QK and Harlan, W1QH about Field Day Set-up and Preparations. A slide show was presented with diagrams of the proposed antenna layout as well as the operating tents and stations. Each antenna will have a designated coax that will be clearly marked as to what band it Is for. There will be a 600ft rectangle loop, a B&W Folded Dipole, and 2 half-square antennas.

Discussion was given regarding the possibility of having a digital station in addition to the usual SSB and CW. This year there are more points to be gained by having a digital station. One point for SSB contacts and two points for either CW or Digital contacts.

A target was set of making 500 QSO's on each of the modes.

There was an overview of the use of the N1MM logger program that will be used this year, followed by many insightful questions about editing a missed call and individual tracking of the many different operators participating. There should be a master computer with the logger that will track the progress of the entire club QSO numbers.

Oscar Fuller was congratulated on his "temporary" appointment to acting DEC. Oscar reported on the proposed test of the new EOC IC-7000 radios that have been installed at 18 EOC's in our region. These units have been complete installations from power supply to antenna and will be tested for interoperability on August 3, 2013. Further details to follow. With no other business the meeting was adjourned at 9:30

FCC Seeks Small Vanity Call Sign Fee Increase

The FCC released a Notice of Proposed Rulemaking (NPRM) on May 23, seeking to raise the fee for Amateur Radio vanity call signs by 20 cents. Currently, a vanity call sign costs \$15 and is good for 10 years. The new fee, if approved, will go up to \$15.20 for 10 years.

The FCC is authorized by the Communications Act of 1934, as amended to collect vanity call sign fees to recover the costs associated with that program. The NPRM can be found in PDF format at,

The vanity call sign fee has fluctuated over the 15 years of the current program -- from a low of \$11.70 in 2007 to a high of \$70 (as first proposed in the FCC's 1994 Report and Order). The FCC said it anticipates some 14,300 Amateur Radio vanity call sign "payment units," or applications, during the next fiscal year, collecting \$217,360 in fees from the program.

The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign, but also upon renewing a vanity call sign. Those holding vanity call signs issued prior to 1993 are exempt from having to pay the vanity call sign regulatory fee at renewal, as Congress did not authorize the FCC to collect regulatory fees until 1996. Such "heritage" vanity call sign holders do not appear as vanity licensees in the FCC Amateur Radio database.

Amateur Radio licensees may file for renewal only within 90 days of their license expiration date. All radio amateurs must have an FCC Registration Number (FRN) before filing any application with the Commission. Applicants can obtain an FRN by going to the Universal Licensing System (ULS) and clicking on the "New Users: Register" link. You must supply your Social Security Number to obtain an FRN.

The ARRL VEC will process license renewals for vanity call sign holders for a modest fee. The service is available to ARRL members and nonmembers, although League members pay less. Routine, non-vanity renewals continue to be free of charge for ARRL members. Trustees of club stations with vanity call signs may renew either via the ULS or through a Club Station Call Sign Administrator, such as the ARRL VEC.

Invite a Kid to Field Day

If you've been around ham radio for any length of time, you'll notice that ham radio operators like to complain. One of the most frequently heard complaints is, "Kids aren't interested in amateur radio anymore." While I'm not so sure that's true, I do know that now is the time for you to do something about it.

How? Invite a kid to Field Day.

Invite them to help you set up antennas.

Show them how you power the rigs with a generator, or even cooler, by charging a battery with a solar panel.

Let them sit in front of the rig, show them how to make contacts, and log for them. To make it easier for them, make up a cheat sheet with the callsign spelled out phonetically and the exchange, also spelled out phonetically.

Let them operate for as long as they're interested. When they're done, thank them on contributing to your club's total score.

Answer every single one of their questions.

This may not win them over immediately, but I can assure you that it will make an impression on them. To increase your chances of success, find a kid that's already technically inclined. Invite a bunch of them from the high school's robotics team, for example.

If you don't have any plans for Field

Day, then make some. Then, go find that kid. If you don't, then you don't have any right to complain that there are no kids in ham radio.
