


























## N1NRP receives Quality of Courage Award from GBARC

## W1QK achieves a personal milestone during the CWOps CWT

Dan-W1QK, CARA Director, and Capers editor, reached a personal milestone on December 6th while participating in the 0300 UTC session (Dec. 7 UTC), of the CWT contest, which is sponsored by the CW Operators Club, known as CWOps.

He achieved a personal record of 96 contacts during the one-hour contest period; finishing in second place among 77 participating stations - operating within the single transmitter, low power (100 Watt), un-assisted category.

His final score of 7,008 points is a result of the contact total times a multiplier of 73, which is the number of different stations that were contacted during the event.

According to the Reverse Beacon Reflector, W1QK's CW speed was recorded consistently at 32 wpm, with an occasional reduction of this running speed.

W1QK was nominated by a fellow CWOps member in September, 2015 and sponsored by

eight members to become accepted as a Lifetime CWOps member. His unique CWOps membership number is 1506.

When operating in the CWT contests, competitors exchange their name and CWOps member number. For non-CWOps members, your name and state are exchanged.

Dan enjoys operating in the weekly CWT contests, and has been progressing in his CW and skills for several years. He finds that this weekly practice helps to maintain the edge for competitive CW contesting.

Besides the CWT's, W1QK participates in many State QSO Parties, the New England QSO Party, VHF contests, and the four major DX contests sponsored by CQ Magazine and the ARRL. He contributes his scores to the Yankee Clipper Contest Club, and the North East Weak Signal Group.


Several other CARA members; Roger-NG1R, and Marcus-AB1WV, are also active in the weekly CWT contests, which are held at 1300 UTC and 1900 UTC every Wednesday, and 0300 UTC on Thursday.

Dan celebrated 50 years as a licensed amateur radio operator in 2017, and has achieved 5BWAS, 5BDXCC, Triple Play, 6M VUCC, and has earned plaques and certificates in many CW, SSB, RTTY, and VHF contests and QSO Parties for fixed station and portable operations.

#### CARA wins Second Place, USA Multioperator, in the 2017 Kansas QSO Party de W1QK

As you may recall, a team of CARA members organized by John-W1JGM, Harlan-W1QH and Dan-W1QK, including N1GSA, W1NSK, KC1EHW and N1NRP, participated in the US/VE Islands QSO Party for the first time ever from Candlewood Isle on August 26.











John - W1JGM, secured permission from the Candlewood Isle Tax District for CARA to operate for the first time in this event from Candlewood Isle, which has a designation of 022L, which was used for our exchange in the contest.

The US/VE Islands QSO Party, Kansas QSO Party and Ohio QSO Parties were on simultaneously during the weekend. Harlan and Dan processed our N1MM+ logs and submitted them to all three contest sponsors. An .adif file of our contacts was uploaded to the W1QI LoTW (Logbook of the World).

We are still awaiting the results from both the US/VE Islands QSO Party, and the Ohio QSO Party.

Our W1QI score of 27 total 1x1 calls confirmed, 17 unique 1x1 calls worked resulted in CARA placing as the second place USA Multi-Operator finish in the Kansas QSO Party. There is a minimum of 50 contacts to qualify for a plaque.

This KSQP certificate as well as a personal note was received from Bob Harder, W0BH, the KSQP Coordinator:




Congratulations on your Second Place USA Multi-Op finish in the 2017 Kansas QSO Partyl. As a winner, you automatically earn a certificate and three antique radio stamps. Our certificate, which was first issued in 2015, is designed to display each of the nine antique radio stamps currently available, plus the new one for 2017.

The 2017 Kansas QSO Party featured 113 Kansas operators including 51 1x1 call operators and 15 mobiles on the eir spelling KANSAS, SUNFLOWER, QSOPARTY and BISON. For the seventh year in a row, we activated all 105 counties. In 2016, we had 325 submitted logs. In 2017, we had 395 logs (including yourst) and 53,268 valid QSOs (both records).

Some links fades over time, so you might consider framing your certificate to minimize this effect and protect your stamps. Our currently available stamps are described on the next page.

We hope you enjoy your certificate and stamp(s). We also hope you'll join us for our Tenth Anniversary Kansas QSO Party on August 25-26. Note that to be eligible for a plaque, we have a 50 contact minimum. If you have comments or suggestions, I'd like to hear from you.


Our certificate included several ham radio, communications, and electronics-related stamps. Besides the images, several **original** stamps were attached.

**Reminder**: The log submission deadline for most ARRL Contests is now FIVE DAYS after the contest end. This applied to Sweepstakes, and it applies to the ARRL RTTY Roundup coming up January 6.

The World Wide Radio Operators Foundation (WWROF) has announced the "KP4 Generator Project" to support the ongoing efforts of WA3FET, W1YW, K1VR, K1ZM, and others to gather funds for the purchase and shipment of generators to Puerto Rico in the wake of the devastation of the recent hurricanes. "Even now, many weeks after the storm, a significant percentage of the island's local hams are unable to send outbound health & welfare traffic because they have no power. As you can imagine, generators are in high demand and very short supply on the island... This project will raise funds to purchase Honda eu2000i generators for the amateurs of Puerto Rico. Well-known contester, Angel Vazquez, WP3R, will distribute these generators to local active hams for use in emergency-related communications and other applications based on situational needs." The WWROF will also match the first \$5000 in donations received from clubs and individuals. The WWROF is an IRSrecognized 501(c)3 organization and donations are tax-deductible for U.S. taxpayers to the extent allowed by law. Donations may be made via the **Donations** button on the WWROF website, or by check to the address on the WWROF Donations page.

DX Engineering has posted a brief 'unboxing' of the new lcom 7610 transceiver, and Tim, K3LR, makes a contact with it from N8DXE, DX Engineering's employee club station.

The technology behind the <u>transcription of</u> the Apollo space missions tapes is interesting reading, and indicates some techniques that might be employed in the future for making transcriptions of an SSB contest weekend. (Dennis, N6KI) PA5MW <u>tried to find the "best headphones for listening to 160m" in 2013</u>, using multiple people and multiple tests. Besides the data,

he's published suggestions on how to choose a set of headphones, and minimize risks for hearing loss.

The popularity of electronic games has spawned E-Sports leagues. Some teenaged players are approaching it like work, and why shouldn't they? They're getting paid a salary, they have benefits, and they have to keep competitive to stay on the team. ### Announcing: The ARRL International Grid Chase!

A new and exciting operating event will kick off on January 1, 2018, at 0000 UTC (New Year's Eve in US time zones), when the ARRL International Grid Chase gets under way. The year-long event hopes to build on the success of the highly successful 2016 National Parks on the Air (NPOTA). The objective is to work stations on any band (except 60 meters) in as many different Maidenhead grid squares as possible, and then upload your log data to ARRL's Logbook of The World (LoTW). Registration is free, and it costs nothing to use LoTW. Many hams are familiar with grid squares from the VHF/UHF and satellite realms, and everyone lives in one. ARRL's VUCC is based on grid squares, and some contests on HF, as well as on VHF and UHF, also use them as a scoring factor. John Morris, G4ANB, came up with the locator system, which the VHF Working Group adopted in 1980 at a meeting in Maidenhead, England thus the term "Maidenhead grid square." The

system divvies up the entire globe into 324 fields, each containing 100 grid squares 1° latitude by 2° longitude in size. With 32,400 potential grid squares, it's not likely that anyone will run out of challenges, even though some grid squares are surrounded entirely by water, are in areas that are uninhabited, or are difficult to access.

If you don't know your grid square, David Levine, K2DSL, has an online calculator. Just enter a postal address, ZIP code or a call sign, and his site will tell you the grid square for that location. For example, enter "W1AW" and the site will return "FN31pr." For the purposes of the ARRL International Grid Chase, though, just the two initial letters and the two numbers that follow (e.g., FN31) are all you need to know. Once you get active in the chase and start uploading your log data, each new grid square contact confirmed through LoTW will count toward your **monthly total**. Getting started is simple: Turn on the radio and call CQ or "CQ Grid Chase," or listen for others doing the same. Make the contact, exchange grid squares, log it, and move on to another. At the end of each month, your totals on the Grid Chase Leader Board will reset to zero, although the system retains all monthly data to determine top finishers in various categories at the end of the year.

Any contact you make in 2018 can count for your Chase score; it doesn't have to involve an exchange of grid squares. As long as the other operators participate in LoTW, you'll get credit automatically when they upload their logs. This means that contest contacts will also count, as will contacts with special event stations, or other on-air activity that uses LoTW to confirm contacts.

Some radio amateurs live in sparsely populated grid squares, and if you're one of those, you could find yourself handling a pileup!
Expeditions to hard-to-reach or rare grid squares will undoubtedly evolve. You also can

travel to one of those grid squares yourself. Some vehicle or hand-held GPS units can be set to display when you are in a particular grid square. Apps are available for smartphones or tablets, such as *Ham Square* for iOS devices or *HamGPS* for Android devices.

There are no restrictions on modes or bands, as long as they are legal. Satellite contacts are valid for the Chase. The event is open to *all* radio amateurs.

#### **Awards**

As all contacts are uploaded to LoTW, participants may use their contacts toward other ARRL awards, in addition to the overall monthly and annual Grid Chase recognitions. These other ARRL awards include the grid-based VHF-UHF Century Club (VUCC) and Fred Fish Memorial Award, as well as Worked All States (WAS), WAS Triple Play, DX Century Club (DXCC), and Worked All Continents (WAC). Complete details of the ARRL International Grid Chase will appear in the December 2017 issue of *QST*. The digital edition is available on Friday, November 10.

Most of us in the Contesting and DXing communities have undoubtedly heard or read something over the last few weeks about ARRL governance; and perhaps specifics about a set of motions that may come before the upcoming ARRL Board Meeting (January 19-20).

There are probably hundreds of individual documents, emails, and other communications floating around on the web and on club email reflectors discussing in some manner the ARRL Director Code of Conduct, the ARRL Censure of N6AA, and most recently the proposed changes to the ARRL Articles of Association and Bylaws which have become public knowledge.

If you want to know more, or simply need a quick primer to participate in discussions, listed below are several information sources that provide the basics and guidance on where additional information can be obtained. Please assist by forwarding this list to others who might benefit.

## Solar array draws lots of glares

Eco-friendly edifice in Beverly generates savings for resident, fury from neighbors



Nearby residents call it an eyesore, but Richard and Lola Eanes are happy with the energy savings their solar setup delivers. Richard and Lola Eanes's solar panels have drawn complaints from neighbors. They could be the last such array in Beverly, which is considering prohibiting them in front yards.

BEVERLY — It's not easy being green.

A retired couple might echo that lament after installing a ground-mounted grid of energy-soaking panels — dubbed "the solar monster" by onecity councilor — that has pitted neighbor against neighbor and sparked a vitriolic war of words.

"It's a foreign body, basically," said Mary Downing, scowling as she looked at her neighbors' carbonfriendly tower. "We don't want to be out on the deck in the summer, by the pool, and see that thing."

"That thing" is a stack of 20 solar panels that turns with the sun each

day and powers the four-bedroom home where Lola and Richard Eanes live. It hums rather than rumbles, moves a foot or two several times a day, and shuts down for the night.

"We have grandchildren, and we've been thinking about climate change and what has to be done to reduce energy," said Lola Eanes, a former private investigator who unveiled the unit last December. "It's a plus for the environment."

But on Putnam Street, a thickly settled stretch of older homes 20 miles north of Boston, neighbors have railed against the eco-friendly structure as if it were a landfill, saying its unsightly appearance offsets any environmental gains.

"It's a gross injustice. I couldn't be more upset about it," said Ted Downing, echoing his wife's objections. "It's so unresidential."

Neighbors have complained to Beverly officials, who say the tower does not violate any city regulations. And they have brought their complaints to the Eaneses, who have been taken aback by the angry reaction.

"They ganged up on me," Lola Eanes said. "It's a new thing, and maybe they don't like change."

Eanes said the complaints have ranged from the expected to the outrageous, including fears that the panels might emit cancer-causing radiation, cause massive erosion, interfere with Beverly Regional Airport, and emit a blinding glare.

Nonsense, Eanes said.

"What right do they have to call this an eyesore? Even the state wants everybody to go solar," she said. "Beauty is in the eye of the beholder."

And it's a boon for the budget. The couple paid for electricity only from June through September, four months when they turned on the air conditioning and circulated the water in their pool, Eanes said. Even then, the bill was far lower than the \$350 to \$500 a month they had paid before.

But neighbors condemn the tower as an out-of-place blemish that will depress property values and tarnish the neighborhood's character. Going green is great, they say. Just find another way to do it.

"It's not that we're against solar, but it belongs on the roof," Mary Downing said.

Neighbors also complained that they weren't warned about the plan.



The Eaneses "didn't say one word about what they were doing and how they were doing it," said Bill Soares, whose bedrooms face the panels. "One day I came home, and there were surveyors poking around, and I asked them, 'What are you doing?'"

He didn't like their answer. They were laying the groundwork for a 21-by-16-foot gray, metallic grid supported by an 11-foot tower wrapped in faux-greenery. It's only the second residential solar tower in Beverly, but its placement is what irks neighbors most.

"It is located physically closer to four other homes than the owner's home," Soares said. "I hold both the city and the Eaneses accountable for that callousness, lack of concern, and unsympathetic attitude toward the neighbors."

City officials said no notification or public hearings were required, but

neighbors argued that common courtesy should count for something.

The dispute is linked to the odd layout of the Eanes property, a "pork-chop" lot with a narrow strip of land that runs hundreds of feet from the street to the couple's home. The tower stands on that strip.

Some of the neighbors, once friendly, no longer speak with the couple. The rift might be permanent.

"We have a place in New Hampshire and get up there on weekends, so we really don't have much to do with them," said Richard Eanes, a former plaster contractor.

Compared with his exasperated neighbors, Eanes was diplomatic.

"I'm stuck with the property value diminished. I'm stuck with looking at the thing. And I'm stuck with a neighbor who paints the other neighbors as obstructionists," Soares said. "It's infuriating."

For her part, Lola Eanes said the real eyesore is the drooping telephone poles that line the streets.

"None of them stand completely straight. Some of them have large transformers on them. Some of them have coils of tangled wires attached, and they are all sagging," Eanes said. "Can these opposing neighbors really say that my sleek solar array with underground wiring to my home is less attractive?"

Sleek solar array or solar monster, the tower may be the last of its kind in Beverly, said city planner Aaron Clausen. The City Council is expected to review draft regulations early next year that could prohibit large, ground-mounted panels from front yards.

Whatever the outcome at City Hall, the "solar monster" of Putnam Street is here to stay, Lola Eanes said.

"We're not fighting anymore. It's there, it's done," she said, waving away the criticism with a flick of her hand. "It's really been quite a ride."
