# **November 9 CARA Meeting Minutes**



Meeting called to order at 8:00 p.m. by President Marcus Swearingen AB1WV at the Stony Hill Volunteer Fire house.

Pledge of Allegiance was recited.

After a round robin introduction session of those in attendance (14), Marcus AB1WV asked those that have served in the military self-identify; the club thanked them for their service to the nation. Minutes of the previous meeting were read and motion approved to accept the minutes.

## TREASURER'S REPORT

Tom Corey WX1T gave his treasurer's report:

Deposits \$ 107.50
Expenses/debits \$ (399.78)
End Bal \$5,097.12

He added that the bank adjusted -\$94.95 due to an erroneous credit from prior month.

## **OLD BUSINESS**

Roger NG1R purchased the club's OCFDipole for \$125.00 at the Nutmeg Hamfest/Meriden under budgeted/approved amount.

Previously tabled motion for CARA to endorse, as an officially sanctioned event, Jay's N1NRP December 4<sup>th</sup> social/dinner was reintroduced and passed. It was mentioned that since this will be a cash bar, the club in not "serving" alcohol and would not present a problem as far as insurance coverage. Jay reported that 42 people have signed up, exceeding the 40 person minimum.

Motion passed that this December 4<sup>th</sup> dinner be designated as the **CARA Holiday Party**.

Discussion occurred on the previously brought up idea of a Club "go box" (hf or vhf/hf). Antenna located at SHVFD also was mentioned. Harlan W1QH is working on the project.

Dan - W1QK, stated a modification will be necessary with respect the design of the new CARA banner. He contacted the CT ARES Website manager, who was unable to provide the CT ARES logo in a high-resolution data file, so it will NOT be included in the design, which now must be modified yet again. Winter Field Day January 26<sup>th</sup> & 27<sup>th</sup> (1900 UTC- 1900 UTC). Jay, Harlan W1QH, Bud and Charlie KC1IBR volunteered for the committee. Harlan will be checking on the SHVFD availability. Jay noted last year's score was 1360.

A brief discussion on a donation to the SHVFD for their graciousness in hosting our meeting location.

After a brief break, Dan – WIQK, gave a PowerPoint presentation on ARRL Affiliated Club contesting, since CARA is an ARRL Affiliated (and Special Service Club as well) and members qualify for the club competition.

# CARA registered for ARRL Affiliated Club Competition – Candlewood ARA

In order to make sure the club results are accurate and fair to all, the ARRL Contest Branch is renewing its effort to help clubs comply with the rules. (See section 8 of the General Rules for All Contests at <a href="https://www.arrl.org/qeneral-rules-for-all-arrl-contests">www.arrl.org/qeneral-rules-for-all-arrl-contests</a>.)

Here are the three changes:

- · Online uploading of club "Eligibility Lists",
- Use of six-character grid locators as locations, and
- Deadline for submitting eligibility is now the contest start time

# Online Uploading of Contest Club "Eligibility Lists" (updated)

Clubs will now have the ability to upload a club Eligibility Lists via an online web page, just like a contest log. Note that the Eligibility List is different than a club roster. A club roster typically includes all club members, no matter where they live or operate. The "Eligibility List" includes only those members who satisfy ARRL General Contest Rule 8.3.3 that they must reside and operate within the club territory, either a section or a circle. If your roster includes ineligible members, please remove them before uploading. (See the FAQ above for more information.)

Using this web page, a club secretary can upload the information and it will be time-stamped and stored. (The data format for the Eligibility List is provided below.) It will no longer be necessary to mail, email, or fax the club Eligibility List to the Contest Branch. You can go directly to the Contest Club Member Eligibility List Upload Page

All that's required is for the club secretary or other authorized member to upload a file containing the current club Eligibility List, including the club's section or the center of the club's eligibility circle. The web service will also provide a window for copy-and-paste from a text list containing the necessary information if that is more convenient.

This process has worked exceptionally well for submitting contest logs and has been accepted by the contest community as convenient and troublefree.

# **Eligibility Deadline**

With the online service available, the deadline for submitting an Eligibility List is also changing. Previously, clubs had 30 days following the contest to submit their Eligibility List. Putting contests on the same footing as all other competitions and to eliminate any temptation to pick only high scores or to engage in "category shopping," the eligibility deadline is being changed to the start of the contest, effective with the November CW Sweepstakes - 2100 UTC on 5 Nov 2016 - and will apply to all nine of the ARRL contests with a Club Competition (see General Rule 8.1).

The Eligibility List and club circle center can be changed and uploaded at any time, including repeated uploads, until the contest starts. If an individual member is added or deleted, just change the list and resubmit it in its entirety. The last Eligibility List and circle center to be submitted before the contest's start time will be used for that contest. A club can change its circle for each contest, if desired. All Eligibility List versions will be saved, just like contest logs. This is similar to the team registration process for NCJ-sponsored contests that has been in use for some time.

After an Eligibility List is submitted, it will be available for inspection online so that everyone can see which stations are claimed as eligible for a club. (Individual contesters can submit their score in support of any club they are eligible to support, of course.)

# **Discussion**

The Eligibility List service will NOT be used to enforce the club rules, only to allow other contesters to view the lists and to make it easy for the clubs to follow the rules. Challenges can be made through the Contest Branch as they are now. The minimum log totals for each club category will remain the same.

Release Candidate "RC4" of WSJT-X is available, see the announcement here. The developers urge anyone upgrading to the new version to read the release notes thoroughly, since the upgrade requires operator settings changes and may not work "out of the box" when upgrading from previous versions. This latest version of WSJT-Xremoves compatibility with earlier versions of the software in certain circumstances.

Well-known contester and CQ Contest Hall of Fame member Paul, W0AIH, passed away on October 31. *NCJ* Editor, Scott, K0MD, penned a tribute to Paul, describing his life and touching on why there's been such an outpouring of emotion from the Amateur Radio and contesting community about his passing.

Scott, KA9FOX, has spearheaded an effort to establish a W0AIH Memorial Scholarship fund (to be administered by the ARRL Foundation). According to the GoFundMe page: "On October 31, 2018, the amateur radio world lost one of its best ambassadors, Rev. Paul Bittner, WØAIH, at age 84. Licensed for nearly 70 years, Paul built one of the largest ham radio stations in the world, and for decades, opened it up for others to use and operate. Over the years, Paul also helped countless hams to get on the air, or to improve their

stations, by installing their towers and antennas. Paul never passed up an opportunity to help a fellow ham. As a remembrance to this great, giving man, we would like to establish The Rev. Paul E. Bittner, WØAIH, Memorial Scholarship via the ARRL Foundation. This will be a permanent award, with a \$1,000 scholarship awarded each year to a deserving young amateur radio operator pursuing higher education (to be used for tuition, books, fees and other educational expenses)." It's not necessary to use the GoFundMe website if vou're interested in contributing, instructions are on the website for those that prefer to send a check.

# Winter Field Day is Just Ahead

Field Day is not just for summertime anymore. Winter Field Day, sponsored by the Winter Field Day Association (WFDA), will take place over the January 28-29 weekend, and it can be a terrific time to prep for ARRL Field Day in June. The annual event's stated purpose is to encourage emergency operating preparedness in the winter, but it's also an excuse to get out of the house and eniov the great outdoors. According to the WFDA. getting ready for emergency communication in a winter environment is just as important as the preparations and practice that take place each June during ARRL Field Day, and — let's face it it's not cold and snowy everywhere during the winter months. Your local climate could be guite the opposite.

"Don't let those winter doldrums keep you locked up in the house," the WFDA says. "Get out and play some radio!" The WFDA said it believes that maintaining operating skills should not be limited to fair-weather scenarios.

The event, which got its start in 2007, is not restricted to North America. All Amateur Radio operators around the world are invited to participate, and there are three entry categories — indoor, outdoor, and home. The **rules** are similar to those for ARRL Field Day. Operation will take place on all HF bands except 12, 17, 30, and 60 meters, as well as on VHF, UHF, and satellite.

The event runs 24 hours. US and Canadian stations exchange call sign, operating category, and ARRL or RAC section.

The WFDA encourages both group and solo operation, and if you're not up for an outdoor winter adventure involving Amateur Radio, you can operate from the comfort of your shack. As the WFDA says on its **Facebook page**, "The object is winter fun!"




Figure 1 — The motorized inverted-L antenna system is built around a ground-insulated aluminum flagpole vertical element, and a loop of nylon monofilament and thin stranded copper wire that form the horizontal element, which is electrically connected to the top of the flagpole and is played in/out to tune the antenna to resonance.




Figure 6 — Shown at (6A) is the horizontal element far-end turnaround pulley, adapted from a standard clothesline pulley yoke. At (6B) is the turnaround pulley mounted high aton my house

# **Tower Leg Grounding**

De Chet – N8RA From the YCCC Scuttlebutt

Ward Silver, NOAX, in his book: "Grounding and Bonding for the Radio Amateur" states: "use proper techniques for connecting dissimilar metals when connecting the (grounding) radials to the tower. Most towers are zinc-coated steel (galvanized). Connecting a copper wire or strap directly to the tower leg will cause the zinc to erode, allowing the base steel to oxidize (rust). This in turn will increase the resistance of the connection and over time may threaten the mechanical strength of the tower segment. One solution to this problem is to use a buffer layer of stainless shim stock between the zinc and the copper. ...stainless steel shims also work when connecting copper to aluminum, such as tower legs. Copper should not be connected directly to galvanizing or aluminum." In the past I had used a tinned crimp lug on a leg bolt; but to get enough contact force for the high transient current it might have required tightening the bolt to the point of distorting the tower leg tubing. In my new tower installation, I used grounding clamps as shown in the photo. For the shims I purchased a 0.024" thick 6" x 12" 304 stainless steel (SS) sheet from McMaster Carr (P/N 8983K121) for about \$5. Though I could cut it into the right size pieces with hand shears, it was close to the limit of that tool. 304 stainless steel also tends to tarnish a little out in the weather. Smear a very thin coat of dielectric grease on the inside of the shim and the clamp's teeth to protect the contact areas from the environment. If I were to do it over, I'd try thinner 316 stainless. McMaster Carr offers convenient 2" wide strips: 2" x 12" 0.015" thick 316 stainless, enough for 3 legs (P/N 9090K3 for about \$6.00), or a 2" x 24" piece for \$11. Round out your order with some SS U-clamps, machine screws, or boxes of lock washers, flat washers and nuts for your antenna projects to spread out the shipping and handling costs.

Lots of signals, but not many decoding.

But, this is day 1. I am sure people will upgrade quickly. I hope that now that it's no longer in Beta, people will upgrade.
Based on observations since the first Beta of 2.0 was released. I'd say there was a 25:1 ratio of

was released, I'd say there was a 25:1 ratio of users of the old 72-bit protocol vs. users of the new 77-bit protocol in 2.0 beta releases. It seemed that only a few wanted to give it a try.



# Seismic waves vibrated off an island near Africa and hit Canada. Their cause is a mystery

The unusual seismological phenomenon originated near the island of Mayotte, off the coast of Madagascar on Nov. 11.

They were detected early on by Twitter user @matarikipax, who posted U.S. Geological Survey data showing they were detected at a monitoring station in Kilima Mbogo, Kenya. View image on Twitter




This is a most odd and unusual seismic signal.

The same user tweeted that waves were also detected in Zambia, Ethiopia, Spain and New Zealand.

<u>John Cassidy</u>, an earthquake seismologist with Natural Resources Canada (NRCan), later joined the fray, saying that the waves had been detected right across Canada, in Victoria, Haida Gwaii, Toronto, Ottawa and Halifax.

# WSJT-X 2.0 is a major upgrade

# **Description**

WSJT-X implements communication protocols or "modes" called FT8, JT4, JT9, JT65, QRA64, ISCAT, MSK144, and WSPR, as well as one called **Echo** for detecting and measuring your own radio signals reflected from the Moon. These modes were all designed for making reliable, confirmed QSOs under extreme weak-signal conditions. All but **ISCAT** use nearly identical message structure and source encoding -- the efficient compression of standard messages used for minimal QSOs. **JT65** and **QRA64** were designed for EME ("moonbounce") on the VHF/UHF bands; **JT65** has also proved popular and effective for worldwide QRP communication at HF. **JT9** is optimized for the LF, MF, and HF bands. It is about 2 dB more sensitive than JT65 while using less than 10% of the bandwidth. With either JT9 or JT65, world-wide QSOs are possible with power levels of a few watts and compromise antennas. JT4 and QRA64 are optimized for EME on the VHF and higher bands, and especially the microwave bands from 2.3 to 24 GHz. FT8 is operationally similar to JT65 but is much faster, using T/R cycles only 15 s long. MSK144 is used for Meteor Scatter on the VHF bands. Finally, as described more fully on its own page, WSPR mode implements a protocol designed for probing potential propagation paths with low-power transmissions. WSPR is now fully implemented within WSJT-X, including automatic band-hopping.

The current General Availability (GA) release is **WSJT-X Version 1.9.1**. A list of new features and enhancements since Version 1.8.0 is available <u>here</u>. One of the new features is <u>FT8 DXpedition Mode</u>, and to use it you <u>must</u> upgrade to Version 1.9.1.

**Please note:** Versions of *WSJT-X* labeled with a "-rcx" suffix, for example *WSJT-X* v1.9.0-rc5, are "Release Candidates" sometimes offered temporarily for beta testing purposes. If you participate in these beta tests you are expected to report back to the developers on your experiences. You should upgrade to the GA release when it becomes available. The -rcx program versions are not suitable for long-term general use.
