Furthermore, there are plans to try and do at least one activation a month.



Meeting called to order at 8:00 PM by Pres. Marcus Swearingen.

Each table seats 8. We have filled the first table and working on the second table!



ARRL has filed an interim report with the FCC in order to report on

its efforts to find common ground regarding issues surrounding the

"symbol" or "baud" rate proceeding, FCC Docket WT 16-239 (the FCC

has issued a Notice of Proposed Rulemaking in WT 16-239, which

stemmed from ARRL's rulemaking petition RM-11708).

ARRL highlighted that the public benefits from the FCC's "fairly

flexible" regulation of Amateur Radio. In particular, innovative

developments in digital technology, including WSJT-X, were cited.

Noting that more than 1,400 comments in total have been filed in

this and on a related rulemaking petition (RM-11831), ARRL pointed

out that, as in other Commission-regulated areas, adapting current

regulations to rapidly evolving technology presents challenges that

may require adjustments to, or clarifications of, the governing

regulations. Making such adjustments can be a challenge to ensure

that valid regulatory purposes continue to be served without

stymieing technological change and innovation in the process.

While a June 11 meeting organized by ARRL had to be reset to

accommodate the invited parties, ARRL has reaffirmed its commitment

to protecting the interests of all amateurs. ARRL said it will

continue to pursue its efforts to address and reconcile differing

opinions expressed in the two matters now pending before the FCC.

Radio Amateur to Lose License as Part of Enforcement Case Settlement

A New Jersey radio amateur, David S. Larsen Sr., WS2L, of Highland Park, will surrender his Amateur Extra-class license and pay a \$7,500 civil penalty as part of a *Consent Decree* with the FCC to settle an enforcement action.

An FCC Enforcement Bureau *Order* released June 18 said Larsen violated the Communications Act of 1934 and Part 90 rules by operating on frequencies licensed to the Borough of Highland Park for public safety communication.

As part of the settlement, Larsen agrees that he will admit making the unauthorized transmissions, not engage in unauthorized use of a radio station, and surrender radios in his possession capable of transmitting on the town's public safety frequencies. If the Commission finds that Larsen has made unauthorized radio transmissions or otherwise violates the terms of the *Consent Decree*, he'll be subject to an additional \$32,500 civil penalty. The agreement stipulates that Larsen may not apply for a new Amateur Radio license for 3 years.

The case stems from a May 2018 complaint of unauthorized transmissions on the Highland Park

municipal radio system. FCC agents followed up with several visits to the town.

"Based on information provided by the complainant and direct observations by the Bureau's agents, the unauthorized transmissions consisted of brief, pre-recorded sounds (such as the sad trombone sound)," the FCC said in the *Consent Decree*. The FCC said individuals the agents interviewed identified Larsen — a former rescue squad volunteer — as the person who was likely responsible.

Responding to an FCC Letter of Inquiry, Larsen subsequently contacted the Enforcement Bureau and related that the unauthorized transmissions had ceased. Last fall, Larsen, responded to the inquiry through counsel to deny making the unauthorized transmissions. A short time after that, the unauthorized transmissions resumed, and the FCC resumed its investigation, attempting to trace the source of the transmissions. Last March, agents used direction-finding equipment at a fixed location near the complainant's residence, while other agents conducted mobile direction finding of Larsen's vehicle in transit.

"The four agents observed Mr. Larsen pull over to the side of the road on the way to his home," the *Consent Decree* recounts. "The four Bureau agents observed (a) that during the brief stop, Mr. Larsen remained in his vehicle, (b) while stopped, a brief transmission consisting of the sad trombone sound emanated from the direction of Mr. Larsen's vehicle on a frequency licensed for use by the Highland Park Radio System, and (c) following the transmission of the sad trombone sound, Mr. Larsen resumed his drive to his residence."

The FCC said agents returned in April to observe Larsen repeat the earlier behavior, including a similar transmission emanating from Mr. Larsen's vehicle, according to the *Decree*.

CARA 2019 Field Day - Tasks and Responsibilities

The purpose of this document is to provide details of tasks and responsibilities that are involved with the CARA 2019 Field Day activity, which is scheduled for the weekend of June 22-23, 2019. Arrangements have been made with the City of Danbury via Paul Estefan for the use of the Red Barn Environmental Education building and the area adjacent to it at Tarrywile Park, Southern Boulevard.

CARA members are encouraged to sign-up for multiple items to ensure that all tasks are adequately covered. This is your club – it only works with TEAMWORK. The level of involvement and commitment will directly affect the planning for, and execution of this event. *Document revision date: July 6, 2019*

1. Coordination with Tarrywile.

Establish contact with Tarrywile officials. Ensure CARA compliance with Tarrywile regulations concerning access, times on site, parking, and other details.

2. FD Entry class & Radio Equipment

Determine FD entry class (2AC)? Determine/arrange for shelter for outdoor station. Determine station equipment needs & arrange transportation. Arrange and perform set up/take down for both stations. Create Excel checklist indicating items and sources. Confirm FD stations are operational before FD begins. Install ground rod for outdoor station, and ensure indoor station is properly grounded. Provide N1NMM+ common operating hints (documentation) for both stations. Provide equipment manuals for operator reference.

3. Antennas

Create antenna setup diagram. (Determine what will be used, and where it will be installed) Antenna selection and placement should allow optimum flexibility in band selection and performance, with minimal co-interference. Attach labels to each FD station antenna. Attach safety streamers to antenna supports, cables, feedlines and other antenna components to ensure safety compliance. Ensure that CARA bandpass filters are installed and used at FD stations. Install/take down antennas. Arrange for

transportation of CARA assets including antennas, rope, and coaxial cable feedlines to/from the Bethel EOC.

4. Operator shifts and event coverage

Create a Sign-Up Genius format using web application. Distribute via CARA Reflector. Ensure that the entire time we're committing for is covered.

Answer questions related to operator shifts. Provide timely updates to FD Leadership/Management team.

5. Food/beverages

Menu, budget, requisition/transportation of supplies. Means for on-site cooking, refrigeration, etc. Set up/take down of field kitchen.

6. Public relations on site during the event (Visitor/Greeter canopy/table)

7. Safety & Security Officer(s)

Mark all hazards on the FD site including coax cables, antenna supports, ground rod wires, etc. Ensure that fire extinguisher locations are known by all. Ensure that a properly equipped First Aid Kit is available during the entire FD event. Perform all the requirements stated on the ARRL Safety Officer FD Checklist document. (from ARRL Website) Provide appropriate security for CARA members, visitors/guests, equipment and assets.

8. Bonus points

Reference the ARRL FD Rules & determine which bonus points to complete the requirements for. Provide the means to execute tasks to earn these bonus points. Includes creating and sending the CARA FD message to the ARRL CT Section Manager, creating and handling formal traffic (maximum of 10 messages) via the FD station(s) during the event. Making satellite QSO. Writing and distributing of the CARA FD Press Release – inviting the media to attend and cover the event. Setting up a CARA FD social media Facebook page, and uploading content during the event. Registering the CARA FD site on the ARRL Website.


