He also recommended a PIC. Public Information Officer. Also, an Activities Committee. These positions are open to all members of the club.

Dan requested that the articles and reports for the CAPERS be **submitted by the deadline date**. The last few months there have many late submissions. This makes it very hard to have this paper done by the print date.

John has the membership list for sending to the receiving this email please let him know.

Dan spoke about the reflector to move to Groups: io. After conversation with Jim WO4X it was determined that there needs to be an administrator selected for Groups: io. It would be a task to move the past reflector archive messages to the new platform, but it is doable. This is available by the month or subject.

Field Day was brought up. Dan was called upon to give an overview of the Field Day rules change for 2020 due to the Covid 19 pandemic. ARRL has made a between class D stations and individual scores can be combined for Club scores. These must be submitted with Candlewood ARA as the club to be counted.

ARRL should be notified with the updated officers. Gary will take care of this update. The bank information also has to be updated

Roger spoke about the financial obligations for the year and also that the Hamfest will probably not happen. A budget should be proposed and put in place to make sure that we keep within our means. The new officers also need to keep in touch with the local EMD's as to the availabilities of funding available.

Dan mentioned the upcoming VHF contest this weekend and requested all to get on the radio and make some contacts.

## 2020 ARRL FD de N1IBQ:

Hi Dan, yes you can include my story in the Capers.

I haven't calculated my score yet. But it will be a record low!

I have to figure out any bonus points I can claim.

Since all of my equipment (except the 949D) was brand new and unfamiliar, I should have set it up and tested it out a week earlier.



So, this was my first Field Day in over 30 years licensed as a Ham!

My objective was to set up a portable station and see how it would work out.



The rain on Sunday had me setting up at the door of my garage.



The equipment was a Yaesu FT-891, an MFJ 949D tuner, a Supper Antenna MP1LX portable antenna (80M through 6M) and a Group 27 Deep Cycle gel-cel marine battery.




It took a while to figure out what was causing my terrible SWR. Kept going to the antenna making many minor adjustments to the sliding coil until I finally figured out the problem was the old feedline plug. Then the rain came.



To charge the battery, I had a 100W solar panel, but with the rain and clouds, I didn't get to use it.

Fortunately, the battery held out, and I cut my power to 50W. Not a lot of contacts - since I initially wasted time fussing with a new automatic antenna tuner, and finally dragged out my 30-year-old MFJ 949D. But, 20M opened up to Japan on Sunday afternoon, and all was not lost.



But – overall, a great learning experience and the first time I'd been on the HF bands since 1991.

I got the radio, antenna and LDG AT-100pro II auto tuner to start working POTA stations.



I got a RigExpert AA-230 a few days before the weekend, and it really saved my bacon. I had an old length of RG8/X feedline that apparently had a bad PL-259.

Forgetfully, I started out using it instead of my brand new 50ft of LRM400 UF Cable.

I did all that, and Social Distanced at the same time!

## Temporary Rule Waivers for ARRL Field Day 2020

5/28/2020

With one month to go before 2020 ARRL Field Day, June 27-28, the ARRL Programs and Services Committee (PSC) has adopted two temporary rule waivers for the event:

1) For Field Day 2020 only, Class D stations may work all other Field Day stations, including other Class D stations, for points.

Field Day rule 4.6 defines Class D stations as "Home stations," including stations operating from permanent or licensed station locations using commercial power. Class D stations ordinarily may only count contacts made with Class A, B, C, E, and F Field Day stations, but the temporary rule waiver for 2020 allows Class D stations to count contacts with other Class D stations for QSO credit.

2) In addition, for 2020 only, an aggregate club score will be published, which will be the sum of all individual entries indicating a specific club (similar to the aggregate score totals used in ARRL affiliated club competitions).

Ordinarily, club names are only published in the results for Class A and Class F entries, but the temporary rule waiver for 2020 allows participants from any Class to optionally include a single club name with their submitted results following Field Day.

For example, if Podunk Hollow Radio Club members Becky, W1BXY, and Hiram, W1AW, both participate in 2020 Field Day — Hiram from his Class D home station, and Becky from her Class C mobile station — both can include the radio club's name when reporting their individual results. The published results listing will include individual scores for Hiram and Becky, plus a combined score for all entries identified as Podunk Hollow Radio Club.

The temporary rule waivers were adopted by the PSC on May 27, 2020.

ARRL Field Day is one of the biggest events on the amateur radio calendar, with over 36,000 participants in 2019, including entries from 3,113 radio clubs and emergency operations centers. In most years, Field Day is also the largest annual demonstration of ham radio, because many radio clubs organize their participation in public places such as parks and schools.

Due to the COVID-19 pandemic, many radio clubs have made decisions to cancel their group participation in ARRL Field Day this year due to public health recommendations and/or requirements, or to significantly modify their participation for safe social distancing practices. The temporary rule waivers allow greater flexibility in recognizing the value of individual and club participation regardless of entry class.

ARRL is contacting logging program developers about the temporary rule waivers so developers can release updated versions of their software prior to Field Day weekend. Participants are reminded that the preferred method of submitting entries after Field Day is via the <a href="web applet">web applet</a>. The ARRL Field Day rules include instructions for <a href="submitting">submitting</a> entries after the event. Entries must be submitted or postmarked by Tuesday, July 28, 2020.

Editor: Use Candlewood ARA when submitting your score via the web applet.

Please read this important update from our convention chair, Bob DeMattia, K1IW, regarding the impact of the COVID-19 pandemic on the 2020 convention:

Hello All,

I hope this message finds you safe and healthy. After long consideration, the convention committee has decided to postpone the 2020 HamXposition to the weekend of November 6th through 8th.

There are several reasons for this, the first and foremost is the health and well-being of our attendees. In addition, there are many logistical problems with holding the convention in July, even under the most favorable conditions of the pandemic emergency being over by then.

We believe it is unlikely that the state's ban on large gatherings will be completely lifted by the end of July.

Even if it were, we believe attendance will be severely impacted due to lingering (and quite appropriate caution).

Almost all of our exhibitors are unwilling to commit to anything prior to June.

The convention is subject to penalties for cancellation. The penalties increase as we get closer to the convention date. By moving to November, we move out the schedule on these penalties. This will allow us to reassess the viability of the convention in early August. By then we will have further insight into prevailing conditions.

The November weekend was the only one available to us and could be lost to another group if we did not act on it. We know that many look forward to attending each year, and presentations that are hard to do in person, I've have probably grown weary of all the cancellations of events decided to offer 4 sessions on Operating specific like these.

However, given the reality of the situation, we believe it is in everyone's best interest to postpone.

Good morning all,

I'm thinking of an upgrade in the shack after the last VHF death match on 6M. My specific questions is: how is the selectivity on the IC-7300? I'm leaning towards this because of the band scope and cost.

What Rudy says is true, but that does not mean the 7300 is as great on 6m. I own one and I love it. It is a great bargain. It does not have superpowers.

On 40m you should run with the preamp off. By the time you get to 10m, you will need at least preamp 1, by 6m, preamp 2 is a must. Here's the rub. The 7300's weakness is that is it prone to overload. When this is happening, you will see OVF on the display. In those conditions, the radio does not behave wonderfully.

I am not a VHF op, so I would recommend that you listen to VHF ops on their opinion.

The IC-7300 is worth at least 50% more than its price, but it is not a high-end VHF radio.

I don't think the spectrum display on 6m is as useful as it is on lower bands. I think it is less sensitive on 6 (I have no proof - just a perception from limited use). This lack of sensitivity is important in VHF contesting. It's not so important in HF contesting.

## Rescued Radio Amateur Says, "Ham Radio Saved My Life"

ARRL member Alden Sumner Jones IV, KC1JWR, of Bennington. Vermont, is thankful for amateur radio, after he suffered a medical incident and lost consciousness on June 15 while hiking with others along a remote section of the Long Trail, not far from his home. An EMT from Appalachian Mountain Rescue (AMR), who was hiking nearby, saw Jones pass out but was unable to connect with 911 via his cell phone. Jones, 41, regained consciousness and was successful in contacting Ron Wonderlick, AG1W, via the Northern Berkshire Amateur Radio Club's K1FFK repeater on Mount Greylock, and Wonderlick initiated what turned into an 8-hour effort to get Jones off the trail and to a medical facility, acting as a relay among Jones, emergency crews, and other agencies involved. As the Bennington Post reported, "The Vermont State Police also received assistance from several licensed amateur radio operators who helped facilitate communications, greatly assisting in the rescue."

Matthew Sacco, KC1JPU, headed to a staging area where rescue crews were gathering. When he could not make it into the repeater, he employed some ham radio ingenuity to fashion a J-pole antenna from some window line he had on hand, casting it into a tree using a fishing pole. That did the trick. An individual on site was able to obtain an accurate location for Jones using the GPS on his cell phone.

After it was determined that rescuers could not reach Jones using an all-terrain vehicle, arrangements were made to have a search-andrescue crew from New York retrieve Jones by helicopter. Amateur radio participants were able to relay critical information, including an accurate location, as preparations continued.

Jones, meanwhile, took advantage of his time with the EMT and other rescuers to talk up amateur radio and explaining how to get licensed. According to one account, rescuers were having trouble making contact with the helicopter, so Jones loaned them a better antenna he happened to have. Jones was eventually flown to a hospital in Albany, New York, again taking advantage of the occasion to promote amateur radio to the helicopter pilot and crew. Jones is said to be recovering.

"Ham radio saved my life last night, and I am very thankful for how everyone helped me," Jones said afterward.



### OPERATING TIP

## After A Contest, Send In the Log Immediately

As soon as you can after the contest, send in your log to the contest sponsors. Your log is what you copied during the contest; no changes are necessary. With the contest over, the log should be ready to send. Generate the Cabrillo file, and submit it via email or the contest sponsor's website. With most major contests moving to shortened submission periods, it's all too easy to forget about it and miss the log submission deadline.

Hello all,

I appreciate all the FD info. I can relate to so much of it.

My first FD was in 1980 and was just me and N3AM (#6), who was one of my early mentors. We did it at a park up in MD. I remember that we got gnats in the meter movement of the FT-101 and June bugs arcing in the power supply. Memorable, for sure!

After that ONE time, I had enough of the bugs, eating you alive, after dark. The next time I remember was with a club in N. VA (Mt. Vernon ARC), where I stacked pallets up outside of a 10 x 10 wall tent, and had an 15,000 BTU A/C unit blasting cold air into the tent.

Many FD's later, I bought a 24 foot enclosed car trailer, which Larry, K7SV, and I stripped, insulated and rebuilt the interior. Wound up installing a roof mounted A/C (gotta have it), 2 benches with 4 op positions, 2 bunks and a hot tub in the basement!


## SUBMITTING YOUR SCORE FOR FIELD DAY

JUNE 29, 2020 ANITA KEMMERER LEAVE A COMMENT

Field Day 2020 is now over and you have until Tuesday, July 28th to submit your log and bonus points. Members can find details in our <u>Field Day Forum</u> on the bonus points that we achieved as a group. Here are some guidelines on how to submit your score.

## Steps to Submit your Score

- 1. Export a Cabrillo file from your logging software
- 2. Capture the breakdown of your score by band and mode from your logging program. For <u>N1MM</u> it is the score window.



N1MM Score Window

- 3. Collect the evidence required for your bonus points:
  - Natural Power Bonus List of QSOs made on natural power
  - Formal messaging Copies of each message you originated, relayed or received (up to 10)
  - Message to ARRL Section Manager (Copy of fully serviced message)
  - Field Day Bulletin an accurate copy of the message
  - Publicity from the local media a copy of a press release sent to the local media or a copy of the actual media publicity received.
- 4. You can submit your score via the web form provided by <u>ARRL</u>. The link to this is <a href="http://field-day.arrl.org/fdentry.php">http://field-day.arrl.org/fdentry.php</a>
- 5. On the web form, fill in your information (Call, ARRL Section, Number of Participants, Entry Class, etc.) For the *Club or Group Name*, you can enter **Nashua Area Radio Society** so that your points count toward our club score.
- 6. Check off the bonus points that you earned and upload the documents that you collected in step 3.
- 7. Use the score breakdown from your logger to fill in the Band/Mode QSO Breakdown. Note that you may need to combine your QSOs from multiple digital modes on each band to fill in the Digital QSO columns. For example, in the Score window illustrated above, on 40 meters, we had 128 FT4 QSOs and 9 FT8 QSOS, so I would enter 137 for the total 40m digital QSOs.
