#### Plan to attend the November 10 Meeting Presentation by Jim Anderson, AJ1MJ



I will relate how the analysis of a ferrite toroid core choke balun was confirmed with an actual measurement of attenuation. I'll also explain how the "L" network and impedance transformer used to interface to an end-fed half wave vertical for 20 meters were analyzed for 50 Ohms without residual reactance.



The math amounts to some algebra (first year), but with the addition of the imaginary part representing reactance. I will go into this to a degree that participants would be able to do it themselves.



What I would like to accomplish with the results of this, is to help fellow hams improve their analytical abilities of antenna and transmission line projects.

I was educated in undergraduate school at Carnegie Tech (Carnegie Institute of Technology, in Pittsburgh, PA). Since then`, the college amalgamated with Mellon Institute and is now known as Carnegie Mellon University. My degree from there is BSEE.

I worked about two years at a company near Pittsburgh in VHF (160 MHz) communications.

I left Pittsburgh in 1965 to work for the Perkin-Elmer Corporation. There, I was doing electronics for an airborne laser scanner for night reconnaissance. This is also where I was introduced to lasers and supporting optics (for the 500 nanometer band, haha!) In 1970, I went to RCA in Hightstown, NJ as the "optical guy" for a laser scanner putting high resolution imagery on high resolution reconnaissance film. We had to

solve a number of new technical problems to make that system work.

In 1974 I worked at what was then called Hewlett-Packard (now "Agilent") where an optical detector was proposed for spectroscopic gas analysis. We worked in the ultraviolet and even the vacuum UV. This included diffraction gratings and both semiconductor and vacuum (photomultiplier) photodetectors.

After that, there was the work at Macbeth division of Kollmorgen Corporation in Newburgh, NY, where optical instruments such spectrophotometers were produced. Zenon flash lamps were used, and their own spectrum was deteriorated by the spectroscopy of the eroding metals, so that we were working on a solution to either suppress or compensate for the tungsten and barium emission.

Later, working for Barnes Engineering here in CT, we were working on attitude control for satellites, using CO2 emission in the thermal infrared. At that time, I had suggested using a CO2 laser in an optical heterodyne system that could greatly improve sensitivity and thereby functionality. However, it would have required some significant development to produce and viable product. More to the point in Ham Radio, I have been working on the physics of ferrite materials to better understand the consequences of the two contributions of relative permeability (mu-prime and mu-double prime) as a function of frequency. This led to an analysis of devices using ferrites for devices such as choke baluns and impedance matching devices - "L" networks and transformers. This allowed experiments and mathematical analysis (predicting performance) to come to rather encouraging agreement.



To generate observations of propagation by the **<u>Reverse</u>** <u>**Beacon Network**</u> and <u>**PSKReporter**</u> event logs before, during, and after the eclipse on the amateur bands for the purpose of ionospheric sounding.



#### September is SepticSmart Month!!

*The average lifespan of a septic system is 15 to 40 years, but it can last longer if properly maintained!* 

Improperly maintained or failing septic systems can be a problem for many homeowners.

Following are a few tips for maintaining and preserving your septic system:

- Have your system inspected every 3-5 years by a licensed septic system service provider.
- Plan to have the tank pumped every 2-3 years. Just like changing the oil in your car, preventive septic system maintenance will extend the life of your system for a small cost compared to the cost of replacing the system.
- Think at the sink many household items can either clog your system or kill the microbes that treat the wastewater; e.g. wipes, coffee grounds, grease, and high amounts of anti-bacterial soaps and detergents.
- Don't strain your drain the less water you use, the less your septic system has to work. Stagger the use of

appliances and repair any leaks in your home.

- Eliminate or limit the use of a garbage disposal. This will significantly reduce the amount of fats, grease, and solids that enter your septic system and could clog it.
- Plant trees away from the drain field since tree roots can clog the field and cause the system to fail.

# How do I know if my septic system is not working properly?

- Wastewater backing up or gurgling into household drains.
- A strong odor around the septic tank or drain field.
- Bright green, spongy grass appearing on the drain field

#### Family sues Google alleging its Maps app led father to drive off collapsed bridge to his death, attorneys say

#### CNN —

Google has been sued by the family of a North Carolina man claiming the company's Maps application last year led him to drive off a collapsed bridge and fall about 20 feet to his death, according to the lawsuit.

Philip Paxson was following Google Maps directions while driving home late at night in September 2022 from his daughter's 9th birthday party when the navigation system directed him to go over an unmarked and unbarricaded bridge that had collapsed years prior, the suit filed Tuesday states.

Paxson drove off the unbarricaded edge of the bridge in Hickory, North Carolina, and drowned, the suit says.

The lawsuit claims neighbors had expressed concern Google Maps had led drivers over the bridge, which allegedly has not been repaired since its partial collapse in 2013.

"For years before this tragedy, Hickory residents asked for the road to be fixed or properly barricaded before someone was hurt or killed. Their demands went unanswered," Paxson family attorney Robert Zimmerman said in a statement. "We've discovered that Google Maps misdirected motorists like Mr. Paxson onto this collapsed road for years, despite receiving complaints from the public demanding that Google fix its map and directions to mark the road as CLOSED." Though residents notified Google Maps of the hazardous bridge, the application continued to navigate drivers over it, claims the suit, which includes a report made to Google Maps by a woman asking it to update its navigation system; CNN is unable to verify the veracity of the exhibit.

"You are not able to cross this road. GPS sends people down here, which is especially dangerous for emergency vehicles," reads the report sent to Google Maps. "Please update this map so GPS is accurate."

The woman appears to have gotten an email autoreply from Google Maps thanking her for the report, the court filing shows: "Your suggestion is being reviewed. Thanks for sharing your knowledge. We'll let you know once the changes are published," it states. Besides Google, the family is suing its parent company, Alphabet, and two local companies it claims were responsible for maintaining the land and bridge, along with proper barricades and warning signs, and failed to repair the bridge or put up barricades and hazard warnings. The suit claims negligence and willful and wanton conduct by the companies and seeks an unspecified amount in punitive damages.

Google has "the deepest sympathies for the Paxson family," it told CNN in a statement. "Our goal is to provide accurate routing information in maps, and we are reviewing this lawsuit." CNN has sought comment from codefendants Tarde, LLC and Hinckley Gauvain, LLC.

Paxson is survived by his wife, Alicia, and the couple's two daughters, ages 9 and 7, the suit says.

Alicia Paxson told CNN Saturday that police officers came to her door after her husband's death.

"Just the look on their faces, you know, I just knew," she said. "It was the worst day in my life."

She told her daughters, "Daddy had an accident Amateur Radio in the United States is and he went to heaven." Her eldest daughter, she said, became angry.

In an earlier statement shared by her lawyers, Alicia Paxson said her family wants to "make sure our voices are heard."

"My daughters spent their first Father's Day without their Dad. They should have been celebrating and spending time with Philip, who devoted his life to his family. Instead, they had to look across the dinner table and see an empty chair," the wife said.

"Our girls ask how and why their daddy died, and I'm at a loss for words they can understand **PATRIOTIC**...station and skill always ready because, as an adult, I still can't understand how those responsible for the GPS directions, and the bridge, could have acted with so little regard for human life," Paxson said.

"No one should ever lose a loved one this way." "Like so many motorists, Philip put his trust in Google Maps to safely guide him home from the children's birthday party," family attorney Larry Bendesky said in <u>a statement</u>. "His trust in Google Maps, and the failure of the road and bridge-keepers to do their jobs, cost him his life."



The ARRL antenna book also has a good description of the Bobtail curtain.

I have used a half square antenna and have been very impressed at its performance for a cheap, easy to make (I made it in 10 minutes from 18 AWG wire), lightweight antenna. I feed the half square antenna with coax at one of the top corners, and bring the coax away from the antenna in line with the horizontal section for at least ½ wavelength beyond the end of the antenna. During a portable operation in Vermont, while on 15M, I asked an op in Texas to tell me the difference in my signal between a 15M half square antenna mounted 12 feet above the ground and a 130 foot 80-10M off-center-fed (OCF) antenna mounted as an inverted V with the feed point 30 feet high. He said the half square was far better than the OCF.

After my good experience with the half-square, I will try the Bobtail curtain to see how much better it is.

CARA has sponsored the Worked all Connecticut Counties Award for decades. The award process has been updated and modernized. Here are some of the changes:


- 1. The Award will be emailed to applicants in PDF format suitable for printing.

## Elmering (aka Mentoring) is not (too) Painful

It was determined after FD 2023 that it would be best to have a dedicated 80/75 m dipole rather than the multiband off center fed antenna that had been previously used. This would give the club dedicated antennas for 80,40,20,15 and 10m. It was suggested by Dan, W1QK, the antenna be built with a single pole knife switch so it would be shorter for the SSB section of the band. It was decided to have the switch around 3.9mhz and the full length of the antenna when switch is closed for 3.55mhz, the desired CW portion of the band. Working measurements were calculated and a preliminary sketch was made for the antenna. The antenna will be used for FD and WFD and put up as an inverted Vee.

Steve, W1SMS, had suggested a while back that as CT Section Technical Coordinator, he would like to host at his QTH some sort of technical hands-on activity. John, W1JMA, suggested the antenna build project for this event and the date August 12, 1pm to 3pm was selected. Invites were sent to CARA club members and other hams from surrounding clubs that had expressed an interest in antenna building. Needed materials for the project were obtained and prior to the event, John and Steve shot lines over trees to test the antenna and settled on how the knife switch would be employed in the construction.

The 12<sup>th</sup> arrived and about a dozen CARA and other local hams began to arrive at Steve's QTH around 1pm, along with heavy rain showers. After an hour rain delay the project began. The first steps were to explain the concept of the antenna and the working calculations and design. Wire was measured and cut for each leg of the dipole for the 3.9mhz and 3.5mhz sections. The wire was soldered to the center insulator and the end insulators were temporarily put on the antenna so we could test the SWR for the SSB section.

Steve had several instruments that could be used for SWR measurements including an MFJ-269 antenna analyzer, Array Solutions AIM-UHF vector network analyzer and a newly purchased NanoVNA . Most measurements were conducted using the AIM-UHF as its control software enabled an immediate scan and display of critical parameters over a defined frequency range. The antenna was hoisted as an inverted vee and measurements were taken.

The antenna was too long! The first of many lessons learned was that when a dipole is in an inverted vee formation, the antenna will be 2-5% less than the standard flat top calculations. After several cuts were made, we were satisfied with the lowest SWR at 3.86mhz. The knife switch and remaining wire were soldered and again measurements were made, and the wire cut to get the CW portion to 3.5MHZ.

The antenna was complete around 4pm local time. A QSO was made with stations in VT, NH and Maine. All who participated were happy with the results; the work areas were cleaned up and then many stayed to have a BBQ.



## **CARA POTA Guidelines**

Purpose:

To set forth operating guidelines for CARA sanctioned POTA events.

- Those members who plan on bringing their stations shall sign up so the POTA • coordinator can set up the operating schedule
- Those members who plan on participating w/o equipment will sign up as an operator •
- Multiple stations will coordinate operating conditions and band plan •
  - Each station will use the CARA filters for the band assigned
  - Each station shall determine their respective operating mode

- Stations shall change operating bands each hour, example:
  - First hour of operation: station 1 on 40m; station 2 on 20m; station 3 on 15m; etc.
  - Second hour of operation: station 1 on 15m; station 2 on 40m; station 3 on 20m; etc.
  - Third hour of operation: station 1 on 20m; station 2 on 15m; station 3 on 40m; etc.
  - Repeat
- Use this activation as a means for new or inexperienced hams to get on the air!
- Have fun!!

# Solar Eclipse QSO Party Rules for 2023 and 2024

The following are the complete, detailed rules for the SEQP. For a quick introduction to the SEQP, please visit the **SEQP FAQ** page. The SEQP is one event within the **Festivals of Eclipse Ionospheric Science**.

# I) Dates and Times

14 Oct 2023 1200 – 2200 UTC (Partial eclipse begins ~1500 UTC in Oregon ends ~1840 UTC in Texas)
8 Apr 2024 1400-2400 UTC (Partial eclipse begins ~1710 UTC in Texas and ends ~2040 UTC in Maine)

Participants are encouraged to operate before, during and after the eclipse passes over the continental US. Doing so will create baseline data (pre- and post-eclipse), and eclipse influenced data (during annullarity or totality) for the research team.

# **II) Objective**

To generate observations of propagation by the **<u>Reverse Beacon Network</u>** and **<u>PSKReporter</u>** event logs before, during, and after the eclipse on the amateur bands for the purpose of ionospheric sounding.

The Solar Eclipse QSO Party (SEQP) is unique among ham radio competitions as it awards points for two-way QSOs (ham to ham contacts via radio) and bonus points for reception reports from skimmers, RBN nodes and the like.

Please be aware that the SEQP is one of many events to be held during the <u>HamSCI Festivals of Eclipse</u> <u>Ionospheric Science</u>. You are welcome to participate in more than one event. Each event has its own 'rules' page, accessible from the 'Festival' link above.

# **III) Station Requirements**

- 1. All transmitting and receiving equipment used to make two-way QSOs must be located within a 500meter diameter circle.
- 2. Remote operation is permitted for two-way QSOs if the physical location of the remote stations meets the 500-meter diameter circle rule above, all station and operator licensing requirements are met for the remote location, and all category limitations in these rules are met.
- 3. Portable operation, from a fixed location (such as POTA, SOTA, Field Day style setups, operated by individuals or groups) are welcome and encouraged (see bonus points below).
- It is important to calculate and record the 6-character Maidenhead grid square of all stations used in the SEQP because the grid square will be needed during the log submission process. Visit this <u>Amateur Radio Grid Square Locator Tool</u> for help in determining your 6-character grid square.
- 5. There are no provisions for mobile or rover operations. Transmitters and receivers should be fixed in one location for the duration of the SEQP.

# IV) Categories (to be listed separately in the results)

- 1. Single-operator (only one transmitted signal, emitted for the purpose of making two-way QSOs, is permitted at any time)
- 2. Multi-operator (one or more transmitters) (only one transmitted signal per band and mode, emitted for the purpose of making two-way QSOs, is permitted at any time)
- 3. Checklog for stations wishing to submit log(s) for other QSO parties on 14 October (PA, AZ, NV, SD), and who wish to be recognized for their contribution to the SEQP data (automatically via CW skimmers, RBN, PSKReporter). Checklogs will not be scored, but submissions will be eligible for an SEQP Participation Certificate. (Of course, it is possible to operate multiple contests, simultaneously, if your logging software supports it. If successful, enter all logs, one at a time, see Section X.)
- 4. There are no restrictions on transmitter power (please be reasonable, don't run a kilowatt on FT8!), spotting assistance, or band changes

# V) Bands, Frequencies and Modes for Two-Way QSOs

160, 80, 40, 20, 15, 10, and 6 meter bands, using these modes: CW, SSB, digital (all varieties)

*Reminder:* By international agreements, the 60, 30, 17, and 12 meter bands may not be used for twoway contest QSOs.

We anticipate plenty of activity. On CW and SSB, tune for stations calling 'CQ SEQP' on the 38s (CW +/-10kHz from 3538, 7038, 14038, etc. SSB +/-25kHz 3838, 7238, 14328, 21338, 28338). Activity on digital modes will be close to the usual activity centers but - please - spread out! With many stations active, assist the receiving decoder stations to make quick and accurate measurements by leaving some space between signals. You can find band planning information at

# VI) Exchange for Two-Way QSOs

Accurate Signal Report, 4-Character Grid Square.

Example Exchange:

- W1AW: CQ CQ SEQP de W1AW W1AW
- NOAX: NOAX
- W1AW: NOAX 579 FN31
- NOAX: 589 EM48
- Optional: Either station's callsign may be inserted at any time during an SEQP QSO. Use your judgment to balance efficiency (short QSOs) against accuracy (knowing for sure who you worked).
- If you miss any of the information, simply ask for a repeat (on SSB), or send AGN? (on CW). Be sure to log what you receive.

#### Notes

- On CW, call "CQ CQ TEST DE [your call] [your call] K" using a single code speed during the transmission. *Repetition of CQ and/or TEST as shown, as well as repetition of your callsign,* maximizes the ability of the <u>automated receivers</u> to decode and spot your transmission. Please see <u>Getting Spotted by the RBN</u> for tips on getting spotted while calling CQ during the SEQP.
- 2. To determine your grid square, visit this Amateur Radio Grid Square Locator Tool.
- 3. Signal Report
  - *CW/Phone:* The strength (S) value of RS(T) signal reports should represent the approximate peak S meter reading. (Readings greater than S9 should be sent as S9.)
  - Digital: The preferred digital signal report is the SNR in dB as provided by the digital mode software. Alternatively, give the operator-determined <u>RSQ (Readability Strength Quality)</u> value. Note that N1MM+'s FT8 integration should automatically place SNR values into the *Snt* and *Rcv* signal report entry boxes, though you can do so manually if desired. (Researchers will assume any CW or digital signal report not in three-digit RST/RSQ format is an SNR [dB] value.)

# VII) Transmitting Digital Modes

- 1. Many software authors publish guides to using their programs with FT8.
  - Contesting software, such as <u>N1MM+</u>, interfaced with WSJT, is the best solution for operating FT8 in the SEQP, in part because it generates Cabrillo files.
  - Desktop logging packages, such as <u>Ham Radio Deluxe</u>, also work well with FT8 and other digital modes. However, it will take a few extra steps to generate a log for uploading to the SEQP Scoring Robot. (You will need to <u>selectively export your SEQP QSOs as ADIF</u> for the date and time you were operating in the SEQP.)
- PSK Reporter Spotting: Many digital mode packages such as the <u>open-source fldigi</u> <u>program</u> and <u>Ham Radio Deluxe/Digital Master 780</u> have options for automatically sending spots to <u>PSKReporter</u>. Please enable this option to send additional data to <u>PSKReporter</u>.
- 3. Operate normally, call CQ, answer CQs same as you would when not involved in a contest or QSO party.
- Make sure your software is configured with your station location in the 4-character grid square format. This is especially important if you are operating portably. See the <u>Amateur Radio Grid Square</u> <u>Locator Tool</u>.
- 5. When using WSJT, it is important to do two things:

1. Enable PSKReporter in the Reporting tab. This will send received signal data to the PSKReporter website, where it will be saved for later retrieval by the HamSCI data analysts.

2. Enter an antenna description on the Frequency tab. This field must have some information, even something simple, like 'dipole' or 'mag loop', in order for PSKReporter to accept received signal data.

- 6. Use an Internet connection for time sync and spotting if possible. Smart phone hotspots and public WIFI may provide Internet in portable locations.
- 7. Use CAT radio control if possible, to accurately record QSO frequencies.
- In your Cabrillo soapbox, please note the type and version number of software used e.g. <u>WSJT-X 2.5.4</u> or <u>fldigi 4.1.23</u>
- 9. Optionally sign SEQP to attract other participating operators (e.g., "KV4PC SEQP 73").

# VIII) Scoring

Score = (QSO Points x Multipliers) + Bonus Points

- 1. QSO Points: CW and Digital QSOs, 2 points each; SSB QSOs, 1 point each
- 2. Multipliers: 4-character grid squares, counted once per band.
- 3. The same station may be worked for QSO points on all SEQP bands and modes (e.g. N4BB contacts KD8GMH three times, on 40m CW, 20m SSB and 10m FT8).
- 4. Duplicate contacts (second, third, fourth, etc. QSOs with a station previously worked on a given band and mode) are allowed after 10 minutes have elapsed since the previous QSO with that station (ie K8MAD may contact N4FCG for QSO points on 40m CW at 2130z, 2152z, and again at 2215z). Note: N1MM+ logging software will correctly accept and score duplicate QSOs as follows:
  - 1. If you work a station that is truly a duplicate (same callsign, band, mode) within 10 minutes, N1MM+ will warn you with a red DUPLICATE message and refuse to log the QSO.
  - 2. If you work a 'legal duplicate' per Rule #4, N1MM+ will warn you with a red DUPLICATE message but it WILL allow you to log the QSO.
- 5. Bonus points earned (see Bonus Points section)

The final score, including bonus points, will be calculated by the HamSCI Data Processing Team. Claimed Scores are not required to be accurate.

# **IX) Bonus Points**

All bonuses will be calculated after the SEQP and included with the final scores.

- 1. Operate during annularity or totality (the time of greatest coverage of the sun at your QTH): 100 points. Visit <u>eclipsewise.com</u> to determine the eclipse start and end times at your QTH. Note: Not all participants will be able to claim this bonus, only those operating under the path of the eclipse will qualify.
- 2. Operate outdoors (so you can see the eclipse): 100 points
- 3. Operate at a public venue: 100 points
- 4. Upload PDF or JPG file of antenna and station photos and/or design characteristics, information such as orientation, E and H plane patterns, height above ground, station block diagram: 100 points.
- 5. Provide <u>Effective Radiated Power relative to a Dipole (ERPD)</u> on each band in a PDF or JPG file: 50 points per band.
- 6. One bonus point will be awarded for each band and clock hour during which your signal was spotted in a grid square other than your own by the RBN, PSKReporter, or DX spotting network. Spots will be counted only during the contest period and only on the seven contest bands. A spot of your signal on any mode will qualify for the bonus point. HamSCI data analysts will mine the data for these bonus points and apply them to your score.
- 7. PDF and JPG bonus points files should be submitted and via e-mail to hamsci.seqp@gmail.com

# X) Log and Score Submission

A log upload page will be available. *The link to the log upload page will be appear here just before the SEQP is held.* Once the upload is successful, you will be able to download a PDF Certificate of Participation from that same page.

- 1. Submit logs using the Cabrillo format standard (see Logging Requirements, below). Cabrillo is the preferred log format. However....
- 2. Participants may also submit ADIF logs. Typically, these will be FT4/8 QSOs, with the log coming from WSJT-X software.
- 3. It is possible to upload both a Cabrillo log (e.g. for CW and SSB QSOs) and a second ADIF log (e.g. for FT8 QSOs).
- 4. Any additional supporting files you believe would be useful to research may be posted to the <u>public</u> <u>HamSCI zenodo.org community</u>. You will be provided a DOI (<u>digital object identifier</u>) which you should include in your regular log's Cabrillo file header so we can associate the files with your log.
- 5. Entrants agree that they have followed the SEQP rules to the best of their abilities. Entrants agree to be bound by the decisions of the SEQP Scoring Committee.
- 6. Logs must be submitted within 30 days following the SEQP events:
- 2023: By 2359 UTC Saturday, November 11
- 2024: By 2359 UTC Sunday, May 7

Zenodo files will be uploaded under **Zenodo's 'open access' policy**. Logs and entry forms will likely be transferred to Zenodo in the future - under the same 'open access' policy.

# **XI) Logging Requirements**

Logs should be in the Cabrillo format (<u>http://www.arrl.net/cabrillo-format-tutorial</u>). All modern logging programs are capable of generating a Cabrillo format log. Required fields:

Frequency, Mode, Date, Time (UTC, not local), Sent Call, Sent Signal Report, Sent Grid, Received Call, Received Signal Report, Received Grid

• Use any software that supports the Solar Eclipse QSO Party. The <u>N1MM+ contest logger</u> natively supports the SEQP as log type "ECLIPSE". Any logging software that supports the ARRL VHF contest exchange format (signal report and grid square) can also be used.
