Terms of Agreement for Daily Pet Care and/or House Sitting

This signed document is an agreement between Pack Leader Pet Services, LLC and _____ (Member) for pet care services beginning on _____ until _____ revoked in writing. Pack Leader Pet Services, LLC agrees to provide pet care services to Member in a reliable, trustworthy, and caring manner.

PET CARE

1. I authorize Pack Leader Pet Services, LLC to perform pet care services as outlined in Member Profile, Pet Profiles, and Policies and Procedures which shall become part of this contract.
2. I authorize **Pack Leader Pet Services, LLC** to obtain any emergency veterinary care that may be necessary during the time spent with my pet. I accept responsibility for any charges related to this emergency care. I also authorize **Pack Leader Pet Services, LLC** to utilize an alternative veterinarian in the event my primary veterinarian is unavailable. Every effort will be made to contact the owner prior to obtaining emergency care.
3. **Pack Leader Pet Services, LLC** accepts no responsibility for security of the premises or loss if other individuals have access to the home during the term of this agreement. Pet care will be performed only by **Pack Leader Pet Services, LLC** during all assignments unless prearranged with member (i.e., in the event of Pack Leader Pet Services, LLC owner or employee being on vacation, etc.)
4. I agree to reimburse **Pack Leader Pet Services, LLC** for any additional fees for providing emergency care, as well as any expenses incurred for unexpected visits, transportation, housing, food, or supplies.
5. **Pack Leader Pet Services, LLC** agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the member expressly waives and relinquishes any and all claims against **Pack Leader Pet Services, LLC**, its employees or assigns, except those arising from proven negligence of the pet sitter.
6. **Pack Leader Pet Services, LLC** will not be liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors.
7. Customer will be responsible for all medical expenses and damages resulting from an injury to the pet sitter or other persons by the pet. Customer agrees to indemnify and hold harmless **Pack Leader Pet Services, LLC** in the event of a claim by any person injured by the pet.
8. **Pack Leader Pet Services, LLC** reserves the right to terminate this contract at any time, at its sole discretion; likewise, member may terminate this contract at any time. There is no term of contract for daily service.

10. Fees are earned upon acceptance of pet sitting reservations and are due weekly. No refunds will be given for cancelled visits once time has been reserved. Members must give a minimum of 24 hours notice to receive credit against future visits, which is given at the discretion of **Pack Leader Pet Services, LLC**. A fee of **\$29** will apply to all returned checks. Member is responsible for all costs of collection.
