It is a full curriculum that includes an online assessment program that teachers are trained on and includes extensive training and follow up training through workshops provided by the publisher. Currently, intensive ESL support is provided in Law and Government and CNMT.

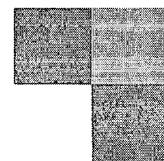
“Access to Core” Instructional Coaches also provide professional development to teachers on how to instruct ELL students. This training is provided by the LAUSD Language Acquisition Branch division (LAB).

The Partnership and Partnership schools also provide other professional development opportunities on teaching strategies that support ELL students. This includes programs such as the Summer Institute, which trains Partnership teachers on a variety of classroom strategies.

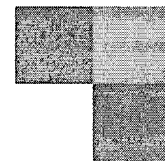

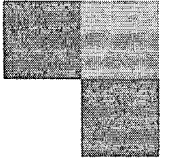
