Capitalized terms in this Third Amendment shall have the definitions set forth in the Declaration unless otherwise provided herein.

Except as set forth in this Third Amendment, the other provisions of the Declaration shall remain unchanged.

This Third Amendment shall be recorded in the official records of Eagle County, Colorado promptly following execution hereof on behalf of the Association and certification by the Secretary of the Association, as set forth below.
