Full Season Financial Policies and Responsibilities of the Parent/Guardian

It is essential that communication lines be open and available at all times. Parents are expected to thoroughly read the policies as stated and agree to all terms upon enrollment.

***Registration and Enrollment**

Registration Fee: \$55

Upon registering for classes, you are expected to pay the registration fee and September tuition. The registration fee secures your child a spot in his/her selected classes and is non-refundable. Registration can be conducted online or in person.

***Tuition Payments - ALL PAYMENTS WILL BE PAID ONLINE THROUGH YOUR ACCOUNT**

Monthly tuition for classes is figured based on the number of hours spent in class weekly. This has been adjusted to provide a discounted rate as the student enrolls in more classes. Tuition payments run September 1st through June 1st. Tuition is due by the 1st of each month and can be paid by credit or debit through your parent portal online. There is an auto-payment option available within the parent portal that will help avoid any late fees due to forgotten or missed payments.

Payments are made online using a credit or debit card. Payments by check are accepted but must be in the payment box by 8pm on the day it is due. If a check is late or returned due to NSF the normal late fee and NSF fee off \$30+tax will be applied and a credit card will be the only form of payment accepted from there forward.

***Sibling Discount - NEW!**

Additional children - \$5 off monthly tuition for 2nd child and \$10 off each child's tuition thereafter. Sibling discounts do not apply to registration fees or costume fees.

***Recital Fee**

Recital Fee – \$85 first child, \$75 second child, or \$225 for families with 3 or more children. The recital fee is non-refundable and helps cover the cost of our spring production. The recital fee includes 3 complimentary tickets for one dancer, 5 for two siblings and 6 for families with 3 or more children. **The Recital Fee is Due March 1st.**

***Costumes**

Your child will have a separate costume for each dance. The deposit is **\$60 deposit per costume**. We have two deposit **due dates, Oct.1st and Nov.1st**. When you pay a costume deposit you are confirming with us that your child will be performing in the recital. The costume deposit will automatically be posted to your account for October and November payments.

COSTUME DEPOSIT PAY TABLE -

Costume deposits are due on the 1st October and 1st of November. Late fees will apply to untimely payments. If you need to make other arrangements we are happy to work with you provided you communicate in advance, the need for assistance.

Costumes can range anywhere from \$70 to \$100+ a piece, depending on style, embellishments and size, whether youth or adult. Measurements are taken in classes in October and the ordering begins in November. If you prefer to measure your son or daughter or be present when the measurements are taken, please speak with your child's teacher in advance. Once ordering is complete, invoices are issued in February for the remaining balance due, minus your paid deposit. We do our best to select affordable, yet comfortable and age appropriate costumes for all students. All alterations and exchange fees should a costume not fit, are the responsibility of the parent unless otherwise noted. deposits are non-refundable. Costumes will be sent home with students once they have been paid for in full.

***Late Fees**

There is a **late fee of \$15.00+tax** added to all balances left unpaid after the due date.

For declined or failed credit/debit card transactions there is a **\$30+tax fee added to the account when the payment is unable to be processed**. Please contact the studio immediately when your card number or information changes to prevent this from occurring. Unpaid tuition could result in your child not being able to participate in class.

Late fees apply to all past due payments.

***Refund Policy**

Tuition is non-refundable and non-transferable. No refunds will be given for recital fees, registration fees, tuition or costumes. Dropping is strongly discouraged. If you need to drop a class for any reason, a drop form must be completed and signed by either the director or teacher of the class being dropped. A student is not considered dropped and all fees will continue being charged until the form has been signed and given to the front desk.

***Financial Hardship**

We understand that there are times in which you cannot control and you find yourself in a financial disparity. Should this affect your ability to pay your tuition or other scheduled fees on time, please contact the director as soon as possible to inform her of the situation. We are happy to work with you in order to keep your child involved and dancing but we must be informed as far in advance as possible to be able to do so. **If a child's account falls 2mos. behind and there has been no communication from the parents in regards, ultimately it is the child who suffers. He or she will not be able to participate in classes and will be asked to remain home until the account is paid up to date.**

***Extended Illness or Injury**

Although we hope to never have to deal with these situations, they do sometimes occur. Each situation will be handled based on the individual and predicted recovery time. Unfortunately, costumes cannot be refunded, nor will tuition paid prior to the occurrence. But we will work with you on tuition and other such fees if necessary. If this were to ever occur, we expect you to contact the office or director immediately to set up a time to meet and discuss options.

***Covid-19 Safety Precautions**

We actively sanitize and disinfect our building and the high traffic areas with regards to Covid-19 and the health hazard it presents. As uncertain as times may be however, we feel strongly about the importance of keeping children active and engaged in activity. Children need socialization, structure and exercise. Therefore, we will remain open as long as our students and staff remain healthy and active in their role in keeping our studio safe from viruses and other health risks. We count on parents to not send their children to dance if there has been any exposure to someone testing positive for Covid or any other spreadable disease or virus. We count on parents to actively observe their children and if any symptoms of Covid are present, to not send them to dance class.

***Medical Conditions/Allergies/Mental or Physical Conditions**

If your child has any medical concern, diagnosis or limitation, please inform the teacher prior to the start of classes. We often have treats, use ink pads for hand stamps, offer lotion for dry skin, use latex balloons, etc. that present allergies could have a negative reaction too. We will do all we can to keep the health and safety of our students at the top of our list as long as we are aware of the condition. If your child uses an inhaler, please have that in his or her dance bag at all times. If your child is on a medication that could affect their performance mentally or physically in class, please inform the teacher prior to the child's first class.

***Communication**

Please keep the front desk up to date with your current contact information. Should an emergency arise or reason for celebration or concern come about, we want everyone to feel comfortable making contact and keeping communication open. Your child's education and success while attending Dance FX is very important to us.
