Highway Commissioner's Report:

Highway Commissioner Rogawski reported 3 bids were received for the final phase of the Bryn Mawr sewer project. The cost increases from previous years bids is on average nearly 2.5 times higher. This was not anticipated. The Pandemic, supply chain issues and inflation have all come together to form the perfect storm. I believe that the price will only go even higher and waiting any longer will put it out of reach entirely. I am in discussions with the lowest bidder to fully complete the job now but to break the payments down over a 2 year period. He is amenable to this. This will trigger a budget issue that John & I will address soon with an amended budget as soon as I get the details on the total cost from the vendor and the budgeting process from John.

Potholes season is in full swing. I will have a full list to A & J Paving by the end of next week. There are quite a few. Additionally, because of the poor or in some cases non-existent aggregate under the streets that were originally done by the WPA in the '30s and superficially resurfaced subsequently, many residents are frequently calling and asking about street repaving. I return calls daily and explain the sad reality of my levy / budgeting constraints.

There is an issue with the area in front of a mailbox on Bryn Mawr near Manor Lane. People drive their car up over the lawn to the mailbox to deposit letters without getting out of their car. This has created huge ruts. There were boulders there previously that prevented this but they

have vanished. I asked A&J Paving to quote a price on paving that square in front of the box, it came in at \$2500.00. I am going to contact the post office to see if the box can be located closer to the street and the extension shoot added instead.
