Supervisor Nasca called the meeting to order at 6:38 p.m.

Pledge of Allegiance was recited.

As the first order of business Supervisor Nasca entertained a motion to dispense with the reading of the minutes of February 23, 2024, and accept them as presented. Trustee Wyda moved. Trustee Alongi seconded the motion. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Trustee Alongi moved, seconded by Trustee Wyda to authorize the expenditures for the Town Fund and G.A. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Supervisor's Report:

Supervisor Nasca informed the Board of the following:

There is one ongoing GA case which was approved and none pending.

The Township was a polling site for the March 19, 2024 election.

He checked back with Lifeline Screening regarding a health screening event. As the coordinator had not heard back from her team, Lifeline was taking a pass for now on setting up an event up at the Township. The Supervisor said he is still interested in the benefits of a health event for the Township. He will continue investigating alternatives and will check back with Lifeline later.

The Property Tax Workshop that took place on March 14th went well. The event had a good resident turnout. The responses gathered from the exit survey were all positive. The next seminar, a workshop detailing real estate exemptions, will be scheduled shortly.

The Supervisor along with Trustees Alongi and Cichon attended the Pennoyer School groundbreaking ceremony on March 13.

The Township is participating in the Norridge and Harwood Heights Community Kindness Day by hosting a food drive from now until April 20th. Donations collected at the Township will be brought to the Salvation Army Norridge Citadel.

The first of a series of safety presentations held with the Cook County Sheriff's Office will be held at the Township on April 16th at 1:00 p.m. Currently, 12 residents are registered.

The Supervisor is exploring memberships for township resources including the Metropolitan Township association. This association has a strong membership in the Northwest area and a great platform for training and tracking development in Springfield.

Committee Reports:

Trustee Alongi stated all is fine and there are no issues regarding building maintenance.

Trustee Wyda reported there were no taxicab books sold in March.

Supervisor Nasca reported on the Youth Committee meeting held earlier. The committee approved funding \$21,500 for the 2024 Norwood Park Township Enrichment Camp. Also, he relayed Youth Committee Chairperson Cichon had spoken to the person from Pathway to Adventure, Boy Scouts regarding their submitted grant. The grant request currently does not meet the criteria of the Township.

Trustee Stefanowicz reported after reviewing the statements, all is good regarding finances.

New Business:

Trustee Wyda moved, seconded by Trustee Alongi to approve funding \$21,500 for the 2024 Norwood Park Township Enrichment Camp. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Trustee Wyda moved, seconded by Trustee Stefanowicz on transfer of appropriation ordinance, Norwood Park Township Budget FY 2023-2024. Supervisor Nasca called for a voice vote. Motion unanimously carried.

Assessor's Report:

Assessor Karns reported the office has been consistently busy daily with residents seeking help with their exemptions and appeals. He surmised this will slow down by April 5th which is the deadline for appeals.


