Supervisor Lupo informed the Town Board that there are currently no G.A. cases and none pending. Trustee Wyda reported 2 cab books were sold for the month of May.

Trustee Stefanowicz stated he has examined the monthly expenditures and cash on hand and all is good.

**Old Business:**

The Decennial Committee decided to hold their first meeting at a future to be determined date.

The Town Board discussed the “National Night Out” Community Event. An installation amount of \$2,296 has been paid from Norwood Park Township to the activity vendor for the event. The balance will be paid by the township to the vendor the day of the occasion.

Trustee Alongi stated the new electric sign was delivered to the distributors building on May 24<sup>th</sup> and is expected to arrive to the Township Building within a few weeks.

**New Business:**

A request for a senior grant benefiting the Golden Fellowship Club was presented before the Town Board. Trustee Stefanowicz moved and Trustee Wyda seconded to provide the club with a grant of \$1000. Motion unanimously carried.

**Assessors Report:**

Supervisor Lupo relayed Assessor Karns report as the assessor was not present for the meeting. The assessor’s office has seemed to quiet down as the initial deadline for the exemption applications has passed. Any additional residents that have come in or called with property tax queries have been assisted.

**Highway Commissioner’s Report:**

Commissioner Rogawski provided the Town Board with the following information: Calls are coming in for pothole repair. The Commissioner is working with Tom McCabe to secure MFT funds to offset the remaining balance to DiMeo Brothers for the Bryn Mawr sewer project. Also the commissioner is working on the details with John Spina regarding our potential permit deposit requirements and subsequent fines for opening the streets in the Unincorporated area and not properly closing it.
