Supervisor Lupo also asked the Town Board to please complete their Ethics Statement and email a copy to the office for township records.

### **Committee Reports:**

Trustee Alongi informed the Town Board that John Soto has completed the gutters and downspouts.

Trustee Wyda reported 11 cab books were sold for the month of January. Also, that Harwood Heights Senior Club will start meeting again, and reminded them to send a grant request into the township for their club grant.

Trustee Nasca reported a Youth Committee Meeting to consider and take final action of 2 grant requests for the Jr. Rebels 11U & 12U baseball teams.

Trustee Stefanowicz reported tax revenue is coming in.

#### **Old Business:**

Supervisor Lupo informed the Town Board that 1000 masks were donated by Cook County. The township will give out 4 masks and 2 bottles of sanitizer per household to township residents. It will be posted on the township website.

He also informed the board that \$4000.00 out of \$10,000.00 grant has been spent for The National Night Out event.

There will be website training for the girls in the office on Wednesday, March 30, 2022.

#### **New Business:**

Tuesday April 12, 2022 will be the Annual Town Meeting. Trustee Wyda moved, Trustee Stefanowicz seconded to adopt the Annual Town Meeting Agenda. Supervisor Lupo called for a voice vote. Motion unanimously carried.

# Assessor's Report:

Assessor Karns informed the Town Board that exemptions are carried over from last year. Also, there is a possibility of a 40% increase in taxes next year.

## **Highway Commissioner's Report:**

The Highway Department is beginning to receive tax revenues. They are coming in at a much increased rate over last year.

Some residents have been complaining about potholes on Bryn Mawr. I notified the contractor. He is applying a temporary quick fix "cold patch". As soon as the asphalt plant opens in April he will be able to effect permanent repairs.

I met with the engineer for the sewer project. He will submit plans to be available at the office & online for pickup. Bids need to be returned by April 4th.

Some Summerdale residents have complained about speeders. I suggested that they need to call the County Sheriff. The more they call, the more patrols get scheduled. Additionally they asked about speed bumps. I am looking into artificial cameras and possibly a speed display trailer.
