If you live in the South Florida area, we would be happy to assist you with your firearm transfer. We can ship your gun to an FFL dealer of your choice hassle free!

TRANSFER FEES:

These fees only apply to firearms inbound and outbound from/to other dealers.

- Gun broker/ Individual Transfers: **\$40 per firearm**
- Transfers from Major Online Retailers: **\$40 per firearm**

PRIVATE TRANSFERS (PRIVATE SALES):

If you are engaging in a private sale, but wish to conduct a background check, we would be happy to provide the service.

Both the seller and the buyer must provide, the same identification and paperwork that are required as a normal sale. This is still a transfer, and the \$40 fee still applies.

SHIPPING RATES FOR OUTGOING TRANSFERS:

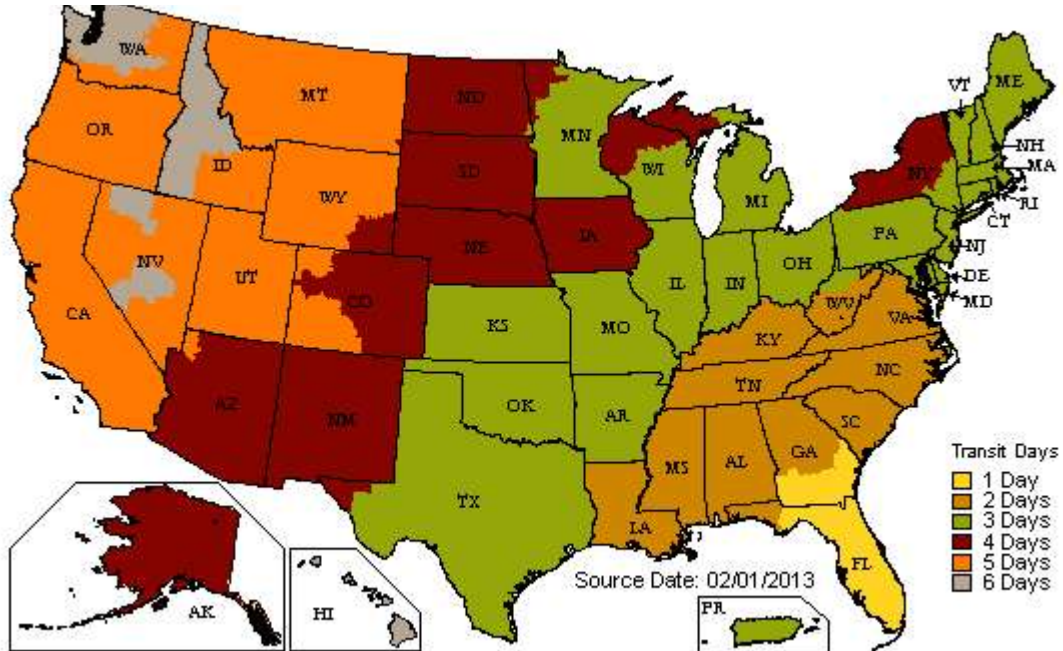
- This is still a transfer, and the \$40 transfer fee applies on top of shipping charges.
- \$35.00 for handguns shipping within the Continental United States
- \$50.00 for long guns shipping within the Continental United States
- If special packaging or delivery services/times are required, there may be additional cost.
- Contact us for Alaska/Hawaii shipping rates.
- Rates include packaging, shipping, delivery confirmation, and insurance.
- You must have an FFL destination for the shipment identified.
- **international shipping (export) requires a quote and specific permits per destination country apply.**

If we are receiving the firearm from another dealer our transfer fee is \$40 per firearm, and \$15 for the federal required NICS background check.

Once the firearm is paid in full, and we have a valid and up to date copy of your dealer's FFL, we can ship out your gun!

Please keep in mind that all pistols and handguns will be shipped via 2nd Day Air, and long guns (rifles or shotguns) will be shipped by UPS Ground. Expedited shipping is available (additional fees will apply).

OUR SHIPPING POLICIES AND INFORMATION

Note: Due to the increased demand for products, shipping lead times have been extended. Please bear with us as we are diligently trying to expedite orders and get them out as fast as we can. We GREATLY appreciate your patience.

- We do not guarantee that boxes and cases will arrive intact (damaged goods are reported to the shipping carrier). However, we do insure the contents against loss and damage.
- We typically ship via UPS and US POSTAL. If you need faster shipment, we can ship 2nd Day or Next Day for an extra charge.
- We make every effort to get your order shipped as fast as possible. In some circumstances, especially during sales and after weekends, we may not get your order shipped in the time specified. Please rest assured that we will ship your item as soon as we can.
- Incorrect items: If a product is not the product that you ordered, we will either replace the product or give you a full refund if returned within 10 days of receipt. We cannot replace products that have been used.
- Special Order Items may not be returned.

By federal law, we will not ship firearms directly to your home. They will only be sent to your local FFL (Federal Firearms License) Dealer, who will then perform any background checks and paperwork required in your area. It is your responsibility to contact the FFL Dealer to make sure of their policies, procedures, and any applicable fees they might charge for the transfer. Virtually any dealer will accept a transfer for you. They will perform all the required background checks and paperwork for your area, and you will typically be charged a transfer fee ranging around \$25.00 to \$50.00. Notify your dealer that they may either fax us a copy of their license or e-mail it to us.

It is important to make sure that your name is somewhere attached with the dealer's license so that we know to apply it to your order. If it is not, shipping times will be delayed.

Please keep in mind that all pistols will be shipped 2nd Day Air (Next Day shipping is available for an additional fee). Long guns will be shipped by UPS Ground.

We offer products for sale that may be restricted in certain areas by Local, State and/or Federal laws. In addition, certain shipping restrictions apply to some products, such as firearms and ammunition.

It is up to the customer to know the latest Local, State, and Federal laws in your area, before placing orders, or making any purchase/shipment.

InterTactical.com abides by all laws and regulations and is an authorized dealer of all the products we sell. However, we cannot grant the right or authority to our customers to purchase items which may be regulated or prohibited by such laws. Items advertised, or offered for sale in this website, are not for sale in any city, county, or state, in which the possession or sale of the item(s) is prohibited. Products will not be shipped to restricted areas.

The shipping date will depend on when we receive the local gun dealer's FFL copy, and when funds have been properly posted.

We cannot ship your firearm until we have a current, signed copy of your local dealer's FFL license. Please call your dealer and make sure he/she knows to expect a firearm from us. Typical shipping and processing times, for in-stock guns, can range from 3 – 10 business days, depending on the distance and carrier. Other products have similar shipping times.
