The Brightwater Annual Meeting held June 2 saw the election of two incumbent Directors, Rita McMahon and Dylan Russell, along with a newcomer, Judy Kay, who replaced Kathy Renfrow on the Board. We welcome Judy to her new position and extend our sincere appreciation to Kathy for her four years' of service and support to Brightwater. We also thank those homeowners who attended or submitted proxies for this important meeting.

Attendees were joined by a number of City representatives including newly-elected City Councilman for District C, Anthony Maroulis; Lt. Kevin Burleson of the Missouri City Police Department; Scott Elmer, Assistant City Manager; Paul McKeever with the City's Code Enforcement Department; and Kelly Matte, Community Relations Coordinator. We appreciate the updates and information they shared with our residents!

As to improvements within Brightwater, the Board is finalizing bids on a total replacement of the structure in the Boat Park (adjacent to the tennis courts); the drainage and lighting project for Northshore Park has been implemented and further adjustments will be made as needed; and we are continuing to work with Lake Management to improve the appearance of our two lakes (recent rains have caused increased debris and vegetation and the color has faded).

Grounds Committee Update:

The recent rains have kept the **Grounds Committee busy!** Everything is growing rapidly and our tree trimming service has worked to keep trees in our common areas well above the 13 foot code restriction over streets and 8 foot over sidewalks. Missouri City Code Enforcement constantly visits neighborhoods to check for violations so be aware of these height restrictions in your own yard. Remember that limbs must be cut to 4-foot lengths and bundled for trash pickup.

Many of our Bradford Pears have exceeded their life expectancy and have become deformed or present a fall hazard. Though we may hate to see them go, we are removing them as needed and will replace them with hardier trees with seasonal colors.

SEECLICKFIX

This service, provided by Missouri City, allows residents to report issues or concerns to the City for correction and clarification. Residents can report on uncollected tree branches, abandoned cars, low hanging tree branches, vehicle violations, etc. There are many wonderful aspects of this program but two stand out:

- 1. You can check to see if a problem has been reported previously and what actions were taken; and
- 2. You can report a problem anonymously (check the "anonymous" option when filing the report).

CITED VIOLATIONS

Property maintenance violations in Missouri City are inspected by code enforcement officers who proactively inspect their assigned areas, as well as respond to citizen concerns received about code violations. Residents are cited directly to Municipal Court for these five violations:

- Damaged pool fences
- Dirty pools
- High grass or weeds
- Junk vehicles
- Parking on the grass
- Trash cans/bags left in public view before 6:00 pm the day before or the day after pick up

The last violation is the one seen most often in Brightwater as homeowners' lawn maintenance crews are leaving bagged grass clippings outside of the acceptable hours for trash pick-up. If you are cited, your cost for this violation is \$275.00.

4/8 (2am) -- Bayshore resident reported Police with spotlights along the small lake. MCPD had responded to an attempted car burglary on Brightwood when the suspect jumped in the lake following a foot chase.



Note: Lieutenant Burleson reminds us that suspects steal identifying information and immediately apply for credit. Report suspicious activity near mailboxes, missing mail and check credit reports occasionally for strange cards or activity.

Police who responded to recent home invasions in Lake Olympia and Riverstone identified the victims as business owners who were followed home. Lieutenant Burleson, MCPD Liaison to Brightwater, advises all homeowners to be aware of their surroundings when leaving banks and businesses. He suggested changing routes home and being alert to someone who appears to be watching you.
