- 6. Co-signers <u>will be allowed</u> for persons who are full or part-time students, or persons who have recently entered the job market and have not yet established a credit history. <u>Co-signers are not allowed for applicants who have a poor or derogatory credit history.</u>

- 1. The maximum number of occupants for a <u>one-bedroom</u> residence is <u>two</u> <u>adults and one child under the age of 1 year.</u>
