## Summary of Events

On April 20, 2018, the Orange County Sheriff's Office (OCSO) requested the Florida Department of Law Enforcement (FDLE) conduct an investigation into the use of force by Sergeant Bruce Vail and Corporal Randy Hovland, which resulted in the death of James Bauduy. The incident occurred near the intersection of Lime Avenue and West South Street, Orlando, Florida. (OCSO case # 18-036429)

At approximately 2018 hours on April 20, 2018, OCSO's Felony Squad was conducting surveillance in the area of 621 South Street, Orlando in reference to a homicide suspect being at the location. During the surveillance, deputies observed the suspect, James Bauduy, sitting at a bus stop in front of the residence. Sergeant Vail and Corporal Hovland arrived first and began to chase a fleeing Bauduy on foot. During the pursuit, Sergeant Vail and Corporal Hovland fired approximately four (4) rounds at Bauduy. Bauduy was struck multiple times and was pronounced deceased at Orlando Regional Medical Center (ORMC).

## 911 calls / Radio Communications / CAD report

On April 25, 2018, Special Agent (SA) Jonathan Stephens received a case file from Detective Granger Prunier with the OCSO. Within the file were Computer Aided Dispatch (CAD) files, recordings of radio traffic, and recordings of 911 calls related to the use of force incident. The following is a summary of those files. ### **Law Enforcement Interviews**

#### **Sergeant Burce Vail**

On April 25, 2018, at 1527 hours, SA Bill Lee and SA Stephens obtained a voluntary, sworn, and recorded statement from OCSO Sergeant Bruce Vail at the FDLE Orlando Regional Operations Center, 500 West Robinson Street, Orlando, Florida. Also present was Sergeant Vail's legal counsel, Stewart Cohen. Sergeant Vail acknowledged that his statement was being given voluntarily and part of an FDLE criminal investigation into his use of force and not part of any administrative investigation being conducted by the OCSO. Sergeant Vail also acknowledged that he understood he was free to stop the interview at any point or pause the interview at any time to speak to his legal counsel. In summary, Sergeant Vail provided the following testimony:

Sergeant Vail has been employed with the OCSO since March of 1994. He is currently assigned to the OCSO Criminal Investigation Division Major Case Felony Squad and was working in that capacity at the time of this event. Sergeant Vail was driving a blue Chevrolet Tahoe and wearing shorts, a t-shirt, and an OCSO tactical vest bearing a Sheriff's Star [badge] and markings of "Sheriff" displayed on the front and back, identifying him as a law enforcement officer.

On April 19, 2018, Sergeant Vail met with members of the OCSO Homicide Unit to discuss an Attempted Homicide and Carjacking case involving James Bauduy as a subject. Bauduy attempted to kill a female he had been dating. Bauduy also was the suspect in the murder of the female's eighty-two-year-old mother. Bauduy used a handgun during these events. Bauduy's criminal history demonstrated that he was violent and dangerous. The Homicide Unit detectives requested the assistance of Sergeant Vail's unit to apprehend Bauduy.

While attempting to locate Bauduy, Sergeant Vail learned that Bauduy had recently been using "crack." A vehicle Bauduy used was located in the same area of the incident. Surveillance was established on the vehicle, but after Bauduy did not return to the vehicle, it was towed.

Sergeant Vail received information that Bauduy was in the area of South Street and Lime Avenue. Felony Squad members Agent Gregory McQuitter, Agent John Angizer, Agent John Podlesnik, Agent John Mears, and Corporal Randy Hovland responded to the area. Agent McQuitter established surveillance of the intersection.

Sergeant Vail received information that Bauduy was at the bus stop at the corner of South Street and Lime Avenue wearing camouflage pants, a black shirt, and black hat. Agent McQuitter observed an individual matching the physical and clothing description at the bus stop but could not positively identify him as Bauduy. Agent Angizer drove past the bus stop and positively identified Bauduy. Sergeant Vail, Corporal Hovland, and Agent Mears were staged at Terry Avenue and South Street. Sergeant Vail directed Felony Squad members to approach Bauduy and attempt to apprehend him.

Sergeant Vail stopped his vehicle at the corner of the intersection on Lime Avenue at South Street. As Sergeant Vail exited and moved around the front of his vehicle, he could hear Corporal Hovland repeatedly giving commands something like "Police get on the ground." Sergeant Vail drew his handgun and was also yelling commands as he moved toward Bauduy. He heard someone yelling "Their running, their running." Sergeant Vail observed two guys, one being Bauduy, move from the bus stop to the north towards the building and they bumped into one another. Sergeant Vail described the second individual as a shorter, black male, wearing dark clothing, who ran north between the buildings.

Sergeant Vail described that Bauduy was still preparing to run and Bauduy had turned away from him, Sergeant Vail either holstered or was holstering his handgun preparing to run after Bauduy. Bauduy stopped and quickly turned towards Sergeant Vail and pointed his right hand, at shoulder height, directly Sergeant Vail. Sergeant Vail observed a dark object in his hand but he could not tell what it was. Sergeant Vail observed Bauduy making a squeezing motion with his hand. Sergeant Vail recalled thinking, "He's trying to make it work, he's trying to make it work, he's working it, he's trying to fire the gun." Sergeant Vail stated "I hope it's not my head," believing he was going to be shot in the head and "staring at it waiting for the flash." Sergeant Vail said he drew his handgun as fast as he could, although it felt like a long time, and fired one round at Bauduy. After Sergeant Vail fired his handgun, Bauduy's hands moved to the area of his right hip and Bauduy turned to his left towards Hovland. Within a second, Sergeant Vail heard someone yelling something at Bauduy and two gunshots. Bauduy "stagger walked" towards the building.

Sergeant Vail turned to his left to engage someone he observed approaching him until he determined it was Agent Angizer. Sergeant Vail turned back towards Bauduy who had fallen to the ground on his stomach with his hands underneath him. Corporal Hovland and Agent Angizer yelled commands for Bauduy to bring his hands out, to which Bauduy did not comply. Corporal Hovland and Agent Angizer pulled Bauduy's hands out from underneath him and secured him with handcuffs.

Sergeant Vail turned and saw a crowd begin to approach. While having some difficulty getting to his radio, Sergeant Vail observed Agent McQuitter with his radio out and directed Agent McQuitter to handle the radio to report their status and request medical resources. Sergeant Vail assisted in rendering aid to Bauduy. Later, fire rescue personnel arrived and continued to render aid and transported Bauduy to the hospital. Sergeant Vail observed a handgun magazine, black in color, with the spring hanging out, and rounds in it lying on the ground close to the building along with a pair of sunglasses.

Sergeant Vail advised that members of the Felony Squad do not wear body-worn cameras.

Sergeant Vail turned his handgun and extra magazines over to a crime scene investigator after the event. A crime scene investigator photographed him documenting the clothing and equipment he was wearing at the time of the event. Sergeant Vail deployed only with his handgun during this event.

Sergeant Vail estimated that he was four to six feet away from Bauduy at the time he fired his handgun at Bauduy.

Sergeant Vail said that the crowd that gathered did not encroach close enough to touch Bauduy or members of the Felony Squad securing or rendering aid to Bauduy.

When asked why he fired his handgun at Bauduy, Sergeant Vail replied, "I thought I was going to be shot. I had a gun facing me and I thought for sure I was shot."

The interview was concluded at 1603 hours.

### **Corporal Randy Hovland**

On April 25, 2018, SA Stephens and SA Lee conducted a recorded, voluntary, sworn interview of OCSO Corporal Randy Hovland. Corporal Hovland's legal representative, Stewart Cohen, was also present during the interview. The interview took place in interview room #1 at the FDLE Orlando Regional Operations Center. The following is a summary of that interview:

On April 20, 2018, Corporal Hovland was performing duties related to his job as a law enforcement officer by working on the Felony Squad for the OCSO. The Felony Squad was attempting to locate a wanted individual for armed carjacking and a suspect in a related homicide. Based on information provided by a confidential informant, the suspect, James Bauduy, was believed to be in the area Lime Avenue and West South Street.

OCSO Agent Gregory McQuitter was conducting surveillance in the provided area and communicated to the squad members that there was an individual, matching the given description, at the bus stop on West South Street. Because Agent McQuitter was unable to positively identify the individual as Bauduy, Agent John Angizer drove by the location and confirmed that it was, in fact, Bauduy at the bus stop. Once Agent Angizer provided the positive identification of Bauduy, Sergeant Bruce Vail and Corporal Hovland made the decision to apprehend Bauduy.

Corporal Hovland and Sergeant Vail traveled west on South Street towards the bus stop in their unmarked agency vehicles. In an attempt to prevent any possible escape, Sergeant Vail drove past the bus stop and turned north on to Lime Street, before stopping. Corporal Hovland stopped before the bus stop on South Street. Immediately upon seeing Corporal Hovland stop his vehicle, Bauduy began to flee from the bus stop in the direction of Sergeant Vail. As he chased after Bauduy, Corporal Hovland shouted commands of, "Stop, police," at Bauduy.

Shortly after Bauduy started running, Corporal Hovland saw Bauduy change his gait and stance toward the direction of Sergeant Vail. Corporal Hovland recalled seeing Bauduy raise his arm in the direction of Sergeant Vail while gripping a black object with silver on top. As Corporal Hovland un-holstered his firearm, he heard a gunshot and saw Bauduy and the raised object begin to turn in his direction. As Bauduy spun toward him, Corporal Hovland discharged his firearm at Bauduy until he fell to the ground.

Bauduy fell onto his stomach with his hands underneath him. Corporal Hovland continued with commands for Bauduy to show his hands but received no response from Bauduy. Agent Angizer moved towards Bauduy and secured his hands from underneath him. After Bauduy was secured, Corporal Hovland and the other members of the Felony Squad, who had arrived throughout the incident, began to render aid to Bauduy. It was at this time that Corporal Hovland saw a loaded handgun magazine on the ground near Bauduy's body. The magazine was missing the bottom section and its spring was sticking out of it. Corporal Hovland drew a rough diagram of the scene to provide a visual aid of the area and the involved parties' locations therein.

Corporal Hovland expressed that when he fired his weapon, he thought himself or Sergeant Vail was going to get shot by what he perceived a gun in Bauduy's hand and he was in fear for both his and Sergeant Vail's life.

### **OCSO Agent Greg McQuitter**

On April 20, 2018, at 2241 hours, SA David Snowden and SA Danielle Wiles conducted a voluntary, sworn, and recorded interview with OCSO Agent Gregory McQuitter. OCSO Detective Miguel Vasquez was also present during the interview. The interview was conducted in SA Wiles' department issued vehicle while parked at Terry Avenue and Central Boulevard, Orlando, Florida. The following is a summary of the interview:

Agent McQuitter advised that on April 19, 2018, his squad began looking for James Bauduy, who was wanted in reference to an OCSO homicide investigation. On April 20, 2018, Sergeant Vail received a possible location of Bauduy from a confidential informant (CI) believed to be in the area of 621 West South Street. Agent McQuitter advised he parked his unmarked vehicle on the south side of West South Street, to conduct surveillance. Sergeant Vail continued to receive information via telephone from the CI, who advised Bauduy had walked out of a residence and was wearing camouflage pants, black t-shirt, and a hat. Agent McQuitter could see a subject at the bus stop located on West South Street at Lime Avenue in close proximity to his location. This subject had camouflage pants, black t-shirt, and a hat on, but Agent McQuitter was unable to see his face. Agent McQuitter advised that Agent Angizer confirmed the subject at the bus stop to be James Bauduy.

Agent McQuitter advised that Sergeant Vail drove his unmarked vehicle just past the bus stop, Corporal Hovland stopped just before the bus stop, while Agent McQuitter positioned his vehicle between Sergeant Vail's and Corporal Hovland's, with the front end of the vehicle facing the bus stop. James Bauduy immediately took flight on foot towards the building, and Sergeant Vail and Corporal Hovland gave chase. Agent McQuitter exited his vehicle and as he was about to give chase, he observed Bauduy aggressively turn his upper body towards Sergeant Vail who was running behind Bauduy giving loud verbal commands to, "Stop, stop running." Agent McQuitter advised he then heard two-four gunshots and knew it was Sergeant Vail who had shot Bauduy.

Agent McQuitter did not see a weapon in Bauduy's hand but after approaching Bauduy who was lying on the ground, he did observe a gun magazine lying near Bauduy's head. Sergeant Vail and Agent Angizer began first aid on Bauduy, while other units attempted to deal with crowd control due to several people crowding the scene. Agent McQuitter only observed one gunshot wound to Bauduy's groin area. Agent McQuitter remained on scene until Bauduy was transported to the hospital.

### **OCSO Agent John Podlesnik**

On April 20, 2018, at 2354 hours, SA Snowden and SA Wiles conducted a voluntary, sworn, and recorded interview with OCSO Agent John Podlesnik. OCSO Detective Miguel Vasquez was also present during the statement. The interview was conducted in SA Wiles' department issued vehicle while parked at Terry Avenue and Central Boulevard, Orlando, Florida. The following is a summary of the interview:

Agent Podlesnik advised the OCSO Felony squad had been looking for Bauduy since April 19, 2018, due to him committing a carjacking against his girlfriend. Bauduy attempted to shoot her but the gun did not go off. Bauduy allegedly then went to his girlfriend's mother's residence and killed her mother. Agent Podlesnik advised there was an active warrant issued for Bauduy in reference to the case involving Bauduy's girlfriend.

After ending their shift, Agent Podlesnik advised Sergeant Vail received information from an Orlando Police Department sergeant, who had a confidential informant that knows Bauduy. This confidential informant advised Sergeant Vail of Bauduy's location. Agent Podlesnik and other squad members were requested to be en route to the two-story apartments located in the area of Lime Avenue and West South Street, where Bauduy was supposed to be. Agent Podlesnik was sent to the area of Jackson Street and Lime Avenue which is a block away from the shooting location. Agent Podlesnik advised he began to move into the area of Lime Avenue and West South Street, upon Agent McQuitter advising he could see Bauduy at the bus stop. Agent Podlesnik advised all units were trying to arrive at the bus stop at the same time, as an element of surprise due to previous experiences where suspects tend to "give up" when they feel they are outnumbered. Agent Podlesnik

advised he saw movement from the bus stop area and subjects running back towards the building. Sergeant Vail and Agent John Angizer were giving verbal commands to, "Show me your hands, show me your hands." As Agent Podlesnik rounded the corner, he could hear three to four gunshots. Agent Podlesnik advised he did not see Bauduy until he rounded the corner and Bauduy was already on the ground. Sergeant Vail kept asking, "Where's the other guy? There is a second guy. Where's the gun at?" Then a large group of people began to crowd the scene. Agent Podlesnik was able to get some of the people to move back. Agent Podlesnik then got his first aid kit and assisted in rendering first aid. Agent Podlesnik advised Bauduy did moan a little bit but never stated anything. Agent Podlesnik attempted to use his blood clot kit, to clot some of the bullet wounds on Bauduy until EMS arrived on scene. Agent Podlesnik observed a loaded gun magazine lying next to Bauduy's hat. There was unknown caliber ammunition inside the magazine. Agent Podlesnik advised Agent John Angizer continued CPR while he held pressure on the bullet wounds until EMS arrived on scene.

Agent Podlesnik advised prior to the shooting the sun was out, but it did get dark out very quickly. Due to the sun going down, Agent Podlesnik felt it was hard to determine which officer was talking while they were all trying to render first aid because they were in close proximity to each other and the crowd continued to gather around them. Agent Podlesnik did observe two subjects running from the bus stop area, but could only tell one male had camouflage pants on and that the other subject was taller. The second individual seen running from the bus stop was never located. Agent Podlesnik remained on scene until Bauduy was taken to the hospital.

### **OCSO Agent John Mears**

On April 20, 2018, at 2334 hours, SA Snowden and SA Wiles conducted a voluntary, sworn, and recorded interview with OCSO Agent John Mears. OCSO Detective Miguel Vasquez was also present during the statement. The interview was conducted in SA Wiles' department issued vehicle, while parked at Terry Avenue and Central Boulevard, Orlando, Florida. The following is a summary of the interview:

On the night of April 19, 2018, the Felony Squad began working an investigation into locating a homicide suspect (James Bauduy). On April 20, 2018, Agent Mears advised they were called due to information coming in that Bauduy was in the area of Lime Avenue and West South Street, at the bus stop. As the units approached, a perimeter was established until an Agent could confirm Bauduy was the person sitting at the bus stop. Agent Mears advised the description provided was camouflage shorts, black t-shirt, and a hat. Upon the confirmation that Bauduy was in fact seated at the bus stop, Sergeant Vail, Corporal Hovland, and Agent Mears all began to move in. Agent Mears advised upon exiting his vehicle, he heard Sergeant Vail yelling at Bauduy, "Get on the ground, Get on the ground!" Agent Mears advised Bauduy started to run, and Corporal Hovland began to give loud verbal commands to Bauduy. Agent Mears advised Bauduy started running and stopped running approximately three different times, all while officers were giving loud verbal commands. Agent Mears remembered seeing an unknown black male wearing a hoodie, run towards Bauduy and say something to him. At that time Bauduy began to run with the unknown black male towards the building until they ran into each other. Corporal Hovland was in front of Agent Mears when Agent Mears heard three gunshots. Agent Mears was focused on the unknown black male as he rounded the corner of the building, but upon losing sight of him, he refocused on Bauduy. Agent Mears remembered seeing an unknown item fall from Bauduy's hand when Bauduy and the unknown black male ran into each other on the corner of the building.

At the time of the shooting, Agent Mears did not know who had fired their gun. Agent Mears assisted in taking Bauduy into custody and assisted in keeping the crowd of people away. Agent Mears was able to identify the item he observed fall to the ground, to be a loaded pistol magazine (unknown caliber) and the magazine spring was hanging out of the bottom.

### **OCSO Agent John Angizer**

On April 20, 2018, at 23:23 hours, FDLE SA Ted Silberstein conducted a voluntary, sworn, and recorded interview with OCSO Agent John Angizer. The interview was conducted inside SA Silberstein's assigned FDLE vehicle in the parking lot at Central Boulevard and North Terry Street. Also present during the interview was OCSO Detective Nate Taylor. The following is a synopsis of the interview:

Agent Angizer is assigned to the OCSO Felony Squad. The team was attempting to locate a suspect (James Bauduy), who was wanted in a homicide that occurred the previous day. The team members were Sergeant Bruce Vail, Corporal Randy Hovland, Agent John Podlesnik, Agent Greg McQuitter, and Agent John Mears. Information was received that Bauduy was in the area of a bus stop at South Street and Lime Avenue in Orlando. Agent Angizer observed Bauduy at that location and transmitted the information over his radio to the other deputies. Agent Angizer heard Agent McQuitter transmit over the radio that he too observed Bauduy at that location. Sergeant Vail then transmitted an order to the team to move in and apprehend Bauduy at the bus stop.

Other team members drove up to Bauduy's location in a westbound direction on South Street while Agent Angizer approached in his vehicle in a southbound direction on Lime Avenue along the side of a building. As the team members approached the bus stop, Agent Angizer saw Bauduy run from the bus stop, and Sergeant Vail ran after Bauduy. After seeing Bauduy run and Sergeant Vail run after Bauduy, Agent Angizer's view was obscured by the building. Agent Angizer exited his vehicle and started running in the direction of Bauduy and Sergeant Vail. As Agent Angizer was running, he heard Sergeant Vail shout verbal commands, but he did not recall specifically what the commands were. Agent Angizer then heard three to four gunshots. Agent Angizer did not see who fired the rounds because his view was obscured by the building. When Agent Angizer reached the bus stop area, he observed Bauduy on the ground. Sergeant Vail and Corporal Hovland were standing at the bus stop near Bauduy. Agent Angizer then handcuffed Bauduy with Corporal Hovland's assistance. Agent Angizer observed a magazine from a firearm on the ground next to Bauduy, but he did not know if the magazine contained any rounds. Agent Angizer did not see a firearm. Agent Angizer did not see Sergeant Vail or any of the other team members with their firearms drawn prior to hearing the gunshots. Agent Angizer had his firearm drawn when he initially exited his vehicle, but holstered it when he started to run.

Upon turning Bauduy over, Agent Angizer observed blood on Bauduy's waist and chest area, and Bauduy was unresponsive. Agent Angizer did not hear Bauduy make any verbal comments or threats leading up to the gunshots, or after being shot. Agent Angizer did not hear Sergeant Vail make any comments other than the commands Agent Angizer heard during the foot pursuit. Agent Angizer went to his vehicle to move it closer and retrieve his first aid equipment. Agent Angizer then administered first aid including cardiopulmonary resuscitation (CPR) to Bauduy. Bauduy started breathing momentarily several times while CPR was being administered, but he never regained consciousness.

Agent Angizer did not have a body-worn camera (BWC), nor did he obtain any video or photographs with his cell phone. Agent Angizer drew a diagram of the scene.

### **Fire/Rescue Response**

On May 2, 2018, SA Stephens and SA Lee conducted voluntary, sworn interviews of Orlando Fire Department (OFD) Firefighters/Paramedics, who assisted in the medical treatment of James Bauduy. The interviews were conducted at the Orlando Fire Department Headquarters in downtown Orlando. The following is a summary of those interviews:

Firefighter/Paramedic Carlos Tavaréz responded to the scene at Lime Avenue and South Street after the scene had been deemed secure. Firefighter/Paramedic Tavaréz described a very dimly lit and crowded scene with lots of onlookers. Firefighter/Paramedic Tavaréz recalled that Bauduy was pulseless when he arrived at the scene. According to Firefighter/Paramedic Tavaréz, Bauduy was handcuffed in the rear when he arrived and was unsecured by the OCSO agents to more effectively render aid. In order to better assess Bauduy's condition, Firefighter/Paramedic Tavaréz cut Bauduy's clothes from his body. Firefighter/Paramedic Tavaréz observed what he believed to be a gunshot wound on Bauduy's right hip. Firefighter/Paramedic Tavaréz also performed Cardio Pulmonary Resuscitation (CPR) on Bauduy while on scene.



Firefighter/Paramedic Tavares did not observe any physical encroachment from the onlookers or see anything remarkable about the scene. Bauduy did not regain consciousness at any time while Firefighter/Paramedic Tavares was treating him.

Firefighter/Paramedic Justin Hartley arrived at Lime Avenue and South Street and witnessed officers administering CPR to an unresponsive Bauduy. Firefighter/Paramedic Hartley took over medical care from the officers and observed no pulse on Bauduy. Firefighter/Paramedic Hartley was told by one of the surrounding officers that Bauduy had been shot by an officer. Firefighter/Paramedic Hartley did not observe anything that resembled a weapon but he stated he was not looking for items of that nature.

Firefighter/Paramedics Hartley and Tavares transported Bauduy to Orlando Regional Medical Center via Orlando Fire Department's ambulance R001.

### Civilian Witness Interviews

~~██████████~~

On April 23, 2018, at 1450 hours SA Snowden and SA Wiles conducted a voluntary, sworn and recorded interview with ~~██████████~~ Aime at 318 Lime Street Orlando, Florida. The following is a summary of the interview:

Aime advised he owns the residence located at 318 Lime Street and on April 20, 2018, he was there to change out the door lock on the downstairs front door. Aime owns the entire residence, but the top floor is divided into individual apartments, which are rented to unidentified tenants. Aime observed two officers exit unmarked vehicles, wearing what he described to be short pants and an "Army," style uniform. Aime was unable to provide a description of the officer's vehicles but could see blue emergency lights activated in the vehicles. Bauduy was sitting at the bus stop but then took off running upon the officers exiting their vehicles. Aime could hear the officers yelling, "Stop!" Aime advised Bauduy then stopped up against the building and that is when he heard gunshots. While speaking with Aime, he continually made a motion utilizing both of his hands when referencing the gunshots. Aime would demonstrate holding both arms out and firing; utilizing the motion of someone firing a rifle or shotgun, but upon further questioning, he could not provide any description of the weapons. Aime was unable to advise the time of the day the incident took place but advised it was light outside. Aime could see the officers rendering first aid/CPR on Bauduy until EMS arrived on the scene.

Aime never walked across the street to get a closer view of the scene but estimated more than one hundred people were around the outside of the crime scene tape. Aime advised the apartment tenants did come out to see what had occurred and were in close proximity to the shooting location. Aime identified a female who had defecated on herself as a possible eyewitness that resided in an apartment next to the shooting location.

~~██████████~~

On April 23, 2018, SA Stephens and SA Lee returned to Lime Avenue and South Street to search for any additional witnesses. SA Stephens conducted a sworn, recorded interview with ~~██████████~~ Brown, who recalled her account of the incident. Segments of ~~██████████~~ Brown's statement were unintelligible and could not be understood by SA Stephens, but the following is a summary of that interview:

~~██████████~~ Brown stated that she saw some vehicles come up and then they (OCSO agents) said "stop," and then he (Bauduy) put his hands up and that's when they (OCSO agents) shot him. Later in her interview, ~~██████████~~ Brown alleged that the "officers" didn't say anything and that the surrounding neighbors said, "Stop, that man ain't got no gun". ~~██████████~~ Brown states again that "they (OCSO agents) ain't said stop, or put your hands up, or nothing".

~~\_\_\_\_\_~~  
On April 23, 2018, at approximately 1435 hours, SA Lee obtained a voluntary, sworn and recorded statement from ~~\_\_\_\_\_~~ outside of 621 W. South Street, in Orlando, Florida. In summary, ~~\_\_\_\_\_~~ provided the following testimony:

~~\_\_\_\_\_~~ was at the bus stop with an individual known to her as "New York" [James Bauduy]. Bauduy had just "taken a hit" when the officers jumped out and said "Get down, get down," and "We scattered." ~~\_\_\_\_\_~~ said that "When he [Bauduy] turned, he seen the wall, then when he came around, just as he was coming around his hands were about this high up (abdomen/chest level) the officer just started spraying it and every time he shot him blood just skeet out his chest." Then he [Bauduy] fell down.

While Bauduy was down the officer put his foot on him and then handcuffed him. Then the officers walked around and didn't try to revive him. The police did not render aid and it took the ambulance forever to get there.

The crowd started to shout and it got a little wild. ~~\_\_\_\_\_~~ referred to the officers, saying, "They let us know, okay, we done killed him, if ya'll don't get your asses back we'll shoot one of ya'll."

~~\_\_\_\_\_~~ felt that the officer did not have to shoot Bauduy. She said they could have "tasered" him because he had no weapon. ~~\_\_\_\_\_~~ said that, "He smoked crack, he had a crack pack." "He turned around because, anybody that got sense you couldn't run from the police, boom, you see the wall, what you gonna do. If you got good sense you give yourself up."

~~\_\_\_\_\_~~ said that they saw the officers riding around but Bauduy did not say anything about the police looking for him.

~~\_\_\_\_\_~~ said that, "The one that come out the car, the one that shot him said, 'Get down, get down.'" ~~\_\_\_\_\_~~ said she heard four shots and that the officer that shot him got out of a gray or silver Charger. She later said that two officers shot.

~~\_\_\_\_\_~~ said Bauduy fell on his back and the officer rolled him over to handcuff him. Bauduy didn't have anything on him but a crack pipe and some dope.

~~\_\_\_\_\_~~ said they tried to go up to Bauduy but the officers kept the crowd away, and no one was able to get close enough to touch him.

~~\_\_\_\_\_~~ only knew Bauduy by his street name of New York. He did not live in the area, he came here to smoke crack. ~~\_\_\_\_\_~~ felt that it was an unnecessary killing, they should have let the law or the system deal with him, and they didn't have to kill him.

#### Walter Rosemond

On April 20, 2018, SA Stephens and SA Lee contacted ~~\_\_\_\_\_~~ in front of 318 Lime Avenue while canvassing the area for witnesses to the use of force incident. ~~\_\_\_\_\_~~ indicated he witnessed the incident from his second-floor window facing Lime Avenue.

~~\_\_\_\_\_~~ stated that a white car approached the bus stop in front of 621 W. South Street and two officers exited the vehicle and ordered the guy wearing "khaki long pants" [Bauduy], who was at the bus stop, to "Stop or come over here." When the officers approached Bauduy, he ran towards the building past the yellow pole. Two to four officers, wearing khaki pants, were following him. They [police] told him [Bauduy] to stop but he tried to run away.

~~\_\_\_\_\_~~ claimed he heard around four shots, however, when he reenacted the shooting, he demonstrated eight shots. After ~~\_\_\_\_\_~~ heard the shots he observed Bauduy fall to the ground.

~~Redacted~~ described that the two shooting officers searched Bauduy on the ground after he was shot and did not find anything. ~~Redacted~~ said that two officers in a Jeep arrived two minutes after the shooting and searched Bauduy again and they dropped something. ~~Redacted~~ could not describe what the object was or what the individuals looked like who dropped the object.

At the onset of the interview and several times throughout, ~~Redacted~~ referenced the crime scene and the "trash" all over the scene. ~~Redacted~~ alleged that the officers threw the trash on the ground to make it look like a bad area or a drug area. The items that ~~Redacted~~ referred to were used medical supplies and packaging. ~~Redacted~~ again referenced that the responding "ambulance" dropped "stuff" all over the area.

~~Redacted~~ was prevented from answering any more questions when he was escorted into the house by an unidentified acquaintance away from the Special Agents.

### ~~Mary [Redacted]~~

On April 24, 2018, at approximately 1157 hours, SA Lee and SA Stephens obtained a voluntary, sworn and recorded statement from ~~Mary [Redacted]~~ at 1814 Riley Avenue, Orlando, Florida.

~~Redacted~~ has known "James" [Bauduy] since 2010. Both of their families are from Haiti. ~~Redacted~~ said that for the past two weeks, James was having emotional problems because something happened to his daughter and he got back on drugs. ~~Redacted~~ indicated that when James used drugs he "twitches," which she demonstrated by moving her arms quickly back and forth from side to side, and maybe that made the officers think James was trying to pull something. ~~Redacted~~ recalled that before the police arrived, she observed James twitching or fidgeting and thought to herself that he should not be moving like that outside because the police would stop him.

~~Redacted~~ initially indicated that she was in the apartment next door to where the shooting happened. ~~Redacted~~ later described that she was standing outside the apartments, near the sidewalk close to Terry Avenue, between twenty-five to thirty yards east of the bus stop. ~~Redacted~~'s attention was first drawn to this incident by officers, one wearing a green uniform, walking up to the area. Shortly thereafter, officers showed up in vehicles "from every direction."

~~Redacted~~ said that before the police arrived, James was getting high. ~~Redacted~~ described James as "fidgeting" prior to the use of force incident. ~~Redacted~~ stated James was both sitting and standing at the bus stop when the officers handcuffed him. ~~Redacted~~ said that James wasn't reaching for anything, "To my knowledge he was already in handcuffs," and, "They didn't have to shoot him like that." ~~Redacted~~ stated that James was in handcuffs when he was shot.

~~Redacted~~ did not hear James or the officers say anything during the shooting.

~~Redacted~~ said there were three other people at the bus stop with James, but could not remember their names. ~~Redacted~~ described one was a homeless man wearing a white T-shirt. Referring to the other people at the bus stop with James, ~~Redacted~~ said they took off.

~~Redacted~~ indicated the police were surveilling the area because earlier somebody called the police and reported that James had a gun.

~~Redacted~~ knew of no one else that witnessed the incident who would talk to law enforcement.

~~Redacted~~ felt that what happened was wrong and that is why she approached Sheriff Demings.

The interview was concluded at 1226 hours.

## **Orlando Police Department Confidential Informant**

On June 14, 2018, SA Stephens and SA Lee conducted a voluntary, sworn, and recorded interview with Orlando Police Department (OPD) Confidential Informant (CI), BD2015. The CI's identity was verified prior to the interview by SA Stephens and SA Lee. Also present at the interview was OPD Detective Andre Howard.

On April 20, 2018, the CI advised she/he was in the area of the use of force incident, but did not see or hear any portion of the event.

### **Neighborhood Canvass**

On April 20, 21 and 23, 2018, Special Agent Supervisor (SAS) Andrew Watts, SA Stephens, SA Lee, SA Silberstein, SA Dale Crosby, SA Snowden, and SA Wiles conducted neighborhood canvasses of Lime Avenue and West South Street to search for witnesses to the officer involved use of force. Many neighbors and onlookers were unwilling to give any information about either the incident or themselves.

The incident occurred in front of 621 West South Street. This address is a group of three apartment buildings.

#### **621 W. South Street**

##### **Apartment #1**

On April 20, 2018, SA Silberstein spoke with ~~Denise Fortin~~ at 621 West South Street, Apt. 1, Orlando. Tertilien stated that she was sleeping and did not hear or see anything in regards to the use of force incident.

On April 21, 2018, at 0133 hours, SA Lee knocked on the door and received no answer.

On April 21, 2018, at approximately 1410 hours, SA Lee contacted a male, who identified himself as ~~John Fortin~~, who stated he was not present at the time of the incident. John said that his mother, ~~Denise Fortin~~, rents the apartment and she was not at home at the time of the incident either.

##### **Apartment #2**

On April 20, 2018, SA Silberstein attempted to make contact with the residents of 621 West South Street, Apt. 2, Orlando. SA Silberstein could not make contact with anyone at the residence and left a business card.

On April 21, 2018, at 0133 hours, SA Lee knocked on the door and received no response.

On April 21, 2018, at approximately 1415 hours, SA Lee knocked on the door and received no answer.

##### **Apartment #3**

On April 20, 2018, SA Snowden and SA Wiles knocked on the door and received no answer.

On April 20, 2018, SA Silberstein knocked on the door and received no answer.

On April 21, 2018, at 0133 hours, SA Lee knocked on the door and received no answer.

##### **Apartment #4**

On April 21, 2018, at 0133 hours, SA Lee knocked on the door and received no answer.

On April 21, 2018, SA Snowden and SA Wiles contacted a female who stated she did not witness any of the events leading up to the shooting incident.

Apartment #5

On May 16, 2018, SA Lee knocked on the door and received no answer.

Apartment #6

On May 16, 2018, SA Lee knocked on the door and received no answer.

Apartment #7

On April 20, 2018, SA Silberstein spoke with ~~Alexander Coleman~~ at 621 West South Street, Apt. 7, Orlando. Coleman shared with SA Silberstein that he heard 4 gunshots but did not see anything related to the use of force incident.

On April 21, 2018, at 1430 hours, SA Lee knocked on the door and a male voice answer saying "I'm busy" and refused to come to the door.

Apartment #8

On April 20, 2018, SA Silberstein spoke with ~~Andrea Jackson~~ at 621 West South Street, Apt. 8, Orlando. Jackson disclosed to SA Silberstein that she heard someone yelling commands to "get your hands up" then heard approximately 5 gunshots but did not see the shooting. Jackson recalled that she looked outside and saw a deputy administering Cardio Pulmonary Resuscitation (CPR) to a subject on the ground. On April 21, 2018, at 1428 hours, SA Lee contacted ~~Mike Williams~~ who said he heard three to four shots and then came outside. When ~~Williams~~ came outside he observed someone handcuffed. ~~Williams~~ said that he "heard that he ran till he couldn't run no more and they shot him with his hands up." ~~Williams~~ told SA Lee there was no one else in the apartment.

At 1430 hours, after ~~Williams~~ walked away, SA Lee knocked on the door again. A male answered by voice but would not come to the door.

Apartment #9

On April 21, 2018, at 0133 hours, SA Lee knocked on the door and received no answer.

Apartment #10

On April 21, 2018, at 0133 hours, SA Lee knocked on the door and received no answer.

On April 21, 2018, at 1428 hours, SA Snowden and SA Wiles contacted a black male who declined to give his name, but said he was not at home at the time of the shooting.

**630 West South Street**

On April 21, 2018, at approximately 0010 hours, SA Lee contacted ~~Jean Charles Felix~~ who stated he did not hear or see any events leading up to the shooting incident.

On April 23, 2018, SAS Watts spoke with an unidentified, elderly black female at 630 South Street, Orlando. The female indicated that she did not see, hear, or otherwise witness any events surrounding the shooting incident on April 20, 2018. The female declined to provide her name, and spoke to SAS Watts through the screened door.

**638 West South Street**

On April 21, 2018, at 0010 hours, SA Lee knocked on the door at 638 West South Street and did not get a response.

On April 23, 2018, SAS Watts spoke with [REDACTED] at 638 West Street, Orlando. [REDACTED] indicated that she heard gunshots, but did not witness the shooting or any events leading up to the shots. Chambers indicated that a number of law enforcement vehicles arrived, and that she then called news stations Channel 9 (left a message) and Channel 13 (already aware and on their way).

On April 23, 2018, SAS Watts spoke with [REDACTED] at 638 West South Street, Orlando. [REDACTED] stated that he heard shots, came outside, and was told by deputies to back away. Jones did not witness the shooting or any events leading up to the shots, and went back inside as directed.

On April 23, 2018, SAS Watts spoke with [REDACTED] at 638 West South Street, Orlando. [REDACTED] was in the backyard when she heard gunshots. When [REDACTED] walked to the front, other police officers arrived and put up crime scene tape. [REDACTED] did not witness the shooting or any events leading up to the shots. Other people were present with [REDACTED] when SAS Watts spoke to her, but none agreed to speak with SAS Watts. One male asked SAS Watts to give a business card to [REDACTED] in case someone wanted to talk.

### **308 Lime Avenue**

On April 21, 2018, at approximately 0110 hours, SA Lee knocked on the door and did not get a response.

### **312 Lime Avenue**

On April 21, 2018, at 0056 hours, SA Lee contacted [REDACTED] who stated she was at the washette and not at home at the time of the shooting incident.

### **318 Lime Avenue**

On April 20, 2018, SA Stephens contacted [REDACTED] who provided a voluntary, sworn, and recorded statement which is documented in the above interview.

On April 21, 2018, at 0015 hours, SA Lee spoke to a male, later identified as [REDACTED], who indicated he owned the building and was repairing an electrical problem. [REDACTED] said that the "Police, the Duke Boys, wearing army uniform shorts chased the subject and just shot him." [REDACTED] did not provide any further information at that time. However, SA Danielle Wiles and SA David Snowden obtained a sworn statement from [REDACTED] which is documented in the above interview.

### **West South Street**

On April 23, 2018, at approximately 1435 hours, SA Stephens contacted [REDACTED] who provided a voluntary, sworn, and recorded statement which is documented in the above interview.

On April 23, 2018, at 1435 hours, SA Lee contacted [REDACTED] who provided a voluntary, sworn, and recorded statement which is documented in the above interview.

## **Crime Scene Activities and Evidence Submission**

On June 29, 2018, SA Stephens received the crime scene report from the Orange County Sheriff's Office. The report was authored by Crime Scene Investigator (CSI) Junella Uadan and contained supplemental reports by

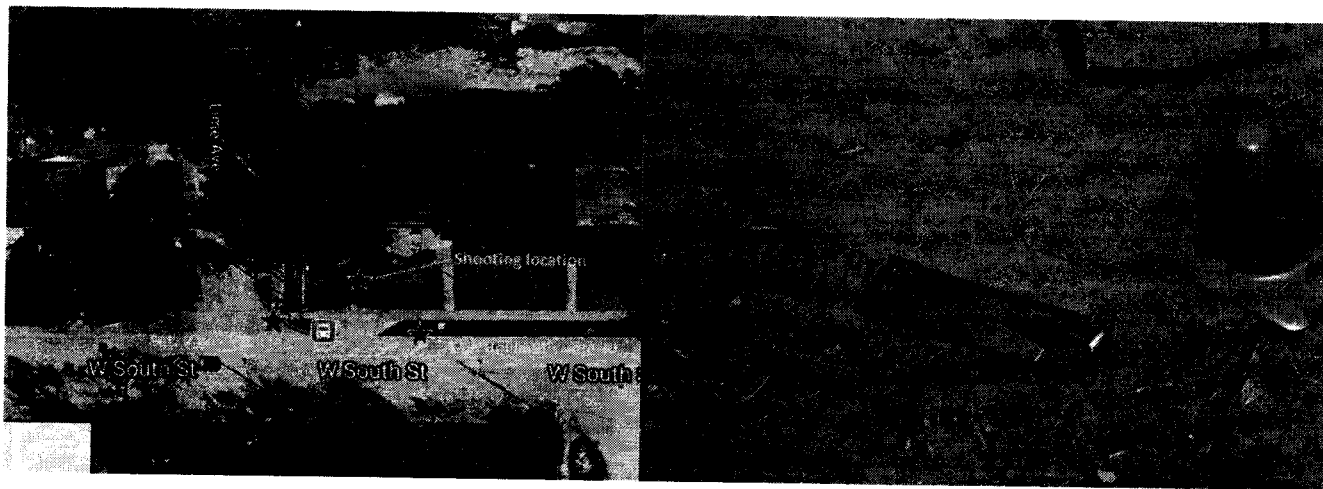
### Biology Laboratory Report

On July 3, 2018, Special Agent Jonathan Stephens was provided an FDLE Laboratory Report from Senior Crime Laboratory Analyst Shawn Johnson, concerning all biological evidence submitted. The following is a summary of the report and its findings:

**RESULTS:**

STR DNA analysis was performed on samples from Exhibit JS19a and JS19b utilizing the GlobalFiler PCR Amplification Kit. The same complete DNA profile consistent with a male individual was obtained from Exhibits JS19a and JS19b. This DNA profile matches the DNA profile from James Bauduy (JS11). The observed DNA profile is greater than 700 billion times more likely to occur if the sample originated from James Bauduy (JS11) than from an unrelated individual.

**Cause of Death:** Gunshot wound to the pelvis

**Toxicology:** Positive testing for Cocaine Metabolites
