FROM THE DIRECTOR

Greetings Everyone.

I am finding it hard to wrap my head around the fact that I have been at The Arc Community Advocates for almost 2 years. It has been an interesting time to step into a role and much of my purview has been dealing with Covid; along with learning the ins and outs of running such a fantastic organization.

Following our annual meeting last September, we finalized and secured a lease for office space in The Central Corners on the Vine building which is managed by The Vine Neighborhood Association. We were able to secure grants from The I.S. Gilmore Foundation and The Jim Gilmore Jr. Foundation totaling \$28,000 to assist with the cost of the move itself, along with updating the flooring and some of our existing furniture, making it accessible (automatic doors!), and all the odds and ends that a big move entails. It has taken us the last 8 months to finally settle in. We began to return to the office this spring and have been open to the public since early Summer. This all culminated in our Grand Opening celebration on the first Friday in September.

While we were settling in, we still managed to keep things up and running. We hosted our 2020 Annual Inclusion Conference (virtually) and had a great turn out. Since that time, we have been rebroadcasting a number of those excellent presentations throughout the remainder of 2021.

The number of cases in 2020 were reduced during the Covid Lockdown as a direct result of the adjusted school and life schedules. In 2021, things are on the upswing and in the last year,

we have been engaged in supporting several adults with long term planning. We are excited to see how things will emerge from here. What we do know is that there are still plenty of people in our community who could use our support and we are excited and well positioned to continue to do that.

Financially the organization is in good shape. We were lucky to have secured a second Payroll Protection Grant early in 2021 and that has allowed us to retain all our staff, despite slightly reduced caseload numbers during the Covid Pandemic. We had several grantors that were able to meet our requests for additional funding and we secured a new grant from the Stryker Johnston Foundation for the first time. All of this has left us on firm financial footing for the 2021 fiscal year.

At this time, I would like to take this opportunity to thank all of our staff members and the board for their ongoing support as we navigate these unusual times. I would like to send a special shout out to Kelley Howard and Allison Hammond. Without their (almost) daily support, I am not sure we could have navigated these last 2 years as well as we have.

Joseph A. Cekola Memorial Fund



Nick Cekola

Joe Cekola was a pillar of the community in Kalamazoo. Not only was "Big Joe" a successful entrepreneur and businessman operating a number of iconic establishments in the Kalamazoo area, he was also generous with his time and money, finding ways to support the community around him. He was known to help family, friends, and practically anyone who showed up. He did this with little fanfare or public acknowledgement and often in secret. His philosophy around philanthropy was that "it was important to give until it hurt and then to give a little more."

Big Joe was also a family man; married to Dee, they had 6 children and each one of them has made a contribution to the family businesses over the years. The eldest sibling, Nick, experiences Down Syndrome and the family was encouraged to place him in an

institution after he was born. Like a number of families in the Kalamazoo Community, the Cekola's chose to keep Nick at home. This choice came with a personal and financial burden; yet not a single family member would say that it wasn't worth it. Nick's siblings would agree that he is the glue that holds them all together and their life would be so much less without him.

In 1994, Big Joe Cekola passed away at the age of 62. Yet, his legacy endures through his children, who continue to be business owners and entrepreneurs in Kalamazoo and beyond. The family also wanted to continue his legacy of giving. So, in 1995, the family gathered to discuss how to utilize the generosity of the community following their dad's passing. That decision has led to an annual fundraiser, paid for by the family, with all the proceeds going into The Joseph A. Cekola Memorial Fund. The intention was to honor Big Joe's love of family, generosity, and kindness towards others. The fund's mission is to provide financial assistance for the families with permanently disabled children who desire to maintain the family unit by caring for the child in their home.

The Arc Community Advocates is proud assist with their mission by screening and allocating funds to families who meet the fund's criteria.

In 2020, we helped 2 families. So far in 2021, and The Cekola Fund just approved an application to assist a family in upgrading their new van to make it






INCOME LEVEL

Below Poverty 50%








AREAS OF ADVOCACY
