

2024 OR 2025 BREEDING CONTRACT FOR PRESLEY

\$3000 includes 1st shipment and collection for fresh in United States And Canada

hereafter referred to as the mare	owner.	

The breeding service fee for Gitt A Hunka Burn 'N Love, Gypsy Horse stallion, shall be \$3000 for one breeding. \$1000 is paid as a non-refundable booking fee upon signature of agreement. The remainder of \$2000 is due anytime prior to shipment. This entitles mare owner to breed one (1) approved Gypsy mare to Gitt A Hunka Burn 'N Love for the 2024 or 2025 breeding season by artificial insemination, by way of shipped chilled semen (If we have frozen semen available that is also an option with frozen shipping fees not included).

1. Collection and shipping will be paid by Stallion owner for 1st shipment and collection. Stallion owner will make every attempt to send two doses in the cooled semen shipment (Presley ships extremely well). If a rebred is needed it will be \$250 at mare owners expense.

If mares live in Canada there is an International Heath Certificate fee that will be an additional fee (It used to be \$75 but it could be up to \$150). Also Our Farm will need to be listed on your Canada Veterinarians Import Certificate:

Mares coming for live cover will have one week paid board. They must have a current coggins and health certificate if from out of state. We are not liable for any injury from live cover. Mares are provided with an individual small round pen or you can pay for a 12 x 12 stall at an additional \$15 day.

- 2. There will be no balance due prior the time of collection unless otherwise specified. Shipping container must be returned within 14 days of receipt.
- 3. Collection service requires a 24-HOUR NOTICE. Stallion owner guarantees semen to be of adequate quality to ship and inseminate. We CANNOT SHIP ON SUNDAY. If you need a last minute shipment call and I will do my best to get it out same day.
- 4. In the event of the death of the stallion, or if he becomes unable to stand as a breeding stallion, as determined by a licensed veterinarian, the stallion owner may, at their discretion, offer a substitute stallion or frozen semen.
- 5. Stallion owner reserves the right to substitute frozen semen if available or ship during the next heat cycle in the event that the stallion is showing/competing during the time of the request. Show dates will be available upon request. Presley is scheduled to be home for the 2024 season.
- 6. Any mare to be bred under this contract must be healthy and in sound breeding condition and free from infection and disease. In the event the service is refused or the mare does not get in foal, the mare owner has return privileges and may substitute another approved mare for a period of 12 months from the original breeding date. Stallions have a Live Foal Guarantee (LFG). "Live Foal" meaning that a foal is born viable and survives the first 30 days. Mare owner shall be permitted to rebreed the mare or substitute another mare for a period of 12 months from the date that the mare lost the foal or during the following breeding season, but will have to pay collection and shipping fees (\$250 plus extra for Canada health export papers if applicable). There may also be an additional handling fee if the mare is sold to another party and needs more semen to be shipped (current shipping and collection rates would then apply).
- 7. Stallion owner must be notified of mare's pregnancy status within 30 days of the mare's last breeding date. If this condition is not met, Live Foal Guarantee (LFG) is null and void. Mare owner agrees to provide adequate feed, shelter and care, plus vaccinations of rhinopneumonitis at 5, 7 and 9 months of gestation to mare while she is pregnant. Showing, shipping, stressful living conditions or campaigning mare may also void this contract.
- 8. Mare owner must sign a contract. Mare owner is liable for all collection and shipping fees after the first collection and shipping for each breeding. Foal registration papers (Breeding Certificate) will not be signed until owner has paid all outstanding fees. Please also email or attach a copy of the Mare's registration papers to us.

9. This agreement constitutes the entire agreement of the parties. 10. This breeding contract is valid for breeding anytime in the 2024 season and 2025 season All payments can be made by Paypal.me/riversedge or paypal KatiesKennelsMN@gmail.com or I can send a quickbooks invoice.
