NOTICE AND DISCLOSURE OF TAXING AUTHORITY BY COQUINA WATER CONTROL DISTRICT

Coquina's annual bill to the owners of real property within Coquina will be shown, in addition to real property taxes and charges of other governmental entities, on the Real Property Tax Bill that is sent out around November of each year by the Okeechobee County Tax Collector.
