HAGUE PROPERTY REASSESSMENT AND TAXES

All properties in the Town of Hague have now been reassessed by Maxwell Appraisal Services. Based on Maxwell's appraisals, the value of each property in Hague has been updated and information has been sent out to property owners.

Those who question the assessment of their property may make an appointment for a phone conversation with Town of Hague Assessor Dave Martucci by calling 518-543-6161, ext. 23. Available dates and times for appointments are April 3rd, 10th and 17th from 10 am – 2 pm, May 8th, 10th and 15th from 10 am – 2 pm, and Saturday, May 13th from 4 pm – 8 pm.

The next step in determining a property owner's future taxes is that the school board, the town, and the county will determine their budget needs for the following year. Based on those budgets, a tax **rate** will be determined by each jurisdiction. That rate will be applied to the newly-appraised values of each individual property in Hague to determine the tax liability for each owner.

In September, owners of property in Hague will receive their resulting individualized school tax bill. In January, owners will receive their individualized county tax bill and fire district tax bill. It should be noted that the Town of Hague is fortunate to have no town tax, as many other communities do.

Martucci plans to attend the next Hague Town Board meeting on Tuesday, April 11th at 6 pm to update the assessment process and to answer questions that have been posed. Residents are urged to attend this meeting in person or via ZOOM. The ZOOM link to that meeting will be on the Town of Hague's website at townofhague.org and on the town's Facebook page.

NORTHWAY EXIT 24 CLOSURES AND DETOURS THIS APRIL - NOVEMBER

From the New York State Department of Transportation:

The Warren County Route 11 bridge over I-87 (the Northway), as well as the southbound Exit 24 on and off ramps, will be closed indefinitely for a bridge replacement project starting Monday, April 3, 2023. There will be alternating lane closures northbound and southbound as work progresses. There will be occasional shutdowns of I-87 northbound and southbound from 12 am to 6 am, and advance notice will be given before this occurs.

The bridge, known as NY 915P, will be fully closed to traffic during

construction. I-87 southbound ramps will be closed during construction while I-87 northbound ramps will remain open to traffic.

I-87 Exit 24 southbound off-ramp traffic will be detoured to Exit 23 and come back on I-87 northbound to exit via the Exit 24 northbound off-ramp. This detour adds approximately 16 minutes to travel time. County Route 11 traffic heading to I-87 southbound will be detoured to the north and enter I-87 southbound at Exit 25. This detour adds approximately 11 minutes to travel time.

The detours are expected to be active during the construction of the bridge from April to November 30, 2023.

A POSSIBLE SOLUTION TO THE EURASIAN WATERMILFOIL PROBLEM

I am relieved that the Lake George ProcellaCOR experiment will not be executed. I thank Judge Muller for his decision, as well as the LGA and the Hague and the Ticonderoga communities for their support. My family has enjoyed our home in Silver Bay (and drinking the water of Lake George) for the past 75 years.

However, there is still milfoil in the lake that needs to be removed! So, what are the alternatives? My avocation as a SCUBA diver has taken me to the depths of the lake from its north to south basins. I can relate to the tedium and difficulty of hand harvesting the milfoil – especially in the hard-to-get places.

I was wondering if the following alternative has been considered: We are in the 21st century and herbicides are so 20th century! Robots have now been integrated into all aspects of our lives. We have bots on planets evaluating soils, bots that perform surgery, bots that build cars, and bots that vacuum floors and rugs.

Why can't we build a system of bots to harvest the milfoil? What a great

NO PROCELLACOR HERBICIDE IN LAKE GEORGE IN 2023

In a decision issued on March 3, 2023, NY State Supreme Court Justice Robert Muller ruled that the Adirondack Park Agency (APA) acted arbitrarily and capriciously in 2022 in granting a permit to the Lake George Park Commission (LGPC) to put ProcellaCOR in Lake George to combat Eurasian watermilfoil.

Brief recap of the history: Last June, in a suit brought by the Lake George Association (LGA), the Lake George Waterkeeper, the Town of Hague and property owner Helena Rice, Judge Muller issued a temporary injunction against the use of ProcellaCOR until such time as he could hear oral arguments from both sides. The LGPC planned to test the herbicide in two bays on the east side of Lake George – in Blairs Bay in Glen Burnie and in Sheep Meadow Bay in Huletts Landing. Both sites fall within Hague's jurisdictional boundaries. The town governments of Hague, Ticonderoga, and Dresden (where Huletts Landing is located) have all adopted resolutions opposing the use of ProcellaCOR. In addition, more than 4,600 people have signed a petition against its use and hundreds have written letters of opposition.

The oral arguments were heard in February of 2023 and Judge Muller issued his opinion on March 3rd. In his detailed decision, Muller noted that APA staff had painted a one-sided picture about ProcellaCOR in their presentation to the APA commissioners. "Of the 110-page PowerPoint presentation," he wrote, "only nine pages were devoted to the 325 public comments in opposition — with these comments minimized during the presentation itself." Muller also pointed to other issues with the APA's review process, including the fact that many public comments ended up in an APA spam folder. In addition, the APA counsel provided questionable advice to commissioners on the timeline for holding an adjudicatory hearing.

The APA and LGPC are currently weighing their options for next steps. Even if the LGPC chooses to pursue its application, there is not enough time to complete the permitting process before the May/June date when ProcellaCOR would need to be applied.

The LGPC argues that the herbicide is safe, pointing to the fact that it has been approved by the Environmental Protection Agency and the Department of Environmental Conservation (DEC). But there are many open questions: How will it affect Lake George specifically, where it could potentially upset the lake's delicate ecosystem balance that keeps our waters pristine? Furthermore, according to its product label, ProcellaCOR is designed for use in quiescent waters, not for fast-moving bodies of water like Lake George. And another question: The manufacturer guarantees the effectiveness of its product for three years, yet its proponents say it dissipates very quickly. Waterkeeper Chris Navitsky questions how both statements can be true.

In a <u>joint letter</u> to the APA and DEC on March 16th, the LGA and the Lake George Waterkeeper detailed a number of serious scientific deficiencies in the current permit applications. They noted, "Lake George is simply too special an ecological and economic resource to risk long-lasting damage to its water quality, plants, and organisms from an unnecessary experiment.

Albany's *Times Union* newspaper agrees, stating in a <u>March 21st editorial</u>, "We can't seem to say this enough: One of the nation's most pristine lakes is not the appropriate place for a chemistry experiment that could risk its water quality and all that depends on it."

ZONING BOARD OF APPEALS - 3/9/2023

(Rescheduled from 2/23/23 due to inclement weather)

Chairman Robert Goetsch and Board Members Jon Hanna, Ray Snyder, and Alternate Cathy Clark were present. Chris Navitsky and Linda Mury were absent. Also present was ZEO Matthew Magee.

RYPKEMA (93.12-1-17) 115 Sabbath Day Point Road (TR1)

In preparation for a house remodeling, the owners would like to construct a new two-bay garage in the northwest corner of their property. The proposed location would not meet the required 15-foot rear lot line setback. A public meeting was held. The owner's son indicated a garage could be built within the required setbacks, but would block their rear neighbor's lake view, whereas the proposed location would not. In support of the variance, a letter was read from the neighbor who adjoins the rear lot line. The neighbor has a shed near the corner of their property that is in line with the proposed garage location and feel they would not be materially inconvenienced. No one spoke against the variance. The board unanimously approved the application.

WILSON/DAVIS (93.12-1-11) 7930 Lakeshore Drive (TR1)

The applicants are requesting the total replacement of a non-conforming structure requiring two variances. The proposed structure would result in a lot coverage of 38.8% compared to 30% allowed by code. The current lot coverage is 36.2%. The increase of the proposed changes would be 52%. (Code allows only 25%.) The structure shoreline setback would remain at 16 ft. and the sideline setback would be increased by 11/2 ft. Neither of the original setbacks met existing code. A site plan review by the Planning Board is required for a total replacement of a non-conforming structure. This is a jointly-owned lot with two principal residential structures, each belonging to a different owner. The lot has a shared septic system and the lot is unable to be subdivided, per code. A site visit was scheduled and a public hearing will be held at the next ZBA meeting on March 23rd.

PLANNING BOARD - 3/2/2023 & 3/16/2023

Deputy Chairman Pam Peterson and Board Members Judy Gourley and Sandy Powell were present. Meg Haskell was present on video chat. Chairman Dick Frasier was absent. Also present were ZEO Matthew Magee and Recording Secretary Cathy Clark.

TROUT HOUSE VILLAGE RESORT, LLC/HENRY KNOX REALTY, LLC (26.17-2-39 & 26.147-2-38 & 26.17-2-41.1) 9117 Lakeshore Drive (HP)

The applicants wish to reconfigure Tax Lot 39 to increase the lakefront property line length from 89 ft. to 154 ft. to make an existing dock compliant with the LGPC spacing and setback requirements. The additional lakefront footage would be taken from the lots to either side of Tax Lot 39. All three lots are owned by the applicants. A public hearing was waived. The lot line change was unanimously approved with no conditions.

WILSON/DAVIS (93.12-1-11) 7930 Lakeshore Drive (TR1)

The applicants are requesting the total replacement of a non-conforming structure requiring two variances. The proposed structure would result in a lot coverage of 38.8% compared to 30% allowed by code. The current lot coverage is 36.2%. The increase of the proposed changes would be 52%. (Code allows only 25%.) The structure shoreline setback would remain at 16 ft. and the sideline setback would be increased by 1½ ft. Neither of these current structure setbacks meet existing code. A site plan review is required for a total replacement of a non-conforming structure. This is a jointly-owned lot with two principal residential structures, each belonging to a different owner. The lot has a shared septic system, and the lot is unable to be subdivided, per code. A site visit was set.

The meeting was left open to allow decisions on a referral to the Zoning Board of Appeals (ZBA) to be made after the site visit on March 16th.

After the site visit, the board made a unanimous referral to the ZBA to approve the application with the following conditions:

- 1. The structure should be moved away from the lake as far as possible without encroaching on the 25-foot lot line setback.
- 2. The lot coverage percentage must remain at the current 36.2%.
- 3. The lakeside foundation should only have a service door and no windows.
- 4. All components of the structure must be kept out of the deeded easement.
- 5. If a Lake George Park Commission stormwater permit is not required, then the applicant will submit a stormwater permit to the Hague Zoning Enforcement Officer (ZEO) for approval. This must be implemented prior to the certificate of occupancy (CO)
- 6. A new wastewater system must be approved and implemented prior to the CO.

PUBLIC HEARING

Steve Robb (Sec. 93.16 Block 1 Lot 43) 24 Sabbath Day Point Road (TR-1R)

Jarrett from Jarrett Engineers, PLLC reviewed the application. Cedarwood Engineering suggested two additions that will be added to the approved application.

WELCOME GUESTS/PRIVILEGE OF THE FLOOR

Fritzky stated the Highway Department did a great job during the storm. Trudeau thanked the community for its help when they offered a warming station, food, and water during the snow storm.

Assessor David Martucci once again reviewed the reval (property values reassessment) procedure and how assessment equity is the goal of the Assessor's Office. Change in the market trends and demands were key in choosing to do this reval. Martucci stated about 10% of the community has responded to the reval.

Martucci is scheduled to sit with the assessment records to review inventory and values on April 3rd, 10th and 17th from 10 am – 2 pm, May 8th, 10th and 15th from 10 am – 2 pm, and Saturday, May 13th from 4 pm – 8 pm. Property owners who dispute their appraisal should call 518-543-6161, ext. 23 to make an appointment within those dates and times to have a telephone conversation with the assessor. The assessor and appraiser have been working with the State of NY and many other agencies that are involved in monitoring procedures and certifying the level of assessment.

Several audience members and ZOOM members questioned Martucci. Their primary concerns were how the reval will affect the school taxes, whether the elderly community members will be unable to pay higher taxes, and the accuracy of new assessment amounts. Martucci will continue to address the questions and concerns of how the assessment will or will not affect taxes.

REGULAR COMMITTEE REPORTS:

Administrative/Assessor/Justice: The Assessor's Office has been working on exemption applications, general file maintenance sales, address changes, and data management.

Highway: There were a couple of truck breakdowns during the last big storm. They have also been busy with smaller storms.

Personnel: As the Town of Horicon has hired a new Zoning Enforcement Officer (ZEO), Matthew Magee will begin as Hague's full-time ZEO on March 16th.

On April 1st, after 43 years to the day of faithful service, Hague Administrator Diane Trudeau will transition from full-time to part-time employee status. She will maintain an office in the community center and will be available on a schedule TBD. Thank you, Diane, for all you've done for so long, for all you are still doing, and for all we know you'll continue to do to faithfully and competently serve Hague. And thank you, Donna Clark, for stepping up to be a Hague administrator!

It was noted that there are five open positions on the Town of Hague ballot for the election in November 2023: supervisor, clerk, two board members, and highway supervisor. The following have declared their intention to run: Supervisor – Edna Frasier (R) and Joshua Patchett (D); Town Clerk – Kim Coffin (R); Town Board, two positions – Steve Ramant (R) and Jack Bast (R). No one has declared an intention to run for Hague Highway Superintendent as of yet.

Town Park/Beautification: The staff and schedules for this season at the beach, boat launch, and visitor center are in the process of being lined up. Food trucks are set for Music in the Park. The visitor center will be open June 12th. Ramant and Patchett are looking into having a boat show at the park this summer.

Sewer District #1 & #2: Bast reported that on February 21st, an overflow event occurred at a sanitary sewer manhole located on Lake Shore Drive in the vicinity of the Lake Shore Drive Pump Station. The manhole overflow resulted from a blockage of wipes and grease and caused a discharge of untreated wastewater into Lake George. Direct discharge of pollution is a prohibited NYS DEC event and Hague duly filed a Report of Noncompliance on February 22nd. Hague is now required to formally respond to the DEC's Notice of Violation by May 2nd.

To address this violation and prevent future impacts, Hague's Wastewater Treatment Plant (WWTP) Chief Operator John Sheehan will reach out to all sewer users, and specifically to those in the immediate area of the overflow, to educate them on proper sewer use. This assignable cause of a blockage by wipes and grease is entirely preventable by proper attention.

Hague will inform the DEC of the town's plans to update the sewer system operation and maintenance procedures to more frequently inspect and clean manholes. In the February 21st event, the discharge into the lake was a very small amount, thanks to prompt and effective action by an individual and by the WWTP staff. However, a discharge of any amount is not acceptable; a penalty of up to \$37,500 per day *for each violation* is possible.

All Hague property owners on the town sewer system are strongly urged to be attentive and careful in the operation of their individual systems and their responsibilities to protect Lake George. (See article on page 2.)

NEW BUSINESS

A new resolution was unanimously passed to establish the Community Center Reserve Fund in the amount of \$1,000,000 to be used to finance the cost of capital improvements.

Several other resolutions were amended by unanimous votes.

Motions were passed to allow:

- Town Clerk Kim Coffin to attend NYS Town Clerks Conference April 23rd – 26th.
- Eric Kramer to attend sewer classes on activated sludge June 20th – 23rd and Basic Ops classes from August 21st -September 1st.

SILVER BAY by Linda Fusco, Ph.D. Since 1975, the members of Property **Owners of Silver** Bay (POSB) have assembled each summer to address issues concerning the Silver Bay and



Hague communities.

Our mission statement reads:

The mission statement of the Property Owners of Silver Bay is to provide opportunities for educating members and sharing information on issues and activities that pertain to the residents of the Silver Bay area.

In the past four plus decades, POSB has grown from representing just property owners in Silver Bay, Arcady, and Sabbath Day Point to now including all property owners from Hague to Sabbath Day Point. The POSB records, going back to 1975, reflect the connection of issues germane to both the Silver Bay and Hague communities.

The board of the POSB is a dynamic group; we have supported the group's evolution in the 20th and on into the 21st century. In the past, we had two board meetings in June and a follow-up meeting in August.

However, significant issues this year, such as the ProcellaCOR decision, property tax assessments, and new septic regulations, prompted us to meet "off season" during the fall, winter, and spring via ZOOM.

One example of our activism is that the POSB board members were livid with the Lake George Park Commission's plan to dump an herbicide into our pristine lake! Many of us drink the lake water! So, Carol Kanis and I joined Hague community members in attending the ProcellaCOR hearing in Bolton Landing.

Our summer 2023 membership meeting will be on July 31st at 1 pm at the Hague Community Center. Hague POSB members and non-members are welcome to attend. Property owners

can become members for an annual fee of \$10, payable at the meeting.

The topics to be discussed include: a presentation of Silver Bay YMCA programs and outreach, updates on garbage recycling, donations made to local charities, and short-term rentals.

Eligible associates programs include (but are not limited to) Associate in Applied Science and Associate in Occupational Science and certificate programs such as (but not limited to): Agriculture Farming and Sustainable Food, Auto and Diesel Mechanics, Auto Body Repair, Computer Electronics and Information Technology Systems, Construction Management, Construction Trades (Carpentry, Masonry), Culinary Arts/Restaurant Management, Criminal Justice/Security, Early Childhood Education (Daycare and Teaching Assistants), Electrical, Environmental Technology (Water Quality, Conservation), Facility Maintenance Tech/Mechatronics, Fire Science and Paramedic, Forestry, General Construction - All Trades, Health and Dental Sciences and Services, HVAC/Plumbing, Landscaping, Land Surveying, Lineman School, Mechanical and Industrial Technology (Paper/Pulp, Plastics, Computer-Assisted Manufacturing (CAM), Nursing, Outdoor Education, Powersports and Marine Performance and Repair, Radiology Technician, Renewable Energy Technology (Wind and Solar Installation Technology), Veterinarian Technician, and Welding.

Scholarships will cover the costs of tuition (after other financial aid) and non-tuition costs such as room and board, transportation, books/tools/supplies, certification or other exam fees, and childcare costs. The scholarships represent a commitment to the student for up to two academic years.

WHAT'S HAPPENING AT THE FORT

The Fort Ticonderoga Author Series features presentations by authors of books related to Fort Ticonderoga's history.

On April 16, 2023, from 2 – 3 pm, the series will feature Jim McIntyre. He will focus on the often-omitted story of the reduction of the Delaware River defenses that engaged the bulk of the resources and



attention of both George Washington and William Howe through October and November of 1777.

McIntyre will explain how on the American side, maintaining the integrity of the river defenses involved an attritional campaign, waged by an intrepid group of defenders, which brought together the efforts of the Continental Army, as garrisons of the various forts, the Continental Navy, and the Pennsylvania State Navy. He will explain the concept that if the Americans could hold their positions until winter set in, they would prevent William Howe from capitalizing his capture of Philadelphia, and possibly force him to abandon the city for want of supplies.


