# LAKE GEORGE LAND CONSERVANCY TO MAKE IMPROVEMENTS AT PEGGY'S POINT

The Lake George Land Conservancy (LGLC) has been awarded a \$44,500 grant to fund improvements at Peggy's Point, its beloved waterfront park in Hague. The work will redevelop the trail and add amenities to make the park and waterfront more accessible. Educational signage will enhance the visitor experience, and native plantings will strengthen the shoreline against erosion from storm events.



This is one of two recent grants from the 2023 New York State Conservation Partnership Program (NYSCPP), which is funded through New York State's (NYS) Environmental Protection Fund. The second grant, for \$23,800, will help increase the LGLC's ability to effectively engage and communicate with the public. This effort will include, among other things, upgrades to the LGLC's conference room equipment for multipurpose public programs and the purchase of field equipment to enhance stewardship efforts and citizen science capabilities.


#### **BOATING SAFETY COURSES**



## NEW PROGRAM TO KEEP WASTEWATER OUT OF LAKE

Did you know...there are about 6,000 private septic systems in the Lake George Basin, and 2/3 of them may be failing? That's the bad news. The good news is that the Lake George Park Commission (LGPC) is now authorized to inspect all septic systems in the critical environmental area (CEA) to determine which ones need repairs, upgrades, or replacement. The CEA includes properties near the lake and its tributaries. If you have a septic system, and your property is in this CEA, you've already received communications from the LGPC about the program. Perhaps you've even already had your inspection performed. These will be carried out every five years for every property owner, which means 20 percent of the systems will be inspected each year. This is a huge step toward keeping wastewater out of Lake George.

The LGPC has a wealth of information about its septic inspection program, including FAQs, a downloadable flyer about septic systems for homeowners as well as a flyer for rental properties.

There are over 391,000 children and youth in foster care, according to the Children's Bureau and up to 80 percent of children in foster care have significant mental health issues.

In honor of National Foster Care Month, and this year's theme of "Strengthening Minds. Uplifting Families," Silver Bay YMCA has added another respite program, "Foster and Adoptive Family Retreat."

This program is offered to give families who are currently fostering or have recently adopted the opportunity to get to know each other and bond in a safe and friendly environment.

Foster and adoptive families from across the nation who meet the criteria can enjoy a stay at Silver Bay at no cost for up to one week anytime throughout the year. The stay includes meals in the William Boyd Center Dining Hall and programs. 

### **ZONING BOARD OF APPEALS - 4/27/2023**

Chairman Robert Goetsch and Board Members Jon Hanna, Linda Mury, Ray Snyder, and Alternate Cathy Clark were present. Chris Navitsky was absent. Also present was ZEO Matthew Magee.

#### WILSON/DAVIS (93.12-1-11) 7930 Lakeshore Drive (TR-1)

The applicants are requesting the total replacement of a non-conforming structure requiring two variances: greater than 30% lot coverage and greater than 25% increase in square footage. Since the last meeting, the applicant revised the square foot increase from 52% to 78%, with the addition of living space in the walk-out basement and the structure has been shifted two feet further away from the lake. Current lot coverage of 38% (more than 30%) would not increase, but will remain nonconforming, hence requiring a variance. A public hearing was held. Three letters from neighbors were read; one in favor, one concerned about the proposed 78% increase in square footage impact for a small lot, and another against approval due to the proposed structure impacting the character and nature of the neighborhood and the visual and environmental impact on the lake. No one in the audience spoke for or against. The owners were present. The application for more than 25% increase in square footage was approved four to one (Mury), with conditions. The conditions are: 1.) a stormwater permit must be submitted to the town if the Lake George Park Commission does not require one, 2.) a new wastewater system must be approved and installed, 3.) post-construction inspection of an existing septic line must be done to ensure there was no damage during construction, and 4.) if a ledge is found that requires blasting, any blasting must occur between Columbus Day and Memorial Day Weekends, with notification to neighbors. The application for greater than 30% lot coverage was unanimously approved.

#### ASIEL (60.9-1-46) 20 Bobkat Lane (TR-1)

The applicants propose constructing a screened-in porch over the existing deck. The house and deck were constructed on this lot in 1981. The original building application was approved, stating all components of the structures were to be 50' from the MHWM of Lake George. A recent survey has found a small, long, and narrow portion of the existing deck to be within the 50-foot shoreline setback. The total area within the setback is approximately 75 sq. ft. The proposed project will not make the deck more nonconforming. The applicants are requesting a shoreline setback variance for the 42-year-old miscalculation. The board accepted the application as complete, scheduled a site visit, and put the application and public hearing on the agenda for the May 25th zoning board meeting.

#### INGREY (60.5-1-14) 31 Pine Cove Road (TR1)

The applicants propose constructing a second-story addition and a new first-floor entry addition to an existing house. The second-story addition (781 sq. ft) and the new first floor entry addition (80 sq. ft) make for an 861 sq. ft increase in living space beyond the current, which translates to a proposed 55.9% increase of square footage of living space. Current lot coverage is 30.28% and the proposal would result in an increase of less than 1%. The zoning issues are new

construction within 100 feet of the lake, a proposed living space increase of more than 25%, and more than 30% lot coverage. The board accepted the application as complete, scheduled a site visit, and put the application and public hearing on the agenda for the May 25th zoning board meeting.

#### RIZZA (42.20-1-6.3) 8835 Lakeshore Drive (TRI)

On July 23, 2020, the owners received approval from the Hague Zoning Board of Appeals to construct a 625 sq. ft. accessory structure on a vacant parcel with a variance for frontline setback. That approval has since expired and the owner is re-applying to build the same structure. The 2020 application approval had a condition that the slope is not to be disturbed by construction. The board accepted the application as complete, scheduled a site visit, and put the application and public hearing on the agenda for the May 25th zoning board meeting.

## SDP HOLDINGS LLC (93.06-1-34) 50 Sabbath Day Point Road (TRIR)

The applicants request approval to replace an existing wood seawall with rocks and add a shorefront patio with stairs within a foot or two of the retaining wall at the shoreline. The land is sloped, so a second wall a few feet tall would need to be installed on the uphill side of the patio. The board accepted the application as complete, scheduled a site visit, and put the application and public hearing on the agenda for the May 25th zoning board meeting.

#### MCLOUGHLIN (76.8-1-6.2) 252 Silver Bay Road (HS-R)

The owners are requesting a two-year extension of their May 6, 2021, Site Plan Approval.

See the August 2021 edition of *The Hague Chronicle* for details. The two-year extension to August 2025 was unanimously approved with all original conditions.

#### **TOWN BOARD - 5/9/2023**

#### WELCOME GUESTS/PRIVILEGE OF THE FLOOR

Frasier read the following statement: "With regards to the very important subjects of the recent reval and the separate but related school tax issues, which have been — 6 — June 2023

discussed at length in the last two town board meetings, I want to provide you an update on information and on actions the board has taken since then."

#### 1) Reval and Tax Rate

"As stated in my April 20th letter to you, the board seriously considered postponing implementation of the 2023 reval, including obtaining legal advice and counsel. It is not an option. The town board does not have the authority to value properties and set assessed values, so it would not be able to dictate whether the revaluation numbers are used to set the assessments for the 2023 (tax) roll. The valuation and assessment of properties in the town is the responsibility and obligation of the assessor and it is not advisable for the town board to interfere with this process. Therefore, Hague's 2023 tax rolls have been filed and are based on the 2023 reval assessments.

"In my letter, I noted that we did not then know the Ti Consolidated School District (CSD) school tax rates. At the Ti School Board presentation here in Hague last Wednesday, it was announced that the latest determination of Hague's 2023 school tax rate is \$7.33 per thousand dollars of assessed value. This will be the rate **IF** the Ti CSD budget is approved next week.

#### 2) 3- or 5-year averaging

"Carney suggested to the town and the Ti CSD School Board that the substantial bump in the school taxes resulting from the 2023 reval be "averaged" over a three- or five-year period, rather than being implemented in one big jolt. The school board has no previous knowledge of this concept. However, in last Wednesday's presentation, School Superintendent Cynthia Ford-Johnston committed to research it and to get back to Hague and to Carney with the findings.

The board hopes there's some relief here. It will inform the public of the results of the Ti CSD investigation.

#### 3) East Shore Taxing

"Carney proposed property taxing the more than 400 docks and boathouses on the lake's east shore, since they are in Hague's jurisdiction. He says such revenue would decrease the tax burden on Hague's residents. Preliminary estimates of the proposal by both our town attorney and by Mark Schachner have been obtained. They both stated that it would take 'extensive and expensive research' to determine the property tax law legality of such an assessment.

"The Hague Town Board judges that such an expense is not warranted. Even if it were determined to be legal, which the board believes is highly unlikely, it thinks that common sense and ethics should prevail. The board believes:

- Property taxes, including school taxes, are for the purpose of funding services.
- Hague cannot impose property owners on the east shore with Hague property taxes because those residing in towns other than Hague would not receive any associated Hague services such as fire protection, highway services, transfer station, beach and town park, a sewer system, town government and administration services, etc.

 We cannot tax for school services only, nor can we expect other towns to support us in paying for our school services, i.e., our school taxes.

Therefore, assessing east shore docks and boathouses in Hague waters will no longer be considered by the Hague Town Board or its assessor.

#### 4) Apportionment and Redistricting

"As expected, the 2023 reval has adversely affected the apportionment of the tax levy for Ti CSD. In last Wednesday's presentation by the school board, it was stated that Hague's share increased from 50.83% last year to 55.92% for 2023-2024. The Hague school tax rate of \$7.33 per thousand is based on this sharing percentage.

"This is indeed painful to the residents of Hague, but neither Hague nor the Ti CSD School Board has any control over the apportionment - it is determined by NY State law. It is simply the result of the decision made by Hague in 1979 to terminate the then-existing Hague CSD and to (a) consolidate with Ticonderoga and (b) on an apportionment basis.

"The town board believes it's time to fight this - again. Several previous efforts have had no effect. The Hague Town Board is appointing a citizen committee to advise it on this particular matter.

"Assessor Dave Martucci is not in attendance as he is attending the Ticonderoga School Budget Public Hearing. The Hague Town Board will not be answering any questions on behalf of Martucci."

Concerns of the audience and ZOOM members were:

- The town board was asked to release the FULL Town Assessment to include ALL properties and the cost of the reval.
- Some people still are unclear as to why the reval was done.
- It was suggested that more town services be offered (such as garbage pickup) with any monies received by the town because of the reval.
- It was suggested that the residents of Hague ask the Ticonderoga CSD if the school tax bills can be billed quarterly rather than once a year.
- Patchett explained his comment ("The increase the town will see in sales tax due to the reval is not needed." ) from the April 11th town board meeting, After lengthy conversation regarding sales-tax income and how it does not relate to the reval, Frasier explained where the sales tax comes from and the percentage that it applies to, stating that if there was no sales tax income, there would have to be a town tax put into place, which would be substantial.
- A new issue raising concerns before the board is Short-Term Rentals. The board agreed to set a meeting with the Short-Term Rental Committee to review its progress and proposed new ordinance. Residents will be welcome to attend. The conversation will only be between the board and Short-Term Rental Committee; a public hearing will be set in the near future.

#### **REGULAR COMMITTEE REPORTS:**

**Buildings & Grounds:** The Highway Department offered to do the repairs on the town boat launch walkway. The town is working with the town attorney regarding ownership of "Union Cemetery."

**Highway:** Five tons of debris have been removed from the beach. It will help maintain the beach this summer. It is doing prep work at the landfill with plans to pave this summer. A motion was unanimously passed for Fiallo and Coffin to attend Highway School June 4, 5, and 6, 2023.

**Museum/Historian:** The museum will display an exhibit about Arcady Bay.

**Personnel:** Clark has recently successfully completed her appointed responsibilities and duties as Assistant Zoning Enforcement Officer in the ZEO Department/Office. Frasier thanked her for her years of dedicated service to the town.

**Planning/Zoning/Storm Water:** Board members were asked to review the Lake George Park Commission letter dated April 28, 2023. A copy of the letter is available for review in the Zoning or Town Clerk Office and <u>HERE</u> online.

**Town Park/Beautification:** The boat launch will open Friday, May 19th. Wally Peterson Sr., Tom Haskell, Meg Haskell, Karen Semigran, Leo Lucas, Gil Engler, Pat Hintze, Marge Pote, and Mindy Swinton will work there. The Visitor Center will open Saturday, June 24th and the employees there will be Susan Adair, Joyce Houck, Karen Semigran, Pat Hintze, and Kathi Ramant. The beach will be opening Monday, June 26th and the lifeguards will be Jenny O'Neill, Emily Best, and Tasia Osier.

The low areas of town park lawn will be filled in with sand to provide better drainage.

Plans for the Hague Memorial Day Parade are coming together. There is still time to add a float to the parade.

**Sewer District #1 & #2:** Eric Kramer has completed his second of three weeks of training. Scott Manning was thanked for helping out at the WWTP while Eric is away.

**Environmental Concerns:** Ramant contacted the DEC to remove fallen trees and branches at the parking area of the DEC hiking trail near the fish weir. He has also been in touch with the Lake George Association (LGA) about the invasive species Hydrilla making its way into the lake. He said measures are being considered such as locking all access areas around the lake at night and at the end of the season.

#### **COMMUNICATIONS AND PETITIONS:**

A motion was unanimously passed for Town Clerk Coffin to attend a Tax Collection Training Seminar June 11 - 14, 2023.

#### **NEW BUSINESS**

 A resolution was unanimously approved for the Hague Highway Department workers to work ten-hour days Monday – Thursdays from 6 am – 4 pm from May -October. This will affect their holidays, vacation, and personal days.

- 2. After a discussion, the board and the Short-Term Rental Committee tentatively set the date of Wednesday, June 21st at 6 pm to discuss what the committee is proposing for the NEW Short-Term Rental Ordinance. The confirmed date and time will be posted on the town's website and Facebook pages. This is between the board and the committee. It is open to the public; but there will be no public discussion until the subsequent public hearing.
- 3. There have been concerns with how the town and the community communicate. The Assessor's and Town Clerk's Offices have been posting information on the town's website and Facebook pages in addition to publishing in *The Hague Chronicle*; however, there is still a need for a better means of communication. Frasier asked Patchett to work with Amanda Peterson to come up with ideas. Wotton mentioned that she knows there are many effective communication platforms available.

## Establishment of Hague School Tax Advisory Committee

In accord with the authority vested in it by Town Law, Chapter 2, Paragraph 2-29, the Hague Town Board announced that it is establishing a citizen Hague School Tax Advisory Committee.

The purpose of this committee is to investigate and advise the board on ways to improve Hague's existing school tax situation. Such situation is determined by NY State law and is the result of the decision made by Hague in 1979 to terminate the then-existing Hague CSD and to (a) consolidate with Ticonderoga CSD and (b) on an apportionment basis.

Changing circumstances over the past 44 years have resulted in increasingly negative consequences for Hague in this arrangement. Hague's 2023 reevaluation has further highlighted the need to change the current terms and conditions.

Ticonderoga CSD has no control over the current districting and apportionment rules and regulations. To change them will require extensive research into existing NYS law and Central School District redistricting.

The board is seeking interested and knowledgeable persons willing to volunteer service to advise the board in this important and complex regard.

Interested persons should promptly submit applications in writing for membership on this committee to Edna Frasier at <a href="mailto:Supervisor@TownOfHague.org">Supervisor@TownOfHague.org</a>. The town is eager to get this action started and to achieve school tax relief for all our citizens as soon as is practical.

### PLANNING BOARD - 5/4/2023 & 5/12/2023

Present at the May 4th meeting were Deputy Chairman Pam Peterson and Board Members Judy Gourley, Sandy Powell, and Meg Haskell. Chairman Dick Frasier was absent. Also present were ZEO Matthew Magee and Recording Secretary Cathy Clark. The meeting was held open until after the site visit on May 12th.

### PLANNING BOARD, CONTINUED

Present on May 12th (a continuation of the May 4th meeting) were Deputy Chairman Pam Peterson and Board Members Sandy Powell and Meg Haskell and ZEO Matthew Magee. Chairman Dick Frasier and Board Member Judy Gourley were absent.

#### ASIEL (60.9-1-46) 20 Bobkat Lane (TR-1)

The applicants propose constructing a screened porch over their existing deck. The house and deck were constructed on this lot in 1981. The original application was approved stating all components of the structures were to be 50 ft. from the MHWM of Lake George. A new survey has found a small, long, and narrow portion of the existing deck to be within the 50-foot shoreline setback. The total area within the setback is approximately 75 sq. ft. The proposed project will not make the deck more nonconforming. The applicants are requesting a shoreline setback variance for the 42-year-old miscalculation. The board made a unanimous positive recommendation to the Zoning Board of Appeals (ZBA) with the suggestion that all window openings are screened only, i.e. no use of glass or similar window material.

#### INGREY (60.5-1-14) 31 Pine Cove Road (TR-1)

The applicants propose constructing a second-story addition and a new first-floor entry addition to an existing non-conforming house. The proposed second story addition (781 sq. ft.) and new entryway (80 sq. ft.) will increase the applicant's living space by 861 sq. ft. or 55.9%. The zoning issues are new construction within 100 ft. of the lake, a proposed living space increase of more than 25%, and more than 30% lot coverage. Peterson recused herself due to jointly owning a nearby property. The application was missing some information, so was deemed incomplete. A letter from a neighbor was read expressing concern that the addition of a 2nd floor would block their view and would result in devaluation of their property. A site visit was set. The meeting was left open to allow decisions on a referral to the Zoning Board of Appeals (ZBA) to be made after the site visit on May 12th. A guorum could not be met after the site visit as Pam Peterson recused herself, so no actions for recommendations to the ZBA were taken.

#### RIZZA (42.20-1-6.3) 8835 Lakeshore Drive (TR-1)

On July 23, 2020, the owners received approval from the ZBA to construct a 625 sq. ft. accessory structure on a vacant parcel. The approval has since expired and the owner would like to re-apply to build the same structure now. A site visit was set. The meeting was left open to allow decisions on a referral to the ZBA to be made after the site visit on May 12th. After the site visit, the board made a unanimous recommendation to the ZBA to approve the application with the same conditions as the 2020 approval. (Click HERE to read *The Hague Chronicle*, Aug 2020 issue. Go to page 4.)

**SDP HOLDINGS LLC (93.06-1-34) 50 Sabbath Day Point Road (TR-1R)** The owners are proposing the addition of a shorefront stone paver patio with stairs in conjunction

with the replacement of a wooden seawall within the 50-foot setback. A site visit was set. The meeting was left open to allow decisions on a referral to the ZBA to be made after the site visit on May 12th. The board unanimously approved and made the following recommendations to the ZBA.

- There should be no changes in the seawall positioning and no new extension of the seawall to the south of the existing seawall.
- Because the seawall continues across the north neighbor's waterfront, it is recommended that the neighbor rebuild their portion of the seawall at the same time to minimize disturbances at the shoreline.
   If the neighbor does not make changes to their seawall, the transition of the new to old seawall should occur at least ten feet before the neighbor's property line.
- There should be no disturbance to the existing shoreline vegetation to the south of the existing seawall.
- The permeable paver patio should be no larger than and located in the same place as the existing gravel dining area (roughly 15 ft. x 10 ft.).
- If the proposed boathouse is approved and built, access to the boathouse from the beach is to be by a path from the existing stairs on the south end of the seawall onto the lawn around the land side of the existing shoreline vegetation and to cross the shoreline vegetation in line with the boathouse catwalk from the lawn, i.e., path to be perpendicular to the shore. There is to be no disturbance of any existing shoreline vegetation other than the lawn access path to the boathouse catwalk.
- Have a native plant buffer of a minimum width of 15 ft. along the entire length of the lakefront other than in front of the existing gravel surfaced dining area (approximately 15 ft. along the seawall).

#### WILSON/DAVIS (93.12-1-11) 7930 Lakeshore Drive (TR-1)

The applicants are requesting the replacement of a nonconforming structure requiring two variances: greater than 30% lot coverage and greater than 25% increase in square footage. The applicants' engineer reviewed the project changes since the last Planning Board meeting. Those changes include sq. ft. increase from 52% to 78% with the addition of living space in the walk-out basement, shifting of the structure two ft. further away from the lake, eliminating any structure from the deeded easement, and adjusting the proposed lot coverage to be just less than the current lot coverage of 38%. At the April meeting, the Zoning Board of Appeals approved the application with conditions. (See Zoning Board of Appeals.) No Planning Board actions were needed at this meeting. The Planning Board will conduct a Site Plan Review once APA comments have been received or the 30-day comment period has expired.

### **LOOKING BACK**

### ANNA GERTRUDE SMITH RIDER – A WOMAN BEFORE HER TIME

As Americans still continue today to grapple with the issue of women's rights, Hague's own Al Rider has a family story that illustrates how far we have come in what is possible or considered appropriate for women.

Al's grandmother, Anna Gertrude Smith Rider, was born in Mechanicville, NY in 1877. She grew up there and also lived in Albany, Tampa, FL and in the family's home on Assembly Point on Lake George.

As a young girl, she learned to paint in the Hudson River School style in art classes she took somewhere in the Mechanicville area. She learned many techniques such as perspective and shading. The booklets with her notes are still in mint condition and are displayed at the Lake George Historical Association Museum (LGHAM) in Lake George.

She painted mostly landscapes. Although there were times when she ventured out by boat to see the beauty of Lake George such as to the Horicon Hotel in Black Mountain with her father and on family picnics, it is most likely that she painted from postcards and probably those of Seneca Ray Stoddard.

She probably painted dozens of paintings, but she gave most all of them away to family. Al does not know where those all are today.

There are two of her paintings in the LGHAM and Al and

his wife, Brenda, have the other two in their living room on Pine Orchard Road in Hague. Al had all four restored by Emily Phillips in Essex, NY, who did a remarkable job of bringing them back to their original grandeur. Emily discovered they had been done on linen, an indicator that the family was fairly affluent. Al had the gold leaf on the frame restored to perfection by a gentleman in VT.

The painting the family treasures most is one Rider did in 1894 of Paradise Bay. She did not title it nor did she sign it. It is special to the Rider family, mainly of course, because she painted it, but also because it is of Paradise Bay, which Al says is, "THE place on the lake. For people who love Lake George, it's revered. People even go there and sing hymns on Sunday mornings."

At the LGHAM, there is a display cabinet with her painting of a dog and a boy, her painting of Paradise Bay, and other information about her alongside a similar painting by

Stoddard.

The fascinating and actually quite sad part of this tale is that Ms. Rider's father made her stop painting at the age of 17 because it wasn't considered proper at that time for an adult woman to be a painter. She never picked up a paint brush after that and, as Al says, the world was deprived of her talent.

When I asked Al what he thought would have happened if his grandmother had lived during his era instead of back then, he replied, "She'd be a very well-known artist. I'd put her work up against anyone."

Al explained that his reverence for

Lake George comes from these grandparents. His family has always been stewards of the lake...and he is carrying on that tradition. Thank you, Al!
