#### **ELECTION 2023 IN HAGUE**

The unofficial final results for the elections held in Hague on November 7, 2023, based on a total of 313 ballots counted were:

#### **Town Supervisor**

Joshua Patchett – 159 Edna Frasier – 149

#### **Town Clerk**

Kim Coffin - 239

#### **Town Council**

(Voted for two; both will serve) Jack Bast – 229 Steve Ramant – 212

#### Superintendent of Highways

Chad Dunklee – 131 Luke Winters – 101

**State Proposal 1 –** Eliminates the constitutional debt limit placed on small city school districts, which are defined as districts partly or fully within a city with less than 125,000 inhabitants.

In Hague, it passed 168 to 92. In Warren County, it passed 8,760 to 4,916. In NYS, it passed 1,386,898 to 769,630.

**State Proposal 2** – Extends the authority of counties, cities, towns, and villages to exclude from their constitutional debt limits any debt incurred for the construction of sewage facilities. This exclusion was already in place, but was set to expire at the end of 2023. The passage of the proposal means that the exclusion will be extended for ten years, until January 1, 2034.

In Hague, it passed 178 to 87. In Warren County, it passed 9,304 to 4,360. In NYS, it passed 1,460,904 to 685,518.

#### **WORK AT PEGGY'S POINT COMPLETED**

The Lake George Land Conservancy (LGLC) has completed the work to improve accessibility at Peggy's Point, including crushed stone paths that lead to the Friendship Garden, gazebo, and waterfront.

An accessible picnic table was also added and the entrance gate was widened.

Final touches on landscaping and the gardens, including memorial plantings, will



be completed next spring, at which time the LGLC will also install a new kiosk and educational signage.

The project is supported with funding from the NYS Conservation Partnership Program (NYSCPP) and New York's Environmental Protection Fund. The NYSCPP is administered by the Land Trust Alliance, in coordination with the State Department of Environmental Conservation.

#### **NEW TOWN COUNCIL MEMBER TO BE APPOINTED**

The Hague Town Board will be appointing a new town council member to fill the remaining two years of Joshua Patchett's unexpired term of office, Patchett having been elected Town of Hague Supervisor in the November election.

A council member must be a resident of the Town of Hague.

The appointed person will commence responsibilities in 2024. The salary is \$6,473 per year. # PARTIAL PROPERTY TAX EXEMPTIONS

Sole Assessor David Martucci urges all primary residence homeowners to contact his office at 518-543-6161 to see if they are eligible for the following exemptions:

**Senior Citizens' Exemption:** Primary residence homeowners over age 65 with the following household income ceilings for the listed taxing jurisdictions: (all include sliding scale)

- County \$29,000
- Town \$18,000
- School \$22,000

This exemption must be renewed each year. Renewal forms will be sent in late December to those who had this exemption last year.

**Enhanced STAR Exemption:** Primary residence homeowners over age 65 with household income less than \$93,200.

This exemption renews automatically each year for those already enrolled in the Income Verification program. New applicants should apply for the Star Credit Program online HERE or call 518-457-2036.

**Basic STAR Exemption:** Primary residence homeowners with annual income below \$500,000.

This exemption does not have to be renewed each year. New applicants should apply for the Star Credit Program online <u>HERE</u> or call 518-457-2036.

**Veterans' Exemption:** Primary residence homeowners with military service during wartime periods.

This exemption does not have to be renewed each year.

Details and applications are available Mondays and Wednesdays from 9 am to 3 pm. The filing deadline is March 1, 2024.

#### **PLANNING BOARD - 10/5/2023**

Present were Deputy Chairman Pam Peterson, Sandra Powell, Judy Gourley, and Margaret Haskell.

Chairman Richard Frasier was absent.

Also present were Acting Zoning Enforcement Officer Cathy Clark, Zoning Enforcement Officer Tristan Shappy, Recording Secretary Kathy Santaniello, and Anthony DeFranco.

ZOOM was not available for this meeting due to technical difficulties. The meeting was video recorded.

# REFERRAL TO ZONING BOARD OF APPEALS (ZBA): ENGLISH (60.13-1-11) 61 Red Fox Lane (TR-1) VAR

#### ENGLISH (60.13-1-11) 61 Red Fox Lane (TR-1) VAR 14-23

The applicants are requesting a variance for shoreline restoration that will include, if approved, stone steps to the dock, a fire pit sitting area, and a boulder retaining wall.

#### Zoning Issue:160-50 B.

DeFranco (representing English) answered questions. Clark reported there was a non-jurisdictional ruling from the Lake George Park Commission (LGPC). A Department of Environmental Conservation (DEC) permit is required. Peterson reported that a site visit had been done.

Discussion ensued. A motion was made, seconded, and unanimously approved that a positive recommendation be made to the Zoning Board of Appeals, with the recommendation that it address the three violation issues that were found at the site visit: the shed, the outside shower, and the stairs.

The board also recommended that the additional fire pit not be approved.

#### **OTHER BUSINESS:**

### RICHARDS (12.18-1-16) 9568 Lakeshore Drive (TR-1) VAR 09-15 SP 12-15(f).

The applicants are requesting temporary relief of conditions placed on their 1/7/2016 site plan approval, until their house receives its Certificate of Occupancy (CO).

At its meeting on September 28, 2023, the ZBA granted relief of their conditions of approval until the new home receives its CO. Its approval is to be renewed each time the Warren County building permit is renewed.

Discussion ensued regarding an outdoor shower that had been installed. A motion was made, seconded, and unanimously passed to grant temporary relief to use the cabin for living until the new house is completed and a CO is issued with the following condition: After the COs are issued for the house, the Zoning Enforcement Officer will inspect the cabin within two weeks to verify that the shower and plumbing for the outdoor shower have been removed.

#### **ZONING BOARD OF APPEALS - 10/26/2023**

Present were: Chairman Robert Goetsch, Jon Hanna, Chris Navitsky, Linda Mury, and Ray Snyder.

Also present were: Acting Zoning Enforcement Officer Cathy Clark, Zoning Enforcement Officer Tristan Shappy, Recording Secretary Kathy Santaniello, and Anthony DeFranco. The meeting was streamed on ZOOM.

#### **PUBLIC HEARINGS:**

### 1. JESBERGER (43.13-1-29) 7 BAYBERRY LANE (TR-1) VAR 08-23, VAR 09-23, VAR 10-23

On September 23, 2023, this public hearing was left open so that more information could be gathered. Ron and Jacyln Jesberger bought the property in 2021. They have three children and would like to renovate the building to better accommodate their family. Clark read two letters from Cape Cod Village residents expressing support of the project. One Cape Cod Village resident expressed concerns about the increase in size of the structure being more than 25% and that parking is an issue.

#### 2. ENGLISH (60.13-1-11) 61 Red Fox Lane (TR-1) VAR 14-23

Anthony DeFranco, (representing English) addressed some issues that came up at the site plan visit as well as updated plans for the project. The Arcady Bay Homeowners may address some of the issues. The Lake George Park Commission (LGPC) returned a notice of non-jurisdiction. No word has been received from the Army Corp of Engineers or the Department of Environmental Conservation (DEC). No statements were made against the project.

#### **REGULAR MEETING:**

#### **OLD BUSINESS:**

### 1. JESBERGER (43.13-1-29) 7 BAYBERRY LANE (TR-1) VAR 08-23, VAR 09-23, VAR 10-23

The applicant is applying for three variances for an addition to a nonconforming structure. The home is in the sewer district and their project has received approval from its association.

Zoning Issues: 160-23 (A) Percentage Lot Coverage, 160-23 (A) Front Yard Setback, 160-65 (A)(1), more than 25% increase to a nonconforming structure.

After discussion, a motion was made, seconded, and passed 4-1 (Hanna) to table action on the project to see if the structure can be kept within the existing footprint.

### 2. ENGLISH (60-13-1-11) 61 RED FOX LANE (TR-1) VAR 14-23

The applicants are requesting a variance for shoreline restoration that will include, if approved, stone steps to the dock and beach, a fire pit sitting area, and boulder retaining walls. They are also asking for an additional variance so they can keep 7.25 sq. ft. of their deck staircase, which was built in the shoreline setback.

#### Zoning Issues: 160-50 B

After discussion, a motion was made, seconded, and passed 4-1 (Navitsky) to grant the variance.

#### **NEW BUSINESS:**

### 1. KIMBLE (26.17-2-42.122) 9112 Lakeshore Drive (Hamlet) VAR 15-23.

The applicants would like to remove an existing 100-sq. ft shed and construct a 200-sq. ft. gazebo 30' from the mean high-water mark (MHW).

#### Zoning Issues: 160-50 B (b) (3)

A motion was made, seconded, and passed to deem the application complete. The project will be added to next month's meeting agenda. A site visit was scheduled for Friday, November 3, 2023 at 3 pm.

#### **OTHER BUSINESS:**

### 1. RICHARDS (12.18-1-16) 9568 Lakeshore Drive (TR-1) VAR 09-15.

A procedural error was made during the September 28th review of this request. To remedy the error, the board needed to vote again on this request. On the re-vote to approve the modifications to Variance #09-15, the motion passed by a 4-1-0 vote (Goetsch recused).

#### **TOWN BOARD - 11/14/2023**

The following board members were present: Deputy Supervisor Steve Ramant, Board Members Joshua Patchett, Jack Bast, and Maureen Cherubini. Supervisor Edna Frasier was absent.

Also present were: Deputy Highway Superintendent and ZOOM Coordinator Tim Fiallo, ZEO Cathy Clark, Lake George Waterkeeper Chris Navitsky, Linda Mury, Leo and Karen Lucas, Mike and Peggy Kowalsky, Maria Waters, Pat Hintze, Mary Lou Doulin, and Mary Behr. There were approximately thirteen attendees via ZOOM.

#### WELCOME GUESTS/PRIVILEGE OF THE FLOOR

Navitsky gave a presentation on Road Salt Reduction. He reviewed the history, funding spent to date, and the needs for the "Road Salt Grant Program Municipal SWiM™ Implementation Grant Agreement." Warren County and three towns within the county are currently part of the grant program: Hague, Queensbury, and Lake George.

The entire grant agreement, which includes Purpose and Grant Process sections, is on file at the town clerk's office.

A motion to agree to and sign the "Road Salt Grant Program Municipal SWIM Implementation Grant Agreement" passed unanimously.

By unanimous vote, all bills were authorized for payment.

#### **REGULAR COMMITTEE REPORTS:**

**Administrative:** Ramant thanked Amanda Peterson for her assistance in making the Town of Hague's website Americans With Disabilities (ADA) Friendly.

**Recreation and Promotion:** Ramant reported that the bands and vendors have been booked for Music in the Park in the summer of 2024.

**Highway:** Deputy Highway Superintendent Tim Fiallo reported:

- James Belden is working out well at the highway department.
- Paving has been successfully completed.
- The highway crew has finished needed culvert replacements.
- All trucks are set up for this year's winter season.
- The Yaw Road FEMA project has been completed.
   Seeding of the area will be completed in the spring of 2024 to assure growth.
- An extension has been filed regarding the next FEMA project for the replacement of a box culvert in Silver Bay.
- Grant funding from ADK is in process.

**Museum/Historian:** See unfinished business section regarding the NLG Outboard Marathon Marker.

**Personnel:** Bast reported that recently-hired ZEO Tristan Shappy is undergoing training with Cathy Clark.

**Planning/Zoning/Stormwater:** Cherubini reviewed the submitted ZEO report.

ZEO Clark requested the required board's permission to write to four property owners using Chapter 76 Unsafe Building, Sections 76-4 E, I and 76-5 stating that due to the unsanitary conditions of their septic systems, until the tanks are replaced, they will not be allowed to stay on their property.

The board granted Clark permission to draft the letters and to forward them (as well as any and all responses received) to the town board members.

Clark noted that the LGPC Wastewater Management Program has put additional strains on Hague's ZEO department time-wise, but helping property owners with failed systems has been a high priority.

Sewer District #1 & #2: Bast reported that the Sewer Advisory Committee met on November 9, 2023. The committee is looking into placing a permanent emergency generator at Cape Cod Village. There is one EDU appeal currently before the Sewer EDU Appeals Committee.

#### **UNFINISHED BUSINESS**

The board tabled the proposed Short-Term Rental Ordinance (STR) until the December 12th meeting.

A motion was unanimously passed to have the public hearing for Larter's wastewater variances requests (Sec. 93.8 Block 1 Lot 23) at the December 12th meeting. — 5 — December 2023

#### **TOWN BOARD, CONTINUED**

A motion was unanimously passed to approve placing a historical marker at the Hague Town Beach Park for the NLG Outboard Marathons next to the first bench as you walk down the boat launch boardwalk.

#### **COMMUNICATIONS AND PETITIONS:**

A motion unanimously passed to accept the letter of resignation from Richard Frasier from the Hague Planning Board.

#### **NEW BUSINESS**

The board agreed to advertise for applications for the Hague Planning Board to:

- Fill the unexpired term of Richard Frasier until 12/31/2025
- Fill the alternate position of Martin Fitzgerald

A resolution was approved by unanimous vote that Sandra Powell be named Deputy Chairman of the Hague Planning Board for the remainder of the 2023 year.

Resolution #86 of 2023 (Knotweed Grant) and to approve the requisite funding (town's share - \$16,800) so that the project can proceed.


A resolution was unanimously passed to cover the \$460.68 costs of a laptop dedicated for providing ZOOM streaming of the town's meetings.

### SILVER BAY YMCA AWARDED GRANT FOR TEEN CENTER

Silver Bay YMCA has been awarded an \$8,600 grant to help support the Silver Bay YMCA Ticonderoga Teen Center.

The teen center is run through Silver Bay in partnership with the Town of Ticonderoga and is open six days a week during the school year. It provides free activities and programs

such as basketball, cooking lessons, cake decorating contests, and pinata making for local teens. Teens may also suggest programs and activities or take advantage of one of the many hangout areas where they can "do their own thing."

In addition to activities and programs, the center has a dedicated hour every day for homework. The teens may also ask any of the staff for help with homework at any time the center is open.

The center's mission is to provide youth with a safe space to connect with their community, to engage in opportunities to grow, and to have the freedom to be their best selves.

"This grant allows us to continue our mission by giving teens a fun and safe place to come every day. We offer opportunities that help teens foster social, emotional, physical, and academic growth in a safe welcoming environment," explained Silver Bay Youth and Teen Director Jackie Palandrani.

The center has seen a lot of use since its reopening in 2022, with over 130 teens enrolled for its first year after the pandemic. During the 2022 - 2023 school

year, the center grew, with 160 teens registered. Many more are expected this school year.

# SILVER BAY AWARDED GRANT FOR HOUSING PROGRAM

Silver Bay YMCA announced it has been awarded a \$2,500 grant from the Glenn and Carol Pearsall Adirondack Foundation to provide emergency housing for families in need, including meals and access to support counseling.

"Silver Bay YMCA has been providing short-term transitional/emergency housing under the auspices of our Pastoral Respite Ministry for nearly 20 years. We have provided housing for people who have lost their primary residences due to fire, flood, homelessness, and for those in need of a safe place to stay.

"The accommodations we offer vary depending upon the situation and availability. We have housed people in cottages and in hotel-style rooms. We also include meals in our dining hall for those who need them. The length of stay can be from just a few days up to a few weeks. At Silver Bay, we strive to 'nurture spirit, mind, and body for all' and we believe that offering short-term transitional/emergency housing to those in our area is both a way for us to fulfill our mission and for us to be good neighbors," explained Silver Bay YMCA Spiritual Life Director Rev. Dr. Garth Allen.

This program has cost Silver Bay roughly \$45,000 so far this year, with it providing transitional/emergency housing to 22 families.

"Silver Bay's program for helping displaced families comes at significant expense. Since the program is free to the families being housed, we have to search for donors to underwrite the expenses. This Pearsall Foundation donation is a substantial source of support this year," Silver Bay's VP of Development and Government Relations Walt Lender stated.

#### **POSB NEW LOGO, INITIATIVES, AND LIAISONS**

On October 24, 2023 the Property Owners of Silver Bay (POSB) board met via ZOOM. Items discussed were:

- Approval of its first-ever logo.
- The development of a "Manual of Practice" (a set of procedures to guide the POSB Board internal operations).
- Donations to various organizations in Hague.
- The appointment of community liaisons.
- · The July 29, 2024 membership meeting.

The board thanked Paul Budd, a board member and owner of the Silver Bay General Store, for "graphic-smithing" the new POSB logo as a visual symbolizing POSB's work on behalf of the residents of Silver Bay/Hague.

Membership in the POSB is open to property owners and their relatives, heirs and successors, persons interested in the mission statement of the POSB, and non-property owners.

The new Manual of Practice defined the concept of "liaisons" as persons who share communications in their neighborhoods to and from the POSB and who encourage their neighbors to join the POSB themselves.

POSB has welcomed John Lipori, who is the president of the Forest Bay Home Owners' Association (HOA) as its liaison for Forest Bay. Mr. Lipori is a regular reader of The Hague Chronicle and reached out to me as the POSB president, with his interest in our



### A PRETTY NORMAL KID OVERCOMING MEDICAL CHALLENGES

Liam Scoville is the son of Patrick Scoville, Jr. and Kelly McCoy of West Hague Road. He has had a challenging start to his young life.

Liam's medical issues began when he was born breech, dislocated his hip, and had to be placed in a full body cast, which caused other problems. He was born with pulmonary hypoplasia, which means (his lungs are too small for his body. He also had an arterial septal defect, which is a hole in his heart and has asthma. He was placed in the NICU and he and his parents essentially "lived" at the hospital for his first two years.



Now Liam is a sweet, smart, resilient 4th grader who especially likes being with his friends.

He takes COPD meds, allergy meds, an inhaled steroid, and albuterol to keep his lungs clear and to help him breathe. He goes back to the hospital every three months for pulmonary function tests.

Tabitha Woods of the Children's Miracle Network chose Liam to be its spokesperson. At a fundraiser in February, he will play the drums and introduce each band.

Liam enjoys the Boy Scouts, video games, singing and dancing, going on walks, Legos, and reading books. Yep, in most ways, he's a pretty normal kid!

#### **BEETLE RELEASE AT CLARK HOLLOW BAY**

Under guidance of the New York State Hemlock Initiative, the Lake George Land Conservancy (LGLC) staff released 2,000 *Laricobius nigrinus* beetles at the LGLC's Clark Hollow Bay property in the Town of Putnam. This release is part of a

long-term management plan to establish biological control of the hemlock woolly adelgid (HWA).

Laricobius nigrinus beetles are native to the Pacific Northwest and are specialist predators, feeding exclusively on HWA throughout the fall and winter when the HWA is in its adult form.

Though these beetles have been released at other protected lands in the Lake George watershed, this release is the first on LGLC-owned land and the site is at the northern most known HWA infestation. The LGLC will continue working with the NYS Hemlock Initiative to monitor and manage the site.

# THE SCIENCE OF PROTECTING LAKE GEORGE

The Warren County Economic Development Corp's annual lunch, held on October 24, 2023, focused on the work being done by The Jefferson Project, a collaboration between Rensselaer Polytechnic Institute, IBM Research, and the Lake George Association (LGA) to understand the impacts of human activity on fresh water and how to mitigate those effects.

Keynote speaker Dr. John Kelly explained the research conducted by The Jefferson Project, which was founded ten years ago. Phase One focused on high-tech monitoring of the lake to understand its behavior. Phase Two embraces a Science-to-Solutions approach. The findings of the research serve as a guide for lake protection efforts and advocacy. Kelly pointed to road salt reduction as an early example of this approach. When monitoring showed a continuing increase in water salinity, the solution came in the form of the Lake George Road Salt Reduction Initiative, which has had great success in certain areas around the lake – particularly in Hague. In Phase Three, the lefferson Project is seeking to understand and mitigate Harmful Algal Blooms (HABs).

Climate change is increasing the amount of stormwater that enters the lake, bringing with it nutrients that contribute to HABs. As a property owner, you can help by managing stormwater on your property. The LGA stands ready to help. When you sign up for your free Lake Protector Profile app, you can tap into the LGA's resources, including an in-person property visit and consultation. You'll then receive a report that includes best practices, how-to information links, and suggested prioritization.

You can also sign up to be part of LGA's Algae Watch program and monitor your shoreline for signs of HABs.

# TI-ALLIANCE RECEIVES CHARLES R. WOOD FOUNDATION GRANT

The Ticonderoga Revitalization Alliance has received a \$100,000 grant from the Charles R. Wood Foundation to support the Ticonderoga Community Childcare Project.

The grant will be used to support the new childcare center to be located at St. Mary's School in Ticonderoga. Since early 2022, Ti-Alliance and a dedicated team of committee members, agency representatives, school leadership, and professionals from the surrounding communities have been working tirelessly to bring public childcare to Ticonderoga.

The Charles R. Wood Foundation was founded in 1978 with a mission to provide assistance to areas of special need in the Lake George Region and surrounding areas. Not-for-profit organizations with an emphasis on programs for children, healthcare, and the arts are the beneficiaries of Woods' generosity.

According to the foundation's website, Wood was known as an "optimistic realist."

"When it comes to building childcare for our community, we needed a lot

of optimism and a healthy dose of realism. Ti-Alliance is honored to be recognized by the foundation for our work on childcare and are so grateful for this critical funding that will help bring this project to fruition. We share Charley's vision of a region rich with resources for children, healthcare, and the arts," said Executive Director Donna Wotton.

The grant is part of a funding goal of nearly \$1 million needed to build a sustainable public childcare facility that will serve Ticonderoga and all the surrounding towns. The center will support approximately 50 children and create 11 full-time jobs, all providing living wage salaries and benefits.

The center is expected to open in the spring of 2024.

Ti-Alliance is an economic development 501c3 non-profit, working to develop business, employment, housing, education, childcare, and other activities that enhance the economy of the Ticonderoga area and to build a strong regional economic hub in the southern part of the North Country.

Fort Ticonderoga is launching a new schedule of programs during its "Winter Quarters" season. From now through April, visitors will be immersed in exciting living history events, engaging seminars, specialty programs, behind-the-scenes VIP Tours, and hands-on workshops.

Guests can explore Fort Ticonderoga during what was historically the "Winter Quarters" season for the armies of the 18th century. Groups of 15 or more are welcome to schedule a visit when they will have the entire property to

themselves and a dedicated historic interpreter for a group tour.

#### IN-PERSON LIVING HISTORY EVENT: Noble Train of Artillery -December 16, 2023, 10 am – 4 pm ET

This one-day living history event will relive Henry Knox's epic feat as he prepared to move massive cannon from Ticonderoga to Boston to force the British evacuation in 1776. Visitors will see soldiers work as carpenters to maintain Ticonderoga and they will witness the raw power of oxen as these thousand-pound animals pull sleds of cannon tubes. Guests will examine the science of gunnery preserved in Fort Ticonderoga's massive cannon collection, tour the fort, and learn more about the

museum's exhibits and daily demonstrations as they step into the first year of the Revolutionary War. They will also visit historic trades shops to discover daily routines for men and women at this strategic fortification in 1775.

#### **FORT RECEIVES GRANT**

Fort Ticonderoga has received a competitive grant from the Institute of Museum and Library Services (IMLS) in the amount of \$237,630 to support a major new 250th Anniversary exhibit program entitled *A Revolutionary Anthology*. The first year of this exhibit program, *A Revolutionary Anthology: Power of Place*, will open to the public in May of 2024.

On display will be hundreds of artifacts from Fort Ticonderoga's singular collection of 18th-century material as well as never-before-seen artifacts from the newly-acquired Robert Nittolo Collection. Rare arms from the battlefields of the American Revolution, artwork, soldiers' equipment, and uniforms from British and French soldiers will be a highlight of these exhibits for the next five years. Many of these artifacts are connected to specific individuals whose experiences during the revolution will provide a personal perspective to the monumental events of the American Revolution.

"The support from IMLS is a ringing endorsement of the significance of Fort Ticonderoga's collection and our museum's ability to activate it in innovative ways during the 250th Anniversary of the War for American Independence," said Fort Ticonderoga Curator Dr. Matthew Keagle. "We are thrilled to upgrade our exhibition capacity to make accessible more of our collection. With the recently-acquired Robert Nittolo Collection, including many artifacts that have never been on public display, we will tell a bigger, richer story about this earth-shattering historic event."
