- 1. Turn in (1) smoke mullet to the judges at 1PM.**
- 2. ALL materials must be legally obtained, mullet, mangrove wood, etc. If mangrove wood is used, it must be obtained from legal trimming.**
- 3. ALL smokers used on site must be in safe working order. You are responsible for maintaining a safety zone around your smoker.**
- 4. ALL fish brought on the premises are the property of Hancock Grills LLC. Selling/vending is not permitted. Any extra fish donated would be appreciated.**
- 5. ALL fish must be smoked on site.**
- 6. ALL fish must be handled and prepared in a clean and sanitary manner in accordance with USDA specifications.**
- 7. A list of all ingredients (recipe) must be available for viewing by the Judges and Hancock Grills LLC if requested.**
- 8. Only one vehicle per contestant allowed within smoking area.**
