Big Canoe Annual Meeting, January 28, 2024

The Annual Meeting of the Big Canoe Congregation was held on January, 28, 2024 following services and a potluck.

President of the Council, Brian Bigler, called the meeting to order and Pastor Gies led in opening devotions and prayer.

Secretary Rita Thomas read the minutes from the last Annual Meeting and they were approved as read.

Treasurer Laurie Emery gave the Treasurers report and it was placed on file. Our balance is \$3,357.14.

The Audit Committee met January 21, 2024 to audit all church financial records. The Committee consists of: Earl Arneson (not present), Michelle Borreson, Liz Schafer, and Rita Thomas. All records were accurate.

Council nominations were presented: Deb Monson, Loren Amundson, Bill Bullerman and Eric Stoen. After a ballot vote Deb Monson and Bill Bullerman were elected to the council. Installation of new members will be February 11.

Financial oversight committee report: The Dalakar fund has been disbursed between the church and the Cemetery Committee. Most of the Grindeland funds are in 3-year CDs. Committee members will meet in March to discuss if more needs to be done with the Grindeland or Osmundson funds. Committee members are: Darrel Stoen, Connie Amundson, Lisa Bullerman, Brian Bigler, Tammy Nordheim, Gary Stortz and Rita Thomas.

Aasa Haugen delegates will be: Sandy Gavle, Dee Wyatt and Emma Thompson.

Nominating Committee for 2024: Sandy Gavle, Brian Bigler and Darrel Stoen.

Conference Spring Assembly delegates will be: Pastor Gies and Bill Stoen.

Shelly Bigler reported that she has the account books and checkbook for **Sunday School** and Tammy Nordheim has the books and check book for **Luther League**. Both organizations are in suspension at the moment due to lack of participants. Shelly Bigler and Anna Jetson have been in discussion about a multi-generational Sunday School.

Youth church involvement was discussed. Tammy Nordheim moved, and Bev Stortz seconded, that the Vice President of the council form a small committee to send out a "Time and Talents" survey to the congregation. The survey will help the committee get a feel for what members want to set as goals for the congregation and what talents members have to bring to the table in meeting those goals. Motion passed. The Shared Ministry has a template for the survey that we could perhaps use.

Call Committee Report: The committee has been active contacting the Synod and doing everything they can think of to speed the call process along. Tammy Nordheim reported that Synod has indicated that most Pastors up for calls seem to want to move to larger cities and more money.

The **Social Concerns Committee** reported that they had been contacted by the Highland Fun Fest Run Committee to say that the Run proceeds this year will be donated to the Callie Tweeten Fund. They believe the Run will bring in more money than they are allowed to collect without forming a 501c3 as per the IRS. The Social Concerns Committee has decided that they will sponsor the Run as they are already under that designation.

Shirley Bigler requested we give a big thank you to those who removed the Christmas decorations from the church, Emma Thompson, Tammy Nordheim and Bob Maroushek. Thank You!

Direct Deposit Giving was discussed. There are several options for direct giving. You can set it up to go directly from your bank account into the church account, usually at no cost. You could use an app that the synod recommends for direct deposit, which does cost. We could have a QR code notice in the front of the church for guest giving. We could use Squar or a similar company to take donations at events. Tammy Nordheim moved, Rita Thomas seconded, that Bill Stoen look into what the QR giving would entail and report to the council. Motion passed.

The giving of the interest from the **Grindeland Fund** was discussed. The amount is \$324.12. Rita Thomas moved, Colleen Bigler seconded that the money go to the Decorah Free Clinic. Motion passed.

Worship service times were discussed at some length. Several members wanted to have services every other Sunday at alternating churches. Some wanted to have services at Big Canoe in the winter because of the pavement and services in summer at Highland for the air conditioning. Most wanted to keep the schedule we have. Kris Bigler motioned; Gary Stortz seconded that we keep the schedule we have now. Motion passed.

Tuckpointing project was discussed. Bill Stoen reported that the window sills and frames need to be painted at the same time as the tuckpointing is done. No other report or information was available at this time.

Cemetery Committee report. Tammy Nordheim reported that a group wanted to do a state wide seminar at Big Canoe on how to fix and clean stones. We have already had several meetings with groups cleaning and restoring stones. Matt Amundson did the mowing last year and did a great job along with helping with fence painting and other odd jobs. The committee hopes to hire him again this year. The committee thanked Steve Emery and Bob Maroushek for the cement work done in the cemetery and Sandy Gavle for putting together the new book of grave sites and a short history of the cemetery. The book costs \$30 for anyone who wants to order one.

WELCA will be holding a **chicken dinner drive through** again in June. Last years was very well received. WELCA also put together and gave away 443 quilts in 2023.

The Parsonage Report. Laurie Emery reported that the rent and utilities are paid promptly. Bob Maroushek reported that he has been mowing the lawn there and that the garbage stacked in the garage is of concern. It was decided that the Joint Property Committee should meet with the renters to discuss a raise in the rent in lieu of their mowing the lawn. The question of the garbage also needs to be addressed.

Bob Maroushek was presented with a bonus of \$1,000 for his work around and for the church and grounds. He has been working with no salary except his house rent since he was sick this last spring. A grateful council and congregation wanted to extend a special thank you to him.

Opening Devotions

Pastor Gies gave a reading and thoughts from Mark 1; healing and casting out demons. We were reminded that we should honor our roles as council members, officers and members of the congregation.

Secretary's Report

Dispensed with the reading of the minutes from the last annual meeting in their entirety and Pastor Gies provided a brief summary of the minutes. Motion by Virginia Karlsbroten and seconded by Dennis Karlsbroten to approve the minutes. Motion carried.

Treasurer's Report

Former Treasurer, Anna Jetson called attention to the printed 2023 financial report as provided in the annual meeting packet, having been printed on February 3, 2024.

Anna stated that insurance is paid up for 2024. The loose offering will no longer be split between the churches each Sunday, but will go to the host church that Sunday in its entirety.

Dennis and Virginia Karlsbroten thanked the church for the donation to their daughter and son-in-law this past year. Mark Sollien suggested that we consider keeping a portion of our benevolence locally for those in need and cut back on what we give to national and worldwide organizations. Tabled for later discussion.

Motion by Dennis Karlsbroten and seconded by Louise Jetson to approve the treasurer's report. Motion carried.

The congregation thanked Anna for her years of service as treasurer.

Pastoral Report

Pastor Gies stated that there were no baptisms or confirmations, no transfers in or out and two funerals at Highland in 2023. Items discussed at the Big Canoe annual meeting included the schedule or frequency of our joint worship services. He feels we can grow as a congregation and encourages us to invite guests, specifically young people to our worship services.

Call Committee Report

Steve Langland reported that the last candidate was not a good fit for our congregation. Little if no interest in us. We need to be open to work with other parishes when there's an opening as we cannot afford to do this on our own. We cannot continue to break even, that's not good enough. We will need to share a pastor. Pastor Gies indicated that he does need to get lay people trained to lead worship services when is gone or otherwise unable to do so.

WELCA Report

Virginia Karlsbroten provided a verbal update on activities this past year, which included bi-monthly meetings, bible study, Memorial Day Service, Ice Cream Social and Fall Bazaar, as well as assisting at the nursing homes for bingo and birthdays. Financial affairs are in order. Virginia noted that the 2024 Fall Bazaar will not be held on Labor Day this year, but later in the month on a date TBD.

Naomi Circle Report

Karen Erickson indicated that she closed the books on Naomi circle after purchasing items for the kitchen and writing a small check to WELCA for the balance.

Property Committee Report

Dan Dutka provided the update, indicating that the Bell Tower still needs work, the Landscaping still needs to be done and we have money for that project from the Depot. We also have money from the Depot for the two interior basement doors. There's been water in the basement in the women's restroom. We may need a new wireless microphone. Dan indicated that he will be retiring and then will have more time to devote to these projects.

Dennis Karlsbroten indicated that he had the church water tested. Once the results are received he will give to the counsel.

Joint Property Committee

Dan Dutka indicated that we do need to meet with Big Canoe about the current renters. Dennis Karlsbroten suggested that we do an annual inspection of the property. There is a contract, but apparently Highland does not have a copy of it. We understand that this a month by month lease.

Highland Cemetery Association Annual Meeting

Motion by Dan Dutka and seconded by Karen Erickson to suspend the Highland Annual Meeting and convene the Highland Cemetery Association Meeting. Motion Carried.

Dennis Karlsbroten called the meeting to order at 12:43 p.m. He called attention to the financial report contained in the annual meeting packet as prepared by treasurer Mark Selness. Dennis indicated that the trees out front were trimmed, but the flags were damaged in the process. He is seeking approval to purchase six new flags. He is not contacting the tree service as they have not billed us, but have donated their work to our church. Motion by Anna Jetson and seconded by Steve Langland to approve the purchase of six new flags. Motion carried. Dennis indicated that there were two funerals this year.

Dan Dutka indicated that the audit committee reviewed the financial records for the cemetery committee and all looks good. We are making money on the royalties from the oil rights we have and should not sell them. We've been receiving inquiries about selling them. Discussed mowing for the upcoming season. Eric Selness and Ed Stoen were thanked for snow removal.

Motion by Mark Sollien and seconded by Steve Langland to keep current cemetery committee members the same for the upcoming year. Motion carried.

There being no further business motion by Mark Sollien and seconded by Ed Stoen to adjourn. Motion carried.

Meeting adjourned t 12:51 PM.

The congregational annual meeting reconvened at this time.

Auditing Committee Report

Committee reported that everything is in order. No issues or concerns were identified.

Nominating Committee Report

The nominating committee presented two candidates for consideration to the council; Gary Selness and Dan Dutka have agreed to serve. Motion by Ed Stoen and seconded by Louise Jetson for nominations to cease and cast a unanimous vote. Motion carried.

Election of Council and Representative Voting Members

Nominating Committee: Mark Sollien and Virginia Karlsbroten agreed to serve.

Audit Committee: Louise Jetson, Joyce Bjerke and Steve Langland agreed to serve.

Mutual Ministry: Anna Jetson and Steve Langland agreed to serve.

Upper Iowa: Ann Jetson agreed to serve.

3C's (Creative, Collaborative Congregations) will be being June 1, 2024. Anna read the details of the event. We can check the website for further details. Anna agreed to serve.

Aase Haugen Senior Services Annual Meeting: Steven Langland, Karen Erickson and Dan Dutka will attend.

Motion by Dennis Karlsbroten and seconded by Mark Sollien to approve all nominees or volunteers. Motion carried.

2024 Budget

Dan Dutka presented the 2024 budget as approved and submitted by the council. He noted several highlights in the budget, benevolence was increased, but they removed the donation to the Depot. Dan informed us that we have a CD for the scholarship fund and that CD cannot fall below \$5000.00. The joint budget did not change and is high in anticipation of calling a pastor. Discussed organist compensation and if we would go back to two services each Sunday, we would eliminate the music coordinator line item.

Mark Sollien suggested that we keep more of our benevolence money for local families in need, cutting from other line items in benevolence. After discussion, motion by Mark Sollien that we add line item in the amount of \$1000 for local benevolence. Dennis Karlsbroten seconded, but offered a friendly amendment, that disbursement of these funds be approved by congregational consensus. Motion carried.

Motion by Dennis Karlsbroten and seconded by Mark Sollien to approve the general budget. Motion carried.

Unfinished Business

Shared Ministry: Anna informed us that the next shared ministry meeting is next Sunday in Burr Oak. She told us that the Synod was surprised by our attendance for our Round Robin Lenten Services. Hops and Hymns has been a success.

New Business

Congregation discussed the joint services schedule and decided to keep it the same; alternating every other month. We are flexible and will adjust as needed. Dan indicated he has offered window air conditioners to Big Canoe to use during the hot summer months.

Congregation discussed removal of the right front pew to allow more room and installing a railing for safety purposes. Would perhaps use the back of the pew as the railing. Motion by Dennis Karlsbroten and seconded by Al Erickson to remove the pew on the right front side and install a railing. Motion carried.

Aase Haugen Donation: Dan Dutka informed us that they are in need of \$300.000 for the new chapel. They are suggesting a target gift goal of \$4348.00 per year for three years. Much discussed ensued. Motion by Louise Jetson to leave this up to the council to decide our gift goal. Darlene offered a friendly amendment that the congregation set the gift goal amount, but leave it to the counsel to decide how we would do it or raise the money. Anna offered another amendment that we set our gift goal at \$1000 per year for three years. Gary Halverson offered another friendly amendment that we use the \$1000 local benevolence for this purpose if not used by the end of the year. Motion and their amendments carried.

Other items: Anna spoke on two items from the Big Canoe Annual meeting that may be of interest to us. 1. A joint Education Committee and 2. Time and Talent Survey to all members. A committee is needed to decide if we want our own tool or use the instrument that Big Canoe is using. The joint education committee was informally approved. Consensus is that we should use the same survey tool as Big Canoe. Both items will be added to our next council meeting agenda.

There being for further business motion by Karen Erickson and seconded by Mark Sollien to adjourn. Motion carried. Meeting adjourned at 2:03 PM.
