Early Schools of Walton County, Florida

Even before there were public schools in Walton County, a number of its families sought education in some form for their children. Typically, the more affluent families with the financial means hired tutors to come into their homes to teach their children, or sent them away to boarding schools or to live with relatives where nearby educational facilities were available to them. The children of families less financially situated however, often had little or no educational opportunities, and even when they did their education often came second to helping out on the farm or other endeavor in which the family made a living. Fortunate were those families in whose communities schools were established to meet the educational needs of their children. One of the earliest in the County for which records are available was Knox Hill Academy established about 1849 in Euchee Valley where it was preceded by the even earlier Henry School of an unknown establishment date. Knox Hill was not a free public school, but a private one funded primarily by the General Assembly of the Euchee Valley Presbyterian Church and its first teacher, Reverend John Newton, was hired by the Church Elders. As was typical of the era, education and religion played equally important roles in the education of children and little distinction was drawn between the two.

Newton's education and training suited him well for the role of a religiously oriented school master. He was a graduate of Amherst College in Massachusetts, which was founded "for the classical education of indigent young men of piety and talents for the Christian ministry." Additionally, before coming to Florida, he briefly taught school in North Carolina. During his tenure at Knox Hill Academy he gained wide recognition as a highly respected educator.³

He taught there from about 1849 until shortly after the Civil War began in 1861. Relocating to California for the duration of the war, he returned to Know Hill in 1866, but soon fell out of favor with the patrons of the school who disagreed with his views on ministering to freed slaves. He departed Euchee Anna and moved to south Walton County where he established the town of Mary Esther, now in Okaloosa County, which he named after his daughters, and became its postmaster. At the time of his death in 1893 he lived with his widowed daughter, Esther Newton Axelson, in Pensacola.

Lists of students he taught at Knox Hill and their patrons exist for the periods of September 24, 1849 to December 24, 1854 and March 1867 to July 31, 1868. Stuart Knox Gillis was one of many teachers who served as instructor at the school following Newton's departure. Patrons and students during his tenure are listed for June 17, 1889 through September 13, 1889. Enrollment at the school was not limited to local students only. Some attended from places such as "Marianna, Quincy and Pensacola, Florida; Geneva, Alabama and the state of Georgia."

Knox Hill Academy continued in operation until 1947. Its student records, however, only date from 1913, part of the reason for which will be explained in due course.

In 1849 when Knox Hill Academy came into existence Eucheeanna was the county seat and site of the courthouse. In May 1885 the courthouse burned and all official records of the county it held were destroyed, including those of the Board of Public Instruction.

Nothing resembling county Boards of Public Instruction existed in the State of Florida prior to the end of the Civil War. They originated under the constitution of 1868 which the former secessionist Confederate State adopted as a requirement for readmission to the Union after the War. ARTICLE VIII, Section 2, of the constitution, mandated the State Legislature to "provide a uniform system of Common Schools, and a University, and provide for the liberal maintenance of the same," and make instruction in the schools free to all children in each county between the ages of 4 and 21.6 Individual county Boards of Public Instruction were integral to the ensuing state-wide public school system established in accordance with the constitutional mandate and became active as soon as the selection of local officials, implementation of applicable regulations and acquisition of office space were possible. Presumably, that occurred about 1869 when John Gillis became the Walton County's first Superintendent of Schools.⁷ Whether he was elected or appointed is unknown.

Also unknown is what system, if any, existed prior to the advent of the Board of Public Instruction for maintaining lists of schools and collecting and preserving records of students attending them. Obviously, the records of some have survived, partially at least, as is evident of those for Knox Hill, although they apparently are privately held rather than in the possession of the Walton County School Board, all of whose existing records postdate the courthouse fire. No school or student records predating the fire other than for Knox Hill have come to light. One possible explanation for the absence of those records from other schools is that they were not required to preserve student records. It is also conceivable that schools retained them locally instead of forwarding them to a central collection point and they eventually became lost. Another possibility is that they were centrally collected at the courthouse only to be destroyed in the 1885 fire, which would seem to explain the absence of student records from the 1869 origin of the Board of Public Instruction to the date the courthouse burned.

The first post fire loss meeting was held on Friday, 19 June, 1885 in Eucheeanna. The minutes of that meeting through the one of Tuesday, 15 June 1886 are transcribed herein. On 16 February 1886, an election was held to select a new site for the county seat. DeFuniak Springs won and became the new site of county government.⁸ Consequently, the Board of Public Instruction meeting of 15 June 1886 was the first to be held at DeFuniak Springs. At that point in Walton County's history, it included a number of schools now in Okaloosa County which predated that County's creation in 1915. The minute books are on file at the District School Board office in DeFuniak Springs and are available for review by the public free of charge. As they include the names of many ancestors of people with Walton and Okaloosa County roots, and the names and locations of schools with which they were associated, these records provide both genealogical and historical information that may be of interest to those wishing to learn about their families' and the public educational heritage of the two counties.

Walton County's earliest student records consisted of names hand written on preprinted forms and filed separately from the minute books. They were later copied onto microfiche film which can only be viewed with a special machine. More recently, student records are entered into computers and can be copied to various forms of electronic media for data management purposes. Since the 1960s,

Florida student records have been confidential under State law and access to them is strictly limited to students and their parents, school district officials and a small number of other specifically designated specialists and professionals. School Board administrators are responsible for ensuring compliance with confidentiality laws.

In 1983, the late Donald Duane Bishop, General Supervisor of Walton County Schools, compiled a list of schools with the beginning and ending dates of student records on file for each. Those records with ending dates presumably corresponded with the closing dates of the schools and those without ending dates signified schools then still in operation. He assigned numbers to the schools and notated the numbers on a map of Walton County corresponding to the locations of schools as a cross index between the list and the map. A transcript of Bishop's school list and his annotated map are included herein.

A comparison of schools approved by the Board of Public Instruction in the minutes of its meetings from June 1885 to June 1886 to those in Bishop's list reveals long gaps of time between school approval dates in the minutes and beginning student dates per Bishop. The reason for these differences is unknown, but Bishop's student record beginning dates clearly are not school approval dates in every instance as the minutes demonstrate. Furthermore, school approval dates per the minutes are not in every instance the original school establishment dates as many of the schools listed originated long before 1885/86, of which Knox Hill Academy is a case in point. As previously indicated, it was established about 1849, whereas its student record beginning date was 1913, a gap of 64 years.

Bishop's list includes a total of 102 documented schools which have existed in Walton County, but the appearance in the Board of Public Instruction minutes of 1885/86 and later of schools not listed by Bishop indicates the number throughout the County's history was even greater. A number of them were in today's Okaloosa County, and no one knows how many community schools might have sprung up and then disappeared overnight without any documented record of their existence. Among those not listed by Bishop but included in the Board of Public Instruction minutes of 19 November 1888 is a school with the colorful name of Punch Bowl, which was located on the pond of that name a short distance south of Gaskin and west of Hwy 83. The number of schools had shrunken dramatically to less than a dozen as of the 1983 date of Bishop's list and included Paxton, Freeport, Maude Saunders, West DeFuniak, Walton Vocational, Walton Senior and Walton Middle School. As of 2019 the Walton County School District website lists 21 schools, including the Emerald Coast Technical College, Walton Virtual School, The Wise Center, Walton In"10" sity School of Excellence and Walton Learning Center.

At the meeting of 13 July 1885, the Board of Public Instruction enrolled a school at Freeport, no. 22 and another at De Funiak, no. 25. At the meeting on the 27 of that month, a school named Funiak (c), no. 29 and one named De Funiak Springs, no. 30, were enrolled. The two schools named De Funiak and De Funiak Springs may have been predecessors of Walton Senior High School. The schools at Freeport, and Walton Senior High School are still in operation and may therefore be the longest continuously operating schools in the county.

Ordered, that W. M. King, Josiah Miller, and J. Gillman be appointed Trustees of School No. 2 at New Prospect Church.

Ordered, that J. C. Douglass be allowed \$2.00 per day and mileage for 6 days services as County Superintendent, and seventy cents for stationery.

Ordered, that the examination of teachers this year be conducted in writing, and that questions on the different branches of study be revised and arranged by the County Superintendent and chairman of the Board by the time of the next meeting.

Ordered, that Mr. Allen McDonald, who claims pay for teaching a public school on Black Creek, last year, be examined. Examination sustained, certificate granted, and a warrant issued to Mr. McDonald for fifty two and 10/100 Dollars for his services as Teacher of Public School No. ___ on Black Creek last year, and that the claim of Mr. Settles be no longer recognized.

Ordered, that the Board meet on Monday 13th July 1885, for the purpose of establishing and organizing schools; and on the 14th July 1885 at 10 o'clock A. M. for the examination of Teachers.

Adjourned to, July 13th/85.






Reverend John Newton

John Newton was born April 22, 1814 in Pittsburgh, Pennsylvania. Of Scottish descent, he attended Amherst College and taught school in North Carolina before migrating to Pensacola, Florida, where, in 1848 he met members of the McKinnon family. Learning that he was a school teacher in search of employment, they invited him to accompany them to their homes in Walton County. He accepted the invitation and traveled with them aboard the schooner "Henrietta" to Freeport. From there he was taken to the Eucheeanna home of Colonel McKinnon who was so impressed with him that he took him to the Valley Church and introduced him to the elders. Newton later recalled of that meeting:

... There were quite a number of old Scotch elders and others in their substantial homespun jeans, suits of blue and dark brown; some sitting on the long door-steps basking in the sunshine, while others stood around them under and leaning against the great oaks that stood in front of the church. The Col. introduced me to all of them, telling them where I was from and how I came. I received a handshake welcome that I rarely met with in any other country.

A meeting was held the next day to hash out the particulars of Newton's employment as a teacher and the plans for a new school building. Knox Hill in the center of the Valley and one of the most elevated places in the county with an all-around view was selected as the location. The new, two story building had blackboards set in the walls, and large maps of both hemispheres hung upon the walls in the back of the building.

The school grew until there were about 100 students. The larger students were put upstairs on their good behavior; the younger ones were kept below under the watchful eye of the teacher. When there was trouble above, the troublemakers were brought down and given seats in the front of the lower room.

This new school, completed in 1849, was built by the parents, relatives, and friends of the students to be served. Although the Presbyterian Church was the School board, Methodists, Baptists, and Roman Catholics attended from places as far away as Pensacola and the neighboring states. The state and Federal governments neither helped nor hindered the school. No union or ACLU was breathing down its neck, proving once again that educated, intelligent, and dedicated teachers coupled with motivated parents make successful schools, not money and the fads of the day.

In 1858 at about age 34, Newton married Margaret Campbell, granddaughter of Daniel Campbell, one of the early settlers. Their first child, Angus Campbell, was born in 1859 and died about five months later. In 1863 they had a daughter, Mary Christine, who died in 1937. Esther Newton, who married Gustav Axelson, was born in 1861 and died in 1931 [in Pensacola]. Ten years into their marriage,

Newton's wife Margaret died in 1868 and was laid to rest in the Euchee Valley [Presbyterian Church] Cemetery.

He was not a physically large man, but he was a person who stuck by his guns and his convictions. He put a piano in the school to teach the young ladies how to play. He also encouraged them to become more used to fashionable but simple attire. His motto was "You must learn and obey." In 1854 when the trustees of his school told him to restrict the use of some of the books he had for his library because they thought the books had abolitionist leanings and were favorable to economic principles with which they disagreed, Newton said he would use the books in his school as he wished or leave the school. The equally stubborn Scots wouldn't back down and Newton resigned and left for California. He later returned to Florida and taught in Marianna and Orange Hill. By 1859 he was back in Eucheeanna, had taken a wife, fathered his first child and he and the trustees had moved the old Knox Hill Academy and started over again.

[It is generally believed] that Knox Hill Academy and other schools Newton founded and taught graduated well-educated students who did well in law, government, medicine and education. In 1853 he was one of four Floridians in the American Association for the Advancement of Science. Although his application only claimed 'ESPECIAL INTEREST' in five fields, he was accepted in the nine fields recognized by the Association at that time. Every time he changed schools, parents changed their children to go to his schools. [An early believer in continuing professional education,] he continued his in Atlanta and Michigan and became an ordained minister as well as a teacher. [One of the places where he served as minister was the Euchee Valley Presbyterian Church, whose elders were among the first to welcome him on his arrival in the county.]

Unfortunately, much of the good work in the county he had done in educating the young men of the area was wasted by the carnage and deaths resulting from the War Between the States. He did not believe in slavery but that did not deter him from marrying two women who were the daughters and granddaughters of two of the county's major slave holders. He didn't favor secession either and in this he was in step with the rest of the county which voted against it. [His rationale for tolerating both] slavery and secession apparently was that he was a part of the community he lived in. However, he didn't trim his sails to meet popular opinion and the more thoughtful residents of the area — who were also the major slave holders — respected his opinions and supported him as a teacher. Reverend Robert Quarterman Baker, a Confederate veteran from Georgia who served until the end of the war, was a staunch friend and admirer whose daughter married Newton's son.

Newton taught during the first three years of the war, but as more of his best students were killed, his first child [having] died in 1860 when only a year old, and feelings about the war running higher and higher, he resigned again and went to California a second time. [Apparently, he made a side trip to the mid-west during this absence from the county because the birth place of his second daughter, Mary Christine, born in 1863, was Illinois.]

[He did not remain out of county for long though.] By 1866 he was back teaching again in Marianna, two years before his first wife, Margaret died. In 1867 he resumed teaching at Knox Hill. He also felt it his duty to minister to the spiritual and educational needs of the freed slaves. In 1868 he left again-this time for Missouri. In 1870 he returned, and married his sister-in-law Mary Catherine, [she was listed as a member of Newton's household under her maiden name of Campbell on the 1870 U. S. census of Walton County] after which he moved to Camp Walton in Santa Rosa County, where he established a school and a church. [On 10 October 1871, he established the community's first post office and was appointed postmaster. He named the post office Mary Esther after his two daughters which also became the name of the town that grew up around it.] It is where his son, John Daniel Campbell was born the following November 20th and his second wife died the day after she bore the child and was buried at the Euchee Valley Presbyterian Church Cemetery.

[As of the U.S. census of 1880 (Figure 1) and the Florida State census of 1885, (Figure 2) Newton and his two daughters were living in Santa Rosa County. Curiously, his son, John Daniel Campbell did not appear in his household in either of those censuses, both of which gave the birth place of his daughter Mary Christine as Illinois.]

April 10, 1858 in East Bay, Santa Rosa County, son of Frederick A. Axelson (1825 Sweden-The Axelson family owned a shipyard at Miller 1883) and Margaret Hunter (1825 Scotland-1887). Point in Santa Rosa County. Gustav and Esther Axelson made their home in Pensacola on Florida Blanca Street. He was captain of "Donna Christine," a three-mast schooner, in the early nineties. In December of 1910, Gustav was aboard his ship "Dois" off Belize, Honduras, when he fell overboard during a storm and lost at sea. [Esther, who never remarried, continued living in her home at 318 South Florida Blanca Street in Pensacola until her death in 1931.]

In 1885, John Newton was asked by the founders of the Florida Chautauqua to take an active role in its creation. He declined with thanks because of his age and his work -- teacher, preacher and postmaster. He and his daughter [Mary Christine, who never married,] remained in Mary Esther until 1889 when they moved to Pensacola [to live with Esther and Gustav Axelson.] Newton lived there until his death in 1893. [According to his death certificate, he died of endocarditis, which generally occurs when bacteria, fungi or other germs from another part of your body, such as your mouth, spread through your bloodstream and attach to damaged areas in your heart." 

[As of the 1920 U. S. census of Escambia County, Mary Christine was listed in the household headed by her widowed sister, Esther Axelson. Mary's place of birth on that census was also Illinois (Figure 4). When Esther died in 1931, her home went to her children. They allowed Mary to continue living there until her death on 22 July 1937, as evidenced by her residence of 318 S. Fla. Blanca St. listed on her death certificate. It identified her as Miss Mary Christine Newton, single white female. Her age was listed as 73 years, 10 months and 10 days. Parents - John Newton and Margaret Campbell. Cause of death was Chronic Cardiac Valvular Disease (Figure 5). Her remains were returned to the Euchee Valley Presbyterian Church Cemetery for burial with other members of her family.]

[The Gustav Axelson House is now an historic land mark in Pensacola (Figure 6). Evidence that it was the place of John Newton's death is provided by a photo of the house with street signs in front reading "Zaragosa St. and Florida Blanca St," as stated on his death certificate.]
