## a. General Manager

- i. GM, Walker reported that this is the second year of the rate study increase that went into effect at the end of December of 2022. January will be the first full month of billing, increased by 5% across the board.
- ii. With all the rain we've had, the lake is up 740 ft in elevation, roughly 23 ft more from Christmas.
- iii. There are current releases at Lake Pilsbury and is down about 1,000 acre feet.
- iv. Lake Mendocino is over 70,000 acre feet in storage as of now.
- v. Has spoken with Jack Miller about getting a quote for a full panel rebuild for Spanish Canyon if they can't get it up and running back from the manufacturer here in the next couple of weeks.
- vi. MSA will be staying in place for another year for Willow. Most of the contracts are staying flat or dropping a little bit.

i. GM, Walker reported that he attended a meeting hosted by Sonoma Water, stating that the State of California is still predicted to be in a drought for the upcoming 2023 year. Most of the major reservoirs throughout the state remain critically low.

- i. GM, Walker reported that meetings are still taking place with City Management and the Attorney Groups; the Attorney Group has decided that the next step is to establish a JPA.
- ii. Working on cleaning up the new draft document to be presented at the next Ad Hoc meeting on the 31st of January.
