Approval of Agenda

Staff Reports

a. General Managers Report

- i. GM, Walker reported he received word from PG&E that they were planning to leave the spill gates open at Lake Pilsbury for the foreseeable future due to a seismic study that had been conducted on Scott Dam
 - 1. PG&E is transitioning to a Liability Reduction Company
 - 2. This will cause drought type of releases in the Summer/Fall months and greater releases in the Spring/Winter months
- ii. PG&E is looking to have the entire PVP and Scott Dam decommissioned

- iii. Russian River Water Forum (RRWF), is a new group being formed (roughly 30 members) to work towards a Water Sharing Project if the current PVP is decommissioned
- iv. GM, Walker also reported that the Form 700's were due at the beginning of this month
- v. There are a few upcoming projects taking place
 - 1. Installation for river intakes,
 - 2. Routine maintenance on pumps, motors, etc

b. Office Managers Report

i. Office Manager, Patton reported that she will have new signature cards by the next meeting available for Director Ross to be able to sign checks.

Old Business

a. Report on Water District Service Contracts

- i. GM, Walker reported that several projects are taking place within the districts
 - 1. Willow & Hopland had a full Sanitary Survey inspection completed by the State
 - 2. Anticipating Millview inspection in the coming months
- ii. Lots of updates taking place in Redwood Valley at their Lake Pump Station & SCADA upgrades at their Water Treatment Plant
- iii. Redwood Valley will have access to water this year to be able to run their treatment plant

b. Update on Drought and Water Conservation

- i. GM, Walker reported that Lake Level is up to 99,000 acre feet
- ii. Anticipating Lake will be over 100,000 acre feet after this weekend
- iii. FIRO is allowing more water to be stored in the Lake

c. Update on Well 6 Pump House Building

- i. GM, Walker reported that ZFA has been in contact with Luhdorf & Scalmanini and everyone is in agreement on the structural plans of the building
- ii. More updates to come on the electrical side of things

d. Report on Upper Russian River Water Agency and Consolidation Efforts

- i. GM, Walker reported that the next Ad Hoc meeting will take place on Tuesday of next week at 6 pm.
- ii. Director Cardoza commented that he was under the impression that the consolidation efforts was going to be based upon an independent water agency and was surprised to find out that the districts would eventually be consolidated into the City of Ukiah
- iii. Attorney Neary stated that the proposal is that the new JPA is to provide services to the customers
