- iv. Several leaks happening among the districts as the ground is drying up for the season

c. Update on Drought and Water Conservation Efforts

- i. GM, Walker reported that Lake Mendocino has started to decline in water level but still remains around 97,000 acre feet at this time
- ii. Re-evaluate relinquishing water restrictions next month; currently at 25%
