

The New Declaration of Independence of the Conservative Population of The United States of America

When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security. Such has been the patient sufferance of this Conservative populace; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present Presidential administration, the preceding Democratic party administrations, and their associated Democratic political party elected politicians and appointed officers (here to fore referred to as 'They' and 'Leftists') is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over God fearing conservative people. To prove this, let Facts be submitted to a candid world:

They have refused to agree to pertinent laws, the most wholesome and necessary for the public good that protect life, liberty, and the pursuit of happiness and have either eliminated or altered said laws.

They created new laws that have robbed the population of freedoms that were set forth in the original 1784 U.S. Constitution and were granted unto all men and women by God, The Creator of Mankind, and have sought to control the citizenry with said laws.

They have called together legislative bodies and committees at unusual places and at unusual times and in unusual manners for the sole purpose of accusing, punishing, confusing, misinforming, and distracting the conservative leaders and general public, from what their true purpose is... to gain tyrannical power over this great nation.

They have repeatedly, through use of the leftist sympathetic media, hypocritically accused innocent individuals on the conservative right, of infractions and insurrections that they, the leftists, have themselves committed.

They have silenced and controlled the speech of all who oppose their way of thinking making a complete mockery of the 1st Amendment and in doing so, have forwarded strange and left leaning ideals and social mannerisms that have perverted the God fearing clean way of life that at one time permeated this land.

They have destroyed the sovereignty of the United States of America by refusing to secure her borders and allowing those who have crossed illegally to remain... whether they be a friend or foe of this nation. In doing so, they have endangered the lives of the peaceful citizens of the U.S. of A. and have in many cases, caused the deaths of innocent U.S. citizens.

They used the afore mentioned open borders to assuage those illegal aliens with tax paid benefits in order to secure votes for themselves from these illegal individuals by restricting the use of proper credentials at polling places and thereby 'winning over' these peoples for the intent of bolstering their own constituency.

They have tolerated, ignored, and even at times encouraged the senseless attacks by leftist mobs who have destroyed private properties, injured, and frightened innocent citizens, and even killed those who have done nothing more than walked down a public street.

They have incited hatred between races, immigrants, and foreign nationals within the borders of the United States of America to the point of endangering those on both sides of this leftist created conflict. We have appealed to their native justice and magnanimity, and we have charmed them by the ties of our common kindred and as both of us being citizens of a free USA to disavow these usurpations, which, has invariably and inevitably interrupted our connections and correspondence and created a divide between us. They too have been deaf to the voice of justice and of consanguinity. We must, therefore, hold them, as we hold the rest of this decaying republic, as enemies of Conservative good.

We, therefore, the Representatives of the 2022 United States of America, in drawing up this declaration, do, in the name, and by Authority of the good People of the Conservative Right, solemnly publish and declare, that The Conservative Right Population of The 2022 United States of America, are Absolved from all allegiance to the 1776 United States of America and that all political and governmental connection between them and the 2022 United States of America, is and ought to be totally dissolved. We also call upon the People and Governors of states that have supported said Conservative values, morals, laws, legislation, and freedoms to secede from the former 1776 United States and to conjoin and form with the New 2022 United States of America as Free and Independent States. They are to have full power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. And for the support of this Declaration, with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes, and our Sacred Honor.
