	Details:	The intersection of Pleasant Hill Road and Poinciana Boulevard will be reconfigured beginning April 10 between 9:30 p.m. until 5 a.m. A barrier wall that will close the southbound right turn lane from Pleasant Hill Road onto Poinciana Boulevard will be installed. The extended southbound turn lane will be closed for water

The message boards indicate that the change will be made overnight April 14th. This conflicts with the above that is available on the county web site:

Time will tell if lessons were learned the last time they mucked with this intersection. I am not confident that they did learn lessons. So, everyone should be prepared for longer than normal commutes over the next month.

Feedback from social media indicates that the work is required (I agree 100%) so just plan accordingly. If the county had a history of initiative-taking and using every mitigation

option to ensure the least disruption possible I would agree. Over the years the county has had no institutional memory. Every time a change like this goes into a huge disruption ensues. Complaints are made and a closer look by the county department of transportation follows. Within a day or two additional mitigation measures are taken. My issue is why not the closer look before action is taken. I did make a presentation at the County Commission Feedback meeting on the issue. If change is what we want we must push the Commissioners at every meeting with large a crowd as possible.

Update:

I was able to speak to the Osceola County Transportation & Transit In-House Consultant about the upcoming work at the Poinciana and Pleasant Hill Road Interaction.

It turns out there are two activities to support the repair/upgrade of a water main.

The first will happen overnight starting on Wednesday April 10th at 9:30pm and is currently on the county website.

The intersection of Pleasant Hill Road (PHR) and Poinciana Boulevard will be reconfigured beginning April 10 between 9:30 p.m. until 5 a.m. A barrier wall that will close the southbound right turn lane from Pleasant Hill Road onto Poinciana Boulevard will be installed. The extended southbound turn lane will be closed for water main construction starting Wednesday, April 11 through May 5, and will then reopen to traffic. Motorists are advised to expect delays. The 2nd activity will be the overnight closing of Poinciana Blvd to make the repairs. This is the work being advertised on the message boards. The full plan will be posted on the above website on Friday and will include the multiple dates the intersection will be closed overnight.

In conversation with the consultant, it was confirmed that the continuous right turn lane from Poinciana Blvd southbound to PHR southbound will not be impacted during the day and evening traffic peaks.

Only time will tell if this is correct.


Per the consultant the reason that both activities were not placed on the web page was the fear it would cause confusion. With the early placement of the message boards this decision led to additional confusion.
