2016 OFFICER FATALITIES

The 135 officer fatalities in 2016 is a 10 percent increase over the 123 who died in the line of duty last year and is the highest total since 2011 when 177 officers made the ultimate sacrifice. Firearms-related incidents were the number one cause of death in 2016 with 64 officers shot and killed across the country. This represents a significant spike— 56 percent—over the 41 officers killed in gunfire in 2015.

Among the states, Texas had the highest number of officer fatalities with 17, followed by California with ten, Louisiana with nine, Georgia with eight, and Michigan with six.
