A. POR Copper Country Logo

B. POR Awards Budget Approval

Motion: Mindy Erskine moved for approval of \$20,000 for the main CCPOR awards as listed on the Copper Country Paint O Rama Awards document.

Second: Beverly Gaddis

Vote: Motion carried unanimously

Discussion: The awards committee is requesting \$20,000 for the main CCPOR awards. Update the Copper Country Paint O Rama Awards document to remove "open" from the All-Breed category for consistency. Clarification on high-end awards. Remove "ultimate awards" from the Copper Country Paint O Rama Awards document.

C. Chrome Cash Awards Approval

Motion: Laurie Roden moved to have the club submit \$5,000 with the application for Chrome Cash.

Discussion: Chrome Cash is an APHA-sponsored matching funds program. APHA will match club funds up to \$10,000 to be used as cash prizes for a show. Exhibitor pays a fee to enter a Chrome Cash class. If approved, Chrome cash classes will be available in the second show of the CCPOR.

C. Stall Fee Increase Approval

Motion: Erica Owen moved to discuss raising stall fees for November and future shows.

Motion Amended: Erica Owen moved to approve a stall increase to \$50 a night for the November show only

Second: Jennifer Hungate

Vote: Motion carried unanimously

Discussion:

- Stall fees will increase to \$50, with a flat fee of \$300 for the November show.
- Concerns were expressed that the flat fee for the 5-night shows in November is \$250, and the 9-night shows at CCPOR is \$300, which is only a \$50 dollar difference for 4 additional nights.
- The flat fee for November was suggested to be \$200.
- Add a 6th-day line item to the CCPOR Stall contract. The flat fee was suggested to be \$350 on the 7th night
- The previous year, approximately 290 stalls were rented.
- It was suggested to raise the "late" fee.
- Add stall 6 nights \$300 to Stall Reservation form
- Revise check payable line from APHC/Stalls to APHC
- The committee will get a stall price confirmation from WestWorld

Motion: Mindy Erskine moved to approve a stall increase for CCPOR stalls to \$50 per night with a cap of \$350 flat rate that kicks in on the 7th night.
