## **RESOLUTION NO. 2001-01**

A RESOLUTION PROVIDING FOR BUILDING PERMITS REQUIREMENT AND FEE SCHEDULE.

THE FOLLOWING VALUATION DATA IS ADOPTED FOR FEE COMPUTATION. ALL OTHER FEES AND COMPUTATIONS ARE DETERMINED BY THE SCHEDULES AND PROVISIONS OF THE 1994 UNIFORM BUILDING CODE AS ADOPTED BY THE COUNTY COMMISSIONERS AND WHICH ARE LOCATED AT THE ADMINISTRATOR'S OFFICE.

BUILDING PERMIT FEE OF \$ 25.00 WILL BE CHARGED IN ADDITION TO CONSTRUCTION RATES EXCEPT FOR MANUFACTURED HOMES, MODULAR HOMES AND TRAILER HOMES.

ADMINISTRATION FEE FOR MANUFACTURED HOMES, MODULAR HOMES AND TRAILER HOMES WILL BE BASED ON .15 CENTS A SQUARE FOOT IN ADDITION TO SET UP FEES.

BASIS FOR SQ. FT. IS TO FIGURE CONSTRUCTION RATE FOR DETERMINING FEE. (example  $-24 \times 60 = 1440 \text{ sq. ft.} \times \$42.00 - 60,480 \text{ value of home which would result in a fee of $643.50 plus $25.00 permit fee for a total of $668.50.)$

## **EFFECTIVE DATE**

This resolution shall become effective upon proper publication thereof and is set forth by the Board of Commissioners. This resolution replaces Resolution 96-08 and any other resolution or ordinance which speaks to building permit fees prior to April 1, 1996.

## PENALTY

Any person violating any provisions of this resolution shall be guilty of a misdemeanor.
