Dear Applicant:

We're pleased to tell you we determined you're exempt from federal income tax under Internal Revenue Code (IRC) Section 501(c)(3). If we indicated at the top of this letter that an addendum applies, the enclosed addendum is an integral part of this letter.



ADDENDUM
