b. 6th District MPD - Captain Matthew Fitzgerald (matthew.fitzgerald@dc.gov)

In the last month, there has been a homicide on Minnesota Avenue at the Shell gas station. As of now, there have been some leads in the investigation that can't be disclosed yet. Overall, there has been an increase in violent crimes and robberies and an increase in property crimes. MPD has increased deployment in areas where there are high rates of property crime. There will also be increased police activity on the Minnesota Avenue Corridor.

5. Presentations/Special Guests

a. US Attorney Matthew Graves, US Attorney's Office for the District of Columbia

US Attorney Matthew Graves has been in office since November of 2021. Matthews has ten years of experience working as a career prosecutor for violent crimes and has lived in the District for 20 years. Because of his experience, Graves is invested in community safety on a community and personal level. The US Attorney's Office is laser focused on reversing the current surge in violent crime. Course of action includes removing people with misconduct for a period to improve the issue of violence in the community. Graves identifies substance abuse and mental health issues as a common cause for misdemeanors. The US Attorney's Office is seeking to adequately address these issues rather than punish individuals.

Regarding juveniles, juvenile cases are handled by the Attorney General's office. A small number of juvenile cases are overseen by the US Attorney's office, under the condition that the juvenile is sentenced as an adult. Additionally, the DC Council has been rewriting the DC criminal code to get rid of the mandatory minimum for car jackings. This is due to the high percentage of juveniles committing carjacking cars for "joyrides." The US Attorney's Office continues to target individuals distributing narcotics illegally.

b. Rev. George C. Gilbert, Jr., Executive Director, The Center for Racial Equity and Justice (Bill concerning Mobile Voting)

Reverend Gilbert lives in Ward 7 and works at the Holy Trinity United Baptist Church. Reverend Gilbert is seeking support for a bill that allows residents to vote via their cell phone devices. This form of voting has been used in states such as Alabama, North Carolina and West Virginia. In order to digitally vote, an individual must register the same way they would for an in-person or mail-in ballot. Additionally, the application for this form of voting has fraud prevention features. The bill is set to take effect in 2024.

c. Barbara J. Bazron, PhD, Director, Department of the Behavioral Health (FY 23 budget presentation)

The Mayor's FY 2023 operating budget is split into two parts. The budget has \$12 billion allocated for General Funds and \$10.7 billion allocated for Local Funds. The funds will be distributed across several sectors. The sectors are Health & Human Services, Public Education, Enterprise & Other Funds, Financing & Other, Public Safety & Justice, Operations & Infrastructure, Government Direction & Support, and Planning & Economic Development. Additionally, the budget will be used to target behavioral health transformation and integration initiatives. The goal of the budget is to help the District emerge from the pandemic stronger and ready to thrive.
