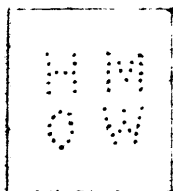

ADDITIONS TO THE OFFICIAL PERFIN CATALOGUE

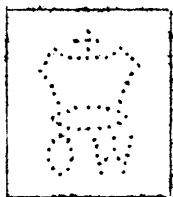
1.4. HER MAJESTY'S OFFICE OF WORKS

It is now possible to give illustrations of the two H.M. Office of Works official perfins. Dr. R. Powell sends a tracing of his mint 1d lilac perforated Crown over OW. The writer has a used ½d vermilion with the perforated letters HM/OW, although the stamp is not on cover or piece with identification, it is thought that it must be an example of the first official stamp used by H.M. Office of Works.



According to Patrick Hamilton (in "British Stamps") 2,400 copies of the ½d vermilion were punctured HM/OW in August 1895, and likewise 3,600 copies of the 1d lilac.

The writer's copy of the ½d vermilion is postmarked 'Liverpool' and is dated FE 11 96.



Two months later, in October 1895, the die was changed to Crown over OW and a similar quantity of stamps were perforated, these being the ½d vermilion and the 1d lilac. Dr. Powell has an example of the 1d lilac mint.

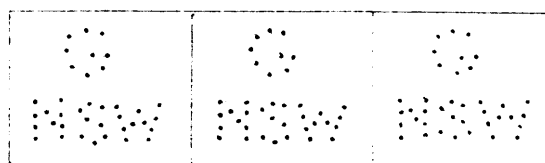
Five months later stamps were OVERPRINTED with the words "OW/OFFICIAL" for use by the Department. The first values were the ½d vermilion and the 1d lilac, issued with overprint on 24.3.96 to replace the two sets of punctured stamps.

G/NSW 9/10,8,11

G/NSW 9/10,8,11, introduced in 1937, surely presents the largest field for specialisation. Strips of stamps with these punctures will show that they are not exactly identical, and it is understood that there are ten 'G/NSW's all slightly different.

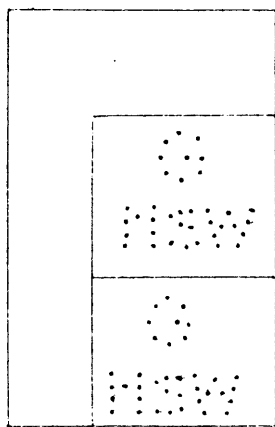
There are also a few constant varieties with missing pins.

A great many stamps were punctured for Official use, and if one tries to get all possible examples for all variations and varieties the collection would be a large one.

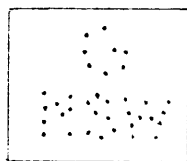


On S.G. 189

(Mr.C.Carr)

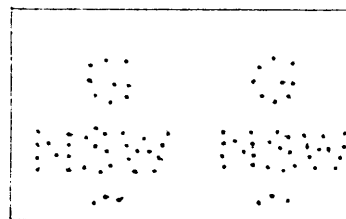
Note The 'G' of the first stamp is a perfect round

- SH/MC Another from Mr Tomkins. Shrewsbury HMC is Birmingham 15 Group.
- PH/MC Mr Summers reports this on code envelope with Wisbech postmark and noted in writing 'Clarkson Hospital'. Peterborough and Stanford HMC is East Anglia 12 but the Clarkson Hospital at Wisbech is North Cambridgeshire HMC (East Anglia 14)
- SM/H On code envelope with postmark London E.C. 7 Jun. 1968. St. Mary's Hospital (London Teaching No. 9) is postally W2. This is a hospital but more information is needed for identification.
- TB/H From Mr Summers. Tooting postmark on code envelope, with Tooting Bec Hospital written on envelope. I think we can accept this as correct. Tooting Bec Hospital was the only hospital in South West Metropolitan Group 30 but in July 1964 it was amalgamated with the Battersea and Putney Group to form the Battersea, Putney and Tooting Group.
- TH/MC No legible postmarks. Possibles are Taunton, Torquay and Tottenham.
- UC/H Mr Summers has this with London W.C. postmark on code envelope with handwritten identity, 'University College Hospital, Gower Street, W.C.1.
- WG/HMC From Mr Coates. Windsor Group HMC, Group 4 in the North West Metropolitan Region.

That seems to be all for the present. I will produce further notes if and when sufficient new material is available.
