RESOLUTION NO. 1-2016

RESOLUTION OF THE COUNCIL OF TRAPPE TO DESIGNATE THE TOWN OF TRAPPE AS A SUSTAINABLE COMMUNITY, PURSUANT TO THE ATTACHED SUSTAINABLE COMMUNITY MAP AND SUSTAINABLE COMMUNITY PLAN, AS FURTHER DESCRIBED IN THE SUSTAINABLE COMMUNITY APPLICATION, FOR APPROVAL EITHER DIRECTLY BY THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT OF THE STATE OF MARYLAND OR THROUGH THE SMART GROWTH SUBCABINET OF THE STATE OF MARYLAND

WHEREAS, the Council of Trappe recognizes that there is a significant need for reinvestment and revitalization of the Town of Trappe; and

WHEREAS, the Council of Trappe proposes to (i) designate the Town, as outlined on the attached map (the "Area"), as a Sustainable Community, and to (ii) adopt the Sustainable Community Plan (the "Plan"), as further described in the Trappe Sustainable Community Application (the "Application"), for the purposes of contributing to the reinvestment and revitalization in the Area; and

WHEREAS, the Area is located within a priority funding area under Section 5-7B-02 of the Smart Growth Act; and

WHEREAS, the applicable law and the Community Legacy Program regulations require a local government to submit an application to the Department of Housing and Community Development in order to become a designated Sustainable Community, and to adopt a satisfactory Sustainable Community Plan in order to be eligible to receive financial assistance under the Community Legacy Program.

NOW, THEREFORE BE IT RESOLVED by the Council of Trappe that the Council hereby (i) endorses the designation of the Area as a Sustainable Community; and (ii) adopts the Sustainable Community Plan described in the Application, which is attached hereto and incorporated by reference herein.

BE IT FURTHER RESOLVED THAT the President of the Council of Trappe is hereby authorized to execute documents and take any action necessary to carry out the intent of this Resolution, including but not limited to executing the Application and such other documentation as may be necessary to pursue and obtain the Sustainable Community Designation for the Town of Trappe.

BE IT FURTHER RESOLVED THAT, copies of this Resolution are sent to the Secretary of the Department of Housing and Community Development of the State of Maryland for consideration by the Smart Growth Sub-Cabinet.
