New Business –

- **Ordinance 1-2020** – An Ordinance of the Town of Trappe approving and adopting certain revisions to the PUD Plan and Design Guidelines for the Lakeside Planned Neighborhood Zoning District. (POSTPONED)
- **Ordinance 3-2020** - An Ordinance of the Town of Trappe to amend Section 14 of the Trappe Town Code titled “Water and Sewer”, Table 1 titled “Fees and Charges” to increase the basic monthly sewer service charge for in town properties to \$55.00 per month and the basic monthly sewer service charge for out-of-town properties to \$110.00 per month and to increase the turn on and turn off fees to \$50.00. *(available for introduction)*
- **Ordinance 4-2020** – An Ordinance of the Town of Trappe adopting a General Budget for the Fiscal Year beginning July 1, 2020 and ending June 30, 2021, and establishing a tax rate of \$.33 per \$100 of assessed real property value and a tax rate of \$.54 per \$100 on all commercial or business personal property and public utilities; and establishing an annual fee of \$130 per residential household for trash collection services, and also adopting an Enterprise Budget for the Town’s water and sewer operations. *(available for introduction)*
