Guest Speaker Major Drew Dela Cruz USAF-DFC

August 22, 2021, more than 100 massive cargo aircraft were tasked with evacuating 114,000 refugees from Afghanistan, including the USAF C-17 piloted by, then, Captain Dela Cruz. His C-17, call sign Reach 651, was circling above Al Udeid Air Base in Qatar with 450 Afghan refugees aboard. The plane had been aloft for hours, had only one small toilet and no air conditioning as it flew through stifling subtropic air and ... it was running low on fuel.

The crew had been briefed earlier in the day that saboteurs planned to attack Hamid Karzai International Airport in Kabul possibly by suicide bombers so the crew had taken extra precautions to search everyone coming on board.


While the aircraft was waiting for landing clearance, a 16-year old mother began convulsing then fell unconscious. To better care for the woman away from the cargo bay, Capt. Dela Cruz ordered she be brought to the flight deck.

As the crew took her to the flight deck, two Afghan men tried to force their way to the front to gain entry to the cockpit. A Security Staff Sergeant physically restrained one of them as a loadmaster pulled the other away, thus defusing the possible attack on the flight crew. A female Sr. Airman saved the life of the young woman while a Lieutenant barricaded the cockpit door. Capt. Dela Cruz declared a medical emergency and was given immediate clearance to land. With extreme skill and assistance from another pilot, Dela Cruz was able to navigate the jammed tarmac and get the stricken woman to a waiting ambulance.

Dela Cruz' poise, sound decisions and command authority aboard Reach 651 led to his being awarded the Distinguished Flying Cross for a single act of heroism and extraordinary achievement in aerial flight. Seven other members of the crew of Reach 651 were similarly recognized.

Dela Cruz' parents, El Dorado Hills residents, Jill and Rick are justly proud of their son's actions. Rick Dela Cruz points out the last mission son Drew flew out of Kabul was his "proudest moment". His C-17 was full of United States Marines, and he was proud to get the marines out and back to safety.

A graduate of Oak Ridge High School in 2012 and the USAF Academy, Major Dela Cruz is stationed at Travis AFB where he resides with his wife, Janessa.



Master of Ceremonies Peter Wolfe Lieutenant Commander, USCGR, Retired

LCDR Peter Wolfe, USCGR (Ret.) served as an officer on high endurance cutters and was awarded the Humanitarian Service Medal for search and rescue and law enforcement.

Peter retired from the U.S. Coast Guard in 1998 with 22 years of enlisted and commissioned active and reserve service, his enlisted service was as a Yeoman Third Class assigned to Coast Guard Training Commands in California and New York and as a crew member on patrol boats assigned to the Pacific Area.

After receiving his commission, Peter was a team member or Boarding Officer responsible for nearly 100 drug enforcement boardings and vessel seizures at sea. In 1976, Peter found himself leading a boarding party which seized a 611-foot Soviet transport ship for violations of the newly established U.S. 200 mile territorial limit.

In 1979 Peter was assigned as operations officer for the Commander, Southeast Squadron, a multi-service flag officer responsible for the U.S. Navy, Coast Guard and Air Force response to the Cuban refugee crises and the Mariel Boat Lift.

LCDR Wolfe was Executive Officer of the Coast Guard Air Station in Sacramento, California, conducting search and rescue and law enforcement operations throughout the Pacific from Southern California to Alaska.

As a reserve officer, Peter was recalled to active duty and ordered to Alaska to assist in the clean up operations related to the grounding of the MV Exxon Valdiz.

In civilian life, Peter is an architect and building inspector. Notably, LCDR Peter Wolfe is the Architect for the El Dorado County Veterans Monument. Peter and his wife, Karen have four adult children. Peter is a member of the board of The El Dorado County Veterans Alliance.

Issuing the proclamation for the State of California is Lindsey Sin

United States Navy Veteran Lindsey Sin serves as Deputy Secretary of Communications for CalVet. After graduating from high school in Sacramento, Lindsey enlisted in the US Navy and served from 1997 until 2005 as a Cryptologic Technician Interpretive in the Arabic language. She completed two flight tours in Rota, Spain during which time she deployed in support of Operations

Northern Watch, Southern Watch, Enduring Freedom and Iraqi Freedom. She worked with veterans at Sacramento State and served as Vice President of the Veterans Alumni Association. She resides in Sacramento with her husband and two children.

Issuing the proclamation for El Dorado County is George Turnboo District Two Supervisor



A formation of renown T-6 "Texan" Warbird aircraft presents three flyovers in tribute to veterans. The ceremony opens with an eastbound direction, the aircraft fly westbound over the monument during the National Anthem and return eastbound a few minutes later in a "missing man" formation. The "missing man" aircraft, by tradition, breaks off from the group and flies west while the rest fly east.

Leading the flight is flight leader, Chuck Wahl. Joining the flight are; Jim Eberhardt, Terry Tarditti and Jim Booth. Booth will be performing the "missing man" maneuver.

WELCOME HOME

Planned for placement at the El Dorado County Veterans Monument, to the left of the entrance walkway, is statuary portraying a joyous return from duty for two El Dorado County members of the U.S. Armed Forces.

Standing will be a life-sized male figure dressed in fatigues like those worn by the U.S. Army, Air Force and Coast Guard. Kneeling, will be a female figure dressed in fatigues similar to those worn by the U.S. Navy and Marine Corps. Rating and warfare badges will be obscured intentionally, so that the figures can represent anyone. A Labrador retriever, symbolizing the joy that family and friends have over the return of their service men and women, will be running joyously toward the veterans.

Artist Rip Caswell, famed for his portrayals of military themes and figures, will sculpt the statuary based on the concept conceived by Friends of the Veterans Monument. Welcome Home will represent the welcome that some never got, but which through the statuary will never end.

HISTORY OF THE EL DORADO COUNTY VETERANS MONUMENT

THE EL DORADO COUNTY VETERANS MONUMENT WAS FIRST ENVISIONED BY FORMER UNITED STATES MARINE, RICHARD W. BUCHANAN, DURING THE VIETNAM WAR, WHERE HE WAS AWARDED THE NAVY CROSS FOR UPHOLDING THE HIGHEST TRADITIONS OF THE MARINE CORPS AND THE UNITED STATES NAVAL SERVICES. ON MAY 24, 1968, AS 3RD BATTALION, 27TH MARINES MOVED AGAINST WELL-ENTRENCHED ENEMY PORCES DURING THE BATTLE OF LE BAC (1), BUCHANAN WITNESSED NUMEROUS EXAMPLES OF THE AMERICAN FIGHTING SPIRIT AND SELFLESS DEVOTION TO DUTY BY HIS FELLOW MARINES AND CORPSMEN. HE VOWED THAT THEIR DEDICATION, AND THE DEDICATION AND SACRIFICES OF OTHER MEN AND WOMEN OF OUR ARMED FORCES, WOULD NOT BE FORGOTTEN.
