Terms & Conditions

IN CONSIDERATION OF THE RENTAL OF THE EQUIPMENT AND SERVICES LISTED HEREON, ALLIANCE CRANE SERVICE (ACS) AND THE CUSTOMER NAMED BELOW AGREE AS FOLLOWS:

1. Except as otherwise mutually agreed in writing, this document is the complete agreement between ACS and the Customer, and supersedes all other agreements or understandings, written or oral.
2. An overtime rate of \$35.00 per man per hour is charged before 7:30 am and after 4:30 pm on weekdays, and for all hours on weekends. An overtime rate of \$55.00 per man per hour is charged for all holiday hours.
3. Customer will provide access to the worksite, and assistance at Customer's expense, when needed, in moving cranes and other ACS equipment in and out of the worksite. Since cranes and related equipment are heavier than some surfaces will support, ACS accepts no liability for damage to parking lots, road surfaces, yard/pasture damager, and underground installations.
4. Unless Riggers/Signalpersons are furnished by ACS, Customer is solely responsible for the rigging and signaling or any damages incurred because of improper rigging or signaling.
5. Slings and fittings are loaned to Customer by ACS, for the Customer's convenience, and solely at the Customer's risk. ACS makes no warranty whatsoever concerning the condition of such loaned equipment or its fitness for the Customer's application.
6. Customer will provide qualified personnel, when needed, to direct or flag the operation of ACS equipment, and agrees to use standard crane signals in accordance with 29 CFR 1926 subpart CC.
7. Customer assumes all responsibility and liability for the adequacy of design or strength of any lift points embedded in or attached to the load.
8. Time charged represents round-trip travel plus job time. For continued jobs, time will be charged to conform to Customer's regular workday (at least an eight-hour day).
9. Responsibility of payment of this invoice is guaranteed by Customer name below and is due in full upon completion of the job unless a pre-approved account has been established. All credit account terms are Net 30, unless otherwise approved. Customer agrees to pay interest of 10% per annum on this invoice if it is not paid within stated terms, plus cost of collections including reasonable attorney fees. Failure to abide by the stated terms and conditions may result in a credit account reverting to COD status.
10. Customer further agrees to indemnify ACS against all loss, damage, expense and penalty arising from any action on account of any injury to person or property of any character whatsoever occasioned by the operation, handling or transportation of any of the equipment during the rental period and while the equipment is in the possession or under the custody and control of Customer and warrants that insurance is in force to provide this protection.
11. Customer agrees to inform ACS if any contact information changes are made and will provide ACS with current and updated contact information within a reasonable time frame to ensure open communication.
