TRASH

The trash situation has become problematic. Each time there is an overage (any debris sticking over the top of the can) the Association is charged extra. Each time someone leaves large item of debris outside the dumpster or on the common elements, the Association has to arrange for a Junk Hauler to properly remove and dispose of items. Here are some facts that everyone should know:

- The trash collection company will not take large items. There is no bulk trash service at Cambridge. If you leave large items anywhere on the Common Elements, the owner of the unit will be issued an instant fine and charged to reimburse the Association all expenses incurred for handling the matter. You cannot place anything in the dumpsters/chutes except normal household trash. All household trash must be in a proper trash bag.
- On Mondays the dumpsters are always full. Please plan to utilize Wednesday or Friday as a trash day, as many times the dumpster are barely full on Wednesdays or Fridays.
- Please breakdown all cardboard boxes. Throwing away boxes without collapsing them first causing the dumpster to overflow and extra charges on the Association.
- If the chute is full or closed, please walk your trash to the next building and place down the chute. DO NOT PLACE HOUSEHOLD TRASH IN THE TRASH CANS BY THE MAILBOXES. DO NOT LEAVE THE TRASH INSIDE THE TRASH CLOSET.

POOL RULES

- If Security asks you to leave the pool, FOR ANY REASON- YOU MUST LEAVE THE POOL WITHOUT INCIDENT.
- NO glass or pets in the pool area.
- Properly dispose of your trash.
- All Children under 12 must be supervised by an adult over the age of 18.
- Please leave the bathrooms clean and sanitary.

DRYER VENT CLEANING

Dryer vent cleaning is the responsibility of the owner. You must be vigilant about keeping your dryer vent clean. If you have not had your dryer vent cleaned in the last 12 months, you MUST do this. Failure to do this will result in a fine, and possibly a fire!

PEST CONTROL

Please treat the inside of your unit for pests on a regular basis. The Association treats the exterior and the common areas, but it is important that the occupants continue to treat on a regular basis.

FLOOR REPLACEMENT

Please remember that it is required to submit approval to the Board to remove any carpet in your unit and replace with wood. YOU ALSO MUST have the proper underlayment installed to avoid future noise complaints. When in question about any improvement plans, please ask before you start.
