#### PHOENIX PD APP

The Phoenix Police Department now has a mobile APP, bringing a variety of resources and information to one place. Users can use the app to access online reporting, crime statistics, precinct locations, phone numbers, career opportunities, virtual block watch, victims' rights information, and more. Users can also turn on notifications from the precinct they live in to receive news updates and information on events in their area.

The APP is now available both in the Apple Store for iOS and in the Google Play Store for Android.

Report graffiti on the Phoenix PD app! Graffiti can now be reported on the Police Department APP released in January 2021. Studies show that if graffiti is removed within 24 hours, there is a 90% likelihood that the graffiti will not use the app to have it removed! #GraffitiFreePHX

#### WHEN YOU CALL 911 - KNOW THE 10 W'S

- What is your location? GIVE EXACT LOCATION
- What happened? WHAT TYPE OF CRIME?
- When did this happen?

These questions will determine if it is a priority call. Give as much of this necessary information as you can.

- Was anyone hurt?
- Weapons are there weapons involved?
- What manner did they leave or arrive foot, vehicle, bicycle...?
- Who did it? -Suspect description
- Where did the suspect go? What direction
- What did the suspect obtain? type and amount
- Who is calling? Give your name location and phone number (You can remain anonymous. If you do give your name, the info is redacted from the public record access.)

**TEXT 9-1-1** "Call if you can. Text if you can't." After months of collaboration between numerous public agencies and advocates for the disability community (or advocates for the disabled) if you are in imminent danger and are unable to talk to a 911 operator, you now have for the first time in Phoenix the ability to text to 9-1-1.

# WARM WEATHER SAFETY

With spring upon us and summer quickly approaching I wanted to take a moment and remind everyone of a few safety tips. The temperatures are rising and with that comes increased water intake and monitoring the amount of sun/heat exposure you get. Also, rising temperatures brings an increase in snake activities.

As we are now experiencing daytime temperatures in the 90s and rising it is important to also increase the amount of water consumed daily. Staying hydrated is one step in avoiding heat related illnesses. Also utilizing sunscreen when you are out in the sun to avoid health issues due to over exposure to the sun. If you are out in the heat, please remember to take breaks often in a location out of the heat. The City of Phoenix offers numerous heat relief stations, please refer to Phoenix.gov for update locations.

With the season changes there is also an increase in activity from snakes as they become more active. Keep an open eye and ear to listen for them to avoid a harmful encounter for you or the snake. If a snake is encountered there are several companies that will come and remove the snakes. If your encounter becomes negative and you are bitten, please seek immediate medical attention and contact poison control. By using these tips, it will assist you in having a great spring and summer while enjoying our Arizona weather.



#### NSD:

Mari said that the Love Your Block Grant will close on Monday, April 15<sup>th</sup>. She had Laura discuss her grant application on TNR for Community Cats which is the first of its kind. NSD has been working on the Greenway conveyance channel with CAOs Jeffrey and Jeremy by installing signage and locked gates.



#### **BRBA**:



Our Board Member, Greg is running for County Assessor and will be on the ballot in November! He talked about what is happening at Turf Paradise. The zoning has been approved 7 – 0. There are currently no buyers. Horse racing is continuing at this time with a limited season. The 343-unit apartment complex across the street from Turf Paradise on 19<sup>th</sup> Avenue will start construction soon. More

building in the area is in the works, too. A third chip plant is coming to Phoenix. Water conservation is being promoted in new construction. The BRBA is supporting Starfish Place, a facility helping women with children who have been victims of sex trafficking, which is located on 19<sup>th</sup> Ave. north of Bell Road.

#### **AZ STATE REP:**

Judy reported on the Arizona Legislature. She voted on 109 bills last week, including Animal Cruelty and Gun Show sales. With the AZ Supreme Court ruling on abortion,



they are trying to put this on the ballot in November, so if anyone wanted to sign a petition was available and also a sign-up sheet for her newsletter. She taught at Greenway High School for 27 years.



## **Black Mountain Precinct Updates**



Cmdr. Matt Siekmann talked about the officer involved critical incident at 17th Avenue and Bell Road. Our Officer Sean is recuperating in the hospital after being stabbed in the neck. Due to the heroic help of the security guard and another man, who stopped the suspect and held him down until PD arrived, Officer Sean's life was saved. They deserve to be commended. The suspect had recently been arrested for gunshots at 7th Street &

Bell Rd. but was released. The police can only do their part and cannot control the courts. There have recently been too many attacks on our officers. The Final Four Event was incident free due to the work of our police department. Violent crime is down 3% and Property crime is down 20% in Black Mountain Precinct. The next Coffee with Cops will be at Biscuit's Café on Thursday, April 25<sup>th</sup> at 8:30 am. Jordan asked about the shots fired at 21<sup>st</sup> Avenue and Wahalla Lane by the park. A vehicle was hit and a report was taken.



#### **BLIGHT AND ZONING LAWS**

STRUCTURES: The maintenance of a home is the responsibility of the property owner. Any wood, siding, shingles, roof covering, railings, fences, walls, ceilings, porches, doors, windows, screens, and other exterior parts of any structure on the property must be maintained in weather tight, sound condition and in good repair. The property owner is responsible for making sure there are no doors or windows left open and not secure to the outside. FOR HELP call the Preservation Division of the Neighborhood Services Dept. at 602-495-0700 to see if you qualify for a free Grant!

**OUTDOOR STORAGE:** All outside storage that can be seen from the street should be inside sheds or cabinets. Items should not be set in car ports in view of the street. Please use enclosed areas or backyards.

**JUNK, TRASH & DEBRIS:** Junk, trash and debris cannot be left in the yard or car port and must be properly disposed of. This includes junk auto parts, appliances, furniture, building and/or landscaping material, trash such as discarded papers, cardboard, plastics, etc. including tree trimmings and fallen limbs or any other items that appear to have been discarded. The only exception is during the Bulk Trash Collection weeks four times a year.

**PARKING:** Parking is only permitted for passenger cars and motorcycles on residential streets, on driveways or in garages. A driveway or parking area must be constructed with an approved dust free parking surface. The stone must be 1/4 -3/4 in size with a permanent border holding it in. 1/4 minus size stone is not allowed for parking. There are limits to the amount of front yard area that can be used for parking. Only 35% of the front yard may be converted to driveway or dust free parking.

**GRASS AND WEEDS:** Grass and weeds must not be allowed to grow over 6 inches high due to fire hazard, allowing the weeds to go to seed and spreading throughout the neighborhood and insect infestation.

**ELIMINATE GRAFFITI:** Keeping the neighborhood graffiti free is something we can all do. If there is graffiti on your property, please remove it as soon as possible. The Graffiti Busters Program provides paint, supplies and training to assist groups with eliminating graffiti. The City will also remove the graffiti from private property with written permission from the property owner. Call 602-495-7014.

# CRIME TIPS:

# FRAUD CONTINUES AT HISTORIC LEVELS

The numbers are in, and 2023 was another record-breaking year for fraud.

According to the Federal Trade Commission's <u>2023 Sentinel</u> <u>Data Book</u>, reported theft through fraud topped \$10 billion. The rise from \$2.4 billion in 2019 – before the pandemic — is a staggering 317%.

While these numbers illustrate that fraud continues to soar across the U.S., they only reveal a fraction of actual theft from fraud, since the crime is notoriously underreported.

More than anything, the report shows that nobody is immune to fraud, a threat that continues to evolve in both scale and sophistication.

#### **IMPOSTOR SCAMS STILL ON TOP**

Over 850,000 consumers reported experiencing impostor scams, with 1 in 5 suffering financial losses.

In these prevalent scams, criminals pretend to be a trusted person, company, or government agency — a bank, known business, celebrity, or a relative in trouble. They convince the target of some untruth to coerce them into making a financial transaction or sharing information that allows the criminal to access and wipe out financial accounts.

#### THEFT THROUGH INVESTMENT SCAMS SOARED

Investment fraud victims reported theft of a staggering \$4.6 billion, surpassing all other types of fraud. Reporting victims in this category experienced median losses of \$7,700.

Many of these scams involve <u>cryptocurrency fraud</u>, which has taken a quantum leap in recent years, where it is used both as a form of payment and as the commodity of choice in sophisticated investment schemes.

#### **CRIMINALS KNOW NO BOUNDS**

Most people believe that scams only happen to older adults. The reality is that younger people report losing money to fraud more often, with 44% of reports coming from those age 20-29. But when older adults are the victim, they lose so much more.

Email was the most popular contact method reported. However, social media-based scams led to the highest reported overall dollars stolen, and phone calls resulted in the highest amount stolen per victim.

It is more important than ever to stay up to date on the latest scams and share what you know to help protect others.

# IS THAT YOUR FAVORITE CELEBRITY OR AN IMPOSTOR?

Celebrities often flood our social media with their presence, sharing snippets of their lives and careers. But if you get a direct message out of the blue from a favorite musician, actor or athlete, don't get starry-eyed, get skeptical — it's almost certainly a scam. Here's what to know.

#### **HOW IT WORKS**

You follow your favorite celebrity on their social media accounts and post messages.

One day, your post elicits a response from the celebrity or someone representing them!

They may tell you that super fans like you can get special access to the celebrity or to a meetup, or that they are fundraising for their favorite charity.

#### WHAT YOU SHOULD KNOW

The special attention you get as a fan is most likely not from your favorite celeb, but rather a criminal impersonating them or someone close to them.

The reasons for reaching out may vary, but the end goal is the same — they want to steal your money by convincing you of something that is untrue and then providing instructions on how to send money.

The method of collecting funds will likely be something unusual, like buying gift cards and sharing the numbers off the back, or taking cash to a cryptocurrency ATM and sending it that way.

#### WHAT YOU SHOULD DO

Have fun following your favorite celebrities on social media, but know that posting to those accounts could result in a fraud attempt against you.

Know that scam criminals use our emotions against us; in the case of connecting us to our favorite celeb, it's excitement. These emotions make it hard for us to access logical thinking.

Anytime a contact puts you into a state of high emotion — excitement, or panic, for example, let that be your signal that it's likely a scam and to disengage.

Report online celebrity impersonators to the social media host.

Knowledge gives you power over scams. The <u>AARP Fraud Watch Network</u> equips you with reliable, up-to-date insights and connects you to our free fraud helpline so you can better protect yourself and your loved ones. We also advocate at the state, federal and local levels to enact policy changes that protect consumers and enforce laws.



#### **SWIMMING POOL SAFETY TIPS**

Pool season is in here, so take these steps to keep your park visitors safe this summer:

- Remove toys and floats from the pool immediately after use; they can attract children.
- Always assign a designated watcher for children in and around the pool.
- Make sure there is a self-closing gate around your pool, and always keep it maintained.
- 4. Gates and fences around the pool area should be at least 4 feet high.
- All pools should have regulation drain covers; discuss local regulations with your pool maintenance provider.
- Keep a fully stocked first aid kit and rescue equipment near your pool area.
- Never swim alone.
- 8. Learn to perform CPR on both adults and children.
- Post pool signs in prominent locations and make sure they are easily seen and read.
- 10. Inspect pool areas for slipping hazards and install safety tape as a precaution.

This is done by utilizing a key that you provide in a secure lockbox attached to your entryway.

The Phoenix Area Association of Realtors, in coordination with Councilwoman O'Brien, has generously provided 100 lockboxes to be installed FREE of charge for city of Phoenix residents. The available lockboxes will be distributed on a first come, first served basis to Phoenix residents with special needs, and mobility issues ONLY.

Your information and the code to the lockbox is provided only to firefighters in the event there is an emergency call to your home. You will need to provide the appropriate key or keys to put in the lockbox at the time of the delivery.

#### National Fentanyl Awareness Day is May 9

#### Maricopa County continues to see dramatic rise in prosecution of fentanyl-related cases

(Phoenix) - In Arizona, an average of five people die every day from an opioid overdose according to the Arizona Department of Health Services.

Meantime, Arizona continues to be a swift-growing importation hub for the drug. According to the Drug Enforcement Agency (DEA), 28 million fake prescription pills containing fentanyl were seized in Arizona in 2022, nearly half of all pills seized nationwide. In just the first four months of 2023, the DEA has already seized 25 million pills, which places our state well on-track to surpass last vear's numbers.

On this <u>National Fentanyl Awareness Day</u>, Maricopa County also continues to witness the dangerous, destructive effects of this drug. Here, the number of opioid-related overdoses has risen by more than 5000% since 2015.

Since the Maricopa County Attorney's Office (MCAO) began electronically tracking the number of fentanyl cases submitted for prosecution in the latter half of 2020, the upward trend has been unmistakable. In 2020, 923 cases were submitted for prosecution; by 2022, the number jumped to 6,629. In the four months of 2023 so far, MCAO has already received 2,432 submittals; if that trend continues, 2023 will be another record-setting year.

As too many families already know, illicit fentanyl continues be to used to make fake prescription pills - sometimes laced with cocaine, heroin, or even a veterinary tranquilizer - that can, in some cases, cause death with a single

"I've spoken one-on-one with parents who have lost their kids to this poison. It is gut-wrenching to hear them talk about having a conversation with a child one evening, only to find that child gone the next morning," said Maricopa County Attorney Rachel Mitchell. "We will keep prosecuting these cases and continue to get this information in front of parents and the public.'

"The fentanyl issue is personal to me because it is ripping families in my district apart, taking the lives of kids that are the same age as mine, in some cases. That's why I promised to put significant county resources into keeping this dangerous drug out of our neighborhoods and punishing those responsible for bringing it here," said Maricopa County Board of Supervisors Chairman Clint Hickman, District 4. "I applaud County Attorney Mitchell for being an active and committed partner in not only prosecutions, but education.

This summer, heat relief centers across Maricopa County will be equipped with new dog shoes and water bowls to help keep hundreds of dogs healthy and safe, thanks to funding approved by the Board of Supervisors on March 13.

This initiative supplements a multi-partner, county-wide heat preparedness effort already underway to prevent another summer of record-breaking heat deaths. From May 1 to September 30, emergency cooling centers and water distribution areas will be established at various community centers, churches, and community organizations to provide refuge for those who lack access to indoor, cool environments.

The purchase of these dog supplies is being funded using \$8,000 of Maricopa County Community Solutions Funding allocated by Supervisor Galvin through October 31, 2024. The Board of Supervisors' Community Solutions Funding is designed to help advance Maricopa County's strategic goals and provide clear public benefits for Maricopa County residents.

## MARICOPA COUNTY SUPERVISORS TO CONSIDER NEW RULES FOR PUBLIC MEETINGS

## Resolution Establishes Rules of Decorum

Maricopa County is taking additional steps to ensure the people's business gets done in a civil and orderly fashion during public board meetings. On April 10, the Board of Supervisors will consider a resolution to establish formal rules of decorum at public meetings. These rules, if adopted, will give



members of the public clear guidelines about how to participate and express opinions on agenda items in a respectful and productive way. Attendees who don't follow the rules may be removed from meetings.

"Unfortunately, we've had an escalation in disorderly and disrespectful behavior at board meetings," said Chairman Jack Sellers, District 1. "We encourage and appreciate public comment when it is respectful and on topic. But we are not going to allow distractions from real discussions on policies, programs, and initiatives that impact all 4.5 million Maricopa County residents."

#### PUBLIC MEETING RULES AND DECORUM

While most of the rules outlined in the April 10 resolution simply formalize current practices, a few represent new protocol.

#### Proper decorum includes:

- Refraining from any loud, threatening, profane, abusive, personal, impertinent or slanderous utterance that disturbs, disrupts, or otherwise impedes the orderly conduct of the meeting.
- Not holding up signs, placards, or banners that distract or disrupt from county business
- Remaining seated except when called upon by the Board Chairman or exiting

The resolution also sets rules for public comment. Attendees are limited to speaking on a maximum of two agenda items as well as the "call to the public" near the end of the meeting.

#### Speakers must:

- Submit a speaker request form no later than 10 minutes following the formal beginning of the meeting
- Address only items on the agenda or issues directly under the Board's authority
- Limit their comments to two minutes per item

If adopted, these rules will be posted inside the Auditorium and on the county website, <u>Maricopa.gov</u>.

#### SECURITY CHANGES

Last month, the Board implemented new security measures at public meetings that had been recommended in a Threat Assessment report from

Maricopa County Sheriff's Office, Maricopa County Security Services, and other partners. On April 10, additional recommendations from that Threat Assessment will be evident inside the Board of Supervisors Auditorium. These include a different location for the speaking podium used during public comment and a barrier separating staff seating from public seating. Members of the public will still need to go through metal detectors before entering the auditorium.

Since 2020, board members have been subject to numerous recorded and written threats, part of a larger trend of violent rhetoric against public servants.



#### **COMMUNITY CATS**

Helpful Information and Tips for the Community

A Community Cat is a catch-all term often used to describe any outdoor cat that may appear to not have an owner. Feral cats, which are under- or not

socialized, fall under this umbrella, as do free-roaming, friendly cats.

In Maricopa County, cats are not subject to the same licensing and leash laws as dogs. Because of this, Maricopa County Animal Care and Control (MCACC) cannot pick up stray or feral cats or take action against those feeding cats in their neighborhoods.

Many times, members of the community act as colony managers to ensure that a feral cat colony is a managed colony. Cats in these communities are usually fed, watered, vaccinated, spayed, or neutered, and monitored for overall health. Other times, the cats are self-reliant and can survive in the neighborhood on their own, without any direct assistance.

#### TNR

TNR (Trap-Neuter-Return) is a long-proven and effective method for humanely addressing community cat populations across the world.

Trap: The cats are humanely trapped and brought to a clinic.

**Neuter**: The cats are fixed, vaccinated, and their left ear is "tipped" to indicate they have been fixed.

Return: The fixed cats are safely returned to their colony.



#### **Benefits of TNR**

- Cats become better neighbors as it reduces or eliminates unwanted mating behaviors (e.g., yowling, fighting, spraying).
- Cats will be healthier when treated with this humane solution and typically are less likely to wander from their food source.
- Halts the breeding cycle which allows community cat populations to stabilize and eventually decline.
- Protects and respects cats' lives.

#### How to Help Keep Community Cats Away from Your Property

- Remove or secure all potential food and water sources from your property, including dog food.
- $\bullet$  Spray concentrated orange juice or hang orange or lemon peels in areas where cats are spraying cats do not like the citrus scent.
- Keep all trash and recycle bins tightly closed as cats are considered opportunistic feeders/hunters.
- Use a motion-detecting device that turns on a sprinkler or bright light in response to motion on your property, such as ScareCrow™.
- Remove or secure potential shelter areas secure access under houses, sheds, decks, porches, and buildings with wire fencing.
- Use plastic carpet runners spike-side up and covered lightly in soil to prevent cats from digging in your garden.
- Keep landscaping trimmed to avoid creating hiding/nesting spots.
- Spread dried wild animal manure in the areas you notice feral cats in your yard; wild animal urine also may work to deter the cats.
- There are also many commercial cat repellants (chemical and non-chemical options) available in garden stores, pet shops, and online.

#### Permit Test @ Home



Teenage Arizona drivers who need to take the written driver test to get an Instruction Permit can now take that test online with appropriate supervision.

Permit Test @ Home is available for parents or legal guardians to administer utilizing their free, personalized account on AZ MVD Now (azmvdnow.gov).

Note: Teenagers' accounts cannot be used for taking the test. The parent or legal guardian must have the account.

#### Steps for the parent or legal guardian:

- Login or create your AZ MVD Now account
- Verify your identity
- Complete your teen's information
- Pay the \$7 application fee
- Supervise the test

#### Permit Test @ Home

Participating Arizona Professional Driving School trainers can also administer the test on behalf of the parent or legal guardian.

It is recommended that teens study the Arizona Driver Manual and take the online practice tests before attempting the Permit Test @ Home.

Note: Currently, Permit Test @ Home is offered only to teenagers under 18.

#### Getting the permit after passing the test:

- With the teen's AZ MVD Now account, schedule an MVD office appointment at AZ MVD Now or visit an Authorized Third Party Driver License Provider.
- Bring a completed application and all original supporting documents.

People experiencing a mental health crisis have a new way to reach out for help in the U.S. They can simply call or text the numbers 9-8-

Modeled after 911, the new three-digit 988 Suicide & Crisis Lifeline is designed to be a memorable and quick number that connects people who are suicidal or in any other mental health crisis to a trained mental health professional.

"If you are willing to turn to someone in your moment of crisis, 988 will be there," said Xavier Becerra, the secretary of the federal Department of Health and Human Services, at a recent press briefing. "988 won't be a busy signal, and 988 won't put you on hold. You will get help."

The primary goal of the new number is to make it easier for people to call for help. Lawmakers and mental health advocates also see this launch as an opportunity to transform the mental health care system and make care easily accessible everywhere in the United States. The Biden administration has invested more than \$400 million in beefing up crisis centers and other mental health services to support the 988 system.

# SHOULD YOU SHARE YOUR LOCATION WITH YOUR PARTNER?

Every relationship has its disagreements. Who takes out the trash and washes the dishes? Who plans the meals and writes out the grocery list? And when is it okay to start tracking one another's location?

Location sharing is becoming the norm between romantic partners—50% of people valued location sharing in their relationships, according to recent research from Malwarebytes—and plenty of couples have found ways to track one another's location, with consent, in a respectful and transparent way.

But, as a cybersecurity, privacy, and identity protection company, Malwarebytes is concerned with risk, and location sharing carries significant risks within many types of relationships.

There are new relationships in which the rules around privacy and sharing are still being agreed upon, old relationships in which power imbalances are deeply entrenched, and, of course, abusive relationships in which non-consensual tracking and surveillance are used as levers of control.

As a company—and not a relationship counselor—Malwarebytes cannot endorse any reasons for location sharing between romantic partners. But Malwarebytes can provide guidance on what safe location sharing looks like, including a requirement for consent.

Importantly, Malwarebytes can also remind readers about one simple, oftenforgotten fact in this conversation: You don't have to engage in location sharing if you do not want to.

It really is as simple as that. Do not agree to location sharing in your relationship if:

- You are being pressured, coerced, or harassed into sharing your location.
- You do not trust or feel comfortable sharing your location with your partner.
- You do not want to.

As the reasons for location sharing are valid for many couples, the reasons against it are just as valid, too. You have the right to determine the rules in your own relationship, and that includes the digital decisions that impact your feelings of privacy, safety, and trust.

#### SAFETY, SECURITY, AND CONVENIENCE

According to research conducted last year by Malwarebytes, <u>location tracking among partners is popular in North America</u>—and even more popular amongst younger generations.

When polling more than 1,000 people about their attitudes and behaviors around online privacy and cybersecurity, a full 50% agreed or strongly agreed with the statement that "monitoring my spouse's/significant other's online activity and/or location makes me feel they are safer."

Similarly, 42% agreed or strongly agreed with the statement that "being able to track my spouse's/significant other's location when they are away is extremely important to me." This sentiment was higher amongst Gen Z—49% felt the same way compared to the general population.

As to why location tracking has become so popular, there is little doubt. It's about safety (or, at least, the feeling of it).

On Reddit, the question of location tracking between partners is frequently posed and is <u>just as frequently answered</u>: "I think it should be fine for safety reasons," said one user in a the most popular response to a thread.

In writing for the media platform Her Campus, one Pennsylvania State University student said that, if she already shares her location with her friends for safety, "why would I not share it with someone I am involved with romantically?"

For some of the <u>editorial staff at the healthy living brand Poosh</u>, location sharing also provided convenience.

"If I want to call my boyfriend for something, sometimes I'll check his location first (if he's at the office, for example, I won't call)," wrote Erika Harwood, managing editor. "Or if he tells me he's on his way home and it seems to be taking unusually long, it's easier to just check his location and see if he's stuck in traffic."

Harwood continued:

"Basically, it all boils down to me trying to eliminate as many phone calls from my day as possible."

What these explanations all share is purpose and consent. The people featured here have told their partners about location sharing, and they have identified specific reasons to engage in this practice. Because of this, these situations are hardly cause for alarm.

What Malwarebytes hopes to draw attention to, however, are starkly different situations.

#### COERCION, CONTROL, AND CRISIS

Location "sharing" implies two partners who consensually share their locations with one another. But as Malwarebytes discovered last year, location "sharing" isn't the only activity that some people engage in—it's also location spying.

According to the same survey last year, 41% of all people admitted to monitoring their partner in some way without their partner's permission.

That includes 16% of people who non-consensually "tracked my spouse's/significant other's location through an app or Bluetooth tracker (like Apple AirTags, Tile, Find My)" and 13% who non-consensually "installed monitoring software/apps on spouse's/significant other's devices (e.g., Life360)."

The harms here are obvious.

Non-consensual location tracking in a relationship is a clear invasion of privacy. It puts sensitive information into one partner's hands without the other partner knowing it, and the nature of the information itself can be used to harass and stalk someone—especially after a breakup.

Non-consensual location tracking is also present in domestic abuse, particularly in instances where one partner is being spied upon with the use of "stalkerware" apps. And while those who deploy these types of invasive apps are not guaranteed to be physically abusive against their partners, several documented cases highlight the risk.

As Danielle Citron, professor of law at UVA, wrote back in 2015 about what she called "cyber stalking apps":

"A woman fled her abuser who was living in Kansas. Because her abuser had installed a cyber stalking app on her phone, her abuser knew that she had moved to Elgin, Illinois. He tracked her to a shelter and then a friend's home where he assaulted her and tried to strangle her. In another case, a woman tried to escape her abusive husband, but because he had installed a stalking app on her phone, he was able to track down her and her children. The man murdered his two children. In 2013, a California man, using a spyware app, tracked a woman to her friend's house and assaulted her."

These cases may sound extreme, but they should not be ignored. They reveal that it isn't location sharing itself which is harmful, but rather that harmful relationships will lead to harmful forms of location tracking.

Be sure that, if you do engage in location sharing, it is with someone who you trust, on both of your agreed terms, and in a way that you can turn off the location sharing at any point in the future.

#### WHAT'S THE ANSWER?

Your real-time location is extraordinarily sensitive information, and as such, access to it should be understood as a privilege, not a right. No romantic partner has a "right" to your location just because their previous partners practiced location sharing. No romantic partner should coerce or harass you into location sharing. And no, the refusal to share your location, at any stage of the relationship. is not a "red flac."

If you do decide to share your location with your partner, be sure to follow these quidelines:

- Have an open conversation about location sharing with one another. You must obtain consent from your partner if you're going to share your locations. Spying on your partner's location without their consent is a breach of trust.
- Have a reason why you're engaging in location sharing. Many problems in a relationship will not be solved by location sharing. Have a firm reason why you want to share locations and what value it will provide. If you do not have a good reason, you may not need location sharing at all.
- Set up rules about location sharing. Location sharing can be enabled on a case-by-case basis for, say, music festivals, vacations, or solo hiking trips. It can also be enabled between partners indefinitely.
- Check in periodically about whether it is working. Just because you agreed to location sharing a year ago does not mean you cannot revisit the topic. See how location sharing feels and then see if you still want it later in your relationship.

As every couple has their own rules and behaviors for success, there is no single answer to whether you should share your location with your partner. You know your partner—and yourself—best to answer this question. Be safe, whatever option you choose.
