**Subject: Customer Notification of Change
WALOCCEL™ CMC brand name changing to TEXTURECEL™ CMC in 2021**

Dear Valued Customer,

In 2019, DowDuPont officially completed the separations of its Agriculture, Material Science and Specialty Products divisions into three independent, publicly traded companies: Corteva, Dow and DuPont. We appreciate your patience as we have orchestrated the necessary changes related to these separations and wanted to make you aware of an upcoming trademark decision for our business.

The WALOCCEL™ Sodium Carboxymethylcellulose (CMC) brand, as of April 1, 2021, will be fully owned by Dow. Therefore, DuPont Nutrition & Biosciences will transition this brand from WALOCCEL™ CMC to TEXTURECEL™ CMC. We expect to complete this transition by the end of first quarter of 2021.

What is Changing

Documentation

We will begin this transition soon, so you may start receiving product labeled with TEXTURECEL™ Sodium Carboxymethylcellulose with the following accompanying documents with the new brand name as early as January 2021:

- MSDS (Safety Data Sheet)
- Invoice
- Certificate of Analysis
- Order Acknowledgement
- Packing Lists
- Quality Agreements
- Certifications and Declarations
- Marketing Collateral

For a period of time and until existing inventories are depleted, you may receive both the WALOCCEL™ and TEXTURECEL™ materials, even in the same delivery.

Our Kosher and Halal certifications will be updated with the new brand.

After: TEXTURECEL™ 30000 PA Sodium Carboxymethylcellulose 25 KG Bag, 40/pallet

What is Not Changing

Please note that our CLEAR + STABLE™ Sodium Carboxymethylcellulose branded products are not impacted by this change.
