BADGER BOYS STATE: A RECIPE FOR CHANGE

Over the years, we at Badger Boys State have taken the time to tell you about the various goings-on within and because of-our organization. It's hard to quantify our impact in numbers and words alone. We can, however, offer a bit of a recipe for how we bring about lasting change in the lives of Wisconsin's brightest young men.

It begins with who is on our staff. A successful blend of former Boys Staters who experienced the program and went on to various career paths, and Legionnaires who served their nation in addition to their life's work come together to lend their time and skills to a successful program. If any citizen has a question about



any career path, be it law, medicine, industry, business, education, or the military, there is likely a staff member they can talk to.

Another ingredient in our magic is conversation. Right away as citizens arrive, we greet them and make them feel welcome. While many of the young men who arrive have seen local Veterans in parades, school assemblies, and brat fries, this is likely their first opportunity for an extended conversation with a Veteran aside from a family member. We are always pleased to see how respectful the young men are right off the bat. As the week continues, we reiterate the importance of respect, healthy conversation, and learning from each other.

The next powerful ingredient is teamwork. We show early on that democracy is a team effort. From the introduction games we play at the beginning, to our government simulation, to the sports and recreation in the afternoon—the citizens are always working together for a common cause. It prepares them best for how the world works—sometimes to our frustration. While their lanyards distinguish their fictitious political party, the fact they're all wearing the same shirt emphasizes that they're on the same team.

The most important ingredient is learning by doing. Since its beginnings in 1939, Badger Boys State has taught our state's young men by letting them exercise the lessons they're learning in a fake simulation of government. Campaigning, making a speech, budgeting both their own (and taxpayer) dollars, are all shaping their understanding of the world. In fact, the best teaching aspect of the simulation is allowing the young men to fail. Take it from me-allowing the young men to fail safely is perhaps the best tool we have in creating lasting life lessons.

As always, we invite all Legionnaires to Eau Claire to join us in changing lives. It is amazing how watching this transformation over one week can fill the heart with hope.

ORATORICAL CONTEST SLATED FOR MARCH 23 AT RIPON COLLEGE

The 87th Annual High School Oratorical Regional and Finals Contest is scheduled March 23, 2024 at Ripon College in Todd Wehr Hall. Opening ceremonies begin at 9 a.m. The contests began at the post level, then advancing to the county and the district level. The district winners will participate in the Regional contest on March 23 in the morning. The winners of the regional contests will participate in the Finals contest the same day at 12:45 p.m. The contestants are competing for scholarships. The winner of the Finals contest will represent the state of Wisconsin at the National Oratorical Contest May 17–19, 2024 at Hillsdale College in Hillsdale, Michigan.

This is a great opportunity for Legion Family members to attend a great event that features talented high school students who have worked very hard to present their orations. Each contestant will present two orations. The first being a prepared 8to 10-minute oration about the U.S. Constitution. Their second oration consists of a 3- to 5-minute oration on a randomly assigned constitutional topic. There are 4 assigned topics, and because they are randomly selected by the Oratorical Chair at each contest, students must be prepared to speak on all of them.

WELLER WINS JEFFERSON AWARD FOR VOLUNTEER EFFORTS

Bob Weller, Past Commander of the Wausau American Legion Post 10, was recently honored at the Jefferson Awards Annual Banquet at the Jefferson Inn on November 16, 2023. He was one of the twelve honorees from the past year who were presented the award by Master of Ceremonies Melissa Langbehn and Justin Loew from News 9 WAOW.

News 9 WAOW and their partner Sparhawk Trucking are the sponsors of the monthly Jefferson Awards and the hosts of the annual event. The Jefferson Award program was created to recognize the volunteers who do extraordinary things in their community without expectation of recognition or reward.

Some of Bob's accomplishments which lead to him being awarded the Jefferson Award include his leadership at the Wausau American Legion Post 10 that played a major role impacting the post and the entire Wausau community.

He expanded the Legion's Veteran meal delivery program. In the past four years volunteers delivered over 5,200 meals to hundreds of Veterans, widows and their families. The meals are prepared by Bunkers restaurant and cookies, candies and pies are donated by area businesses and organizations. Thank you cards were created by young adults from

various organizations. The overall satisfaction of the Veteran meal program is echoed in the numerous calls and thank you notes.

Bob was contacted by two area foundations who had seen the work the post had done with their Veteran meal program. These two foundations and others donated funds that enabled the purchase of a vehicle for the post and Honor Guard. A post vehicle was needed to transport rifles, flags, and support items to the funeral homes, churches and cemeteries when preforming Military Rites for fallen Veterans. The Post Honor Guard provides an average of 70 Military Rites annually.

Bob initiated the Veterans Avenue Honor Banners that display the Veterans' photos, dates and icons relating to their service connection along Grand Avenue from Memorial Day to Veterans Day. The Veterans and their families are also honored during the Memorial Day ceremonies at Restlawn Cemetery.

Bob has a very creative mind and the ability to work well with businesses, our community and members of the American Legion. His actions will be felt for years to come by Veterans and their families ... his leadership is hard to match ... and the lives he has impacted can never be counted!



LARSONS' TOYS FOR TOTS DONATION GIVEN IN MEMORY OF CHILDREN, GRANDCHILDREN




On Friday, December 1, Tom and Deb Larson pulled up to Legion Headquarters' front door with a trailer full of over 650 toys for Toys for Tots.

The American Legion Americanism and Government Scholarship Program Department of Wisconsin



To promote "Americanism", love of country, knowledge of government and allegiance to the U.S. flag to our youth. Eligible students are tested on their knowledge of U.S., Wisconsin and Country Governments, the U.S. Constitution and flag etiquette.

What Is It?

The test consists of 50 questions; true/false, multiple choice, matching, and an essay question that must be answered in order to qualify for the scholarships. Students are not allowed to use outside resources for answers while taking this test.



Who Is Eligible?

Any student in the 10th, 11th, or 12th grade in any public, private, parochial or home-schooled within the State of Wisconsin may participate. Students may only take the test 1 times per year; however, students may participate all 3 years and be eligible for the scholarships for multiple years.

The test is available on-line in March through March 15, 2024. Students Register on-line when taking the test. The test link is found at:

The link is only active during the test window.

Annually, 33 students throughout the State of Wisconsin are awarded scholarships selected by the Americanism Committee of The American Legion, Department of Wisconsin. The following scholarships are awarded:

11 students in Grade 10 receive a \$250 scholarship

11 students in Grade 11 receive a \$300 scholarship

11 students in Grade 12 receive a \$750 scholarship

SELECTIVE SERVICE SYSTEM IN NEED OF LOCAL BOARD MEMBERS

The Selective Service System (SSS) is a trusted and engaged national defense partner in support of the U.S. National Defense Strategy and our all-volunteer military in the event of a national emergency.

1. Registration rate needs to be improved for 18 - 25-yearold males in Wisconsin. Currently only 76% of Wisconsin's young men are registering. Please remind our male youth to register at https://www.sss.gov/.

2. Volunteers are needed to fill the positions of Local Board

Members (LBM) around the Badger State. We especially need LBM in the following counties: Ashland, Barron, Bayfield, Calumet, Clark, Douglas, Florence, Forest, Green, Green Lake, Iron, Jefferson, Lafayette, Langlade, Lincoln, Marinette, Marquette, Rock, Sawyer, Shawano, Taylor, Vilas, and Washburn. Please help get the word out with your Legion Family and communities.

Individuals who meet the following criteria would qualify as Local Board Members:

• Be a citizen of the United States and at least 18 years of age.

- Males must have registered with the Selective Service (Men born in March 1957 thru December 1959, and March 1975 thru June 1980 are exempt.).
- Cannot be an active or retired member of the Armed Forces or Reserve/National Guard.
- Conviction of any criminal offense disqualifies a person from being a board member.



RED ARROW VETERAN AWARDED PURPLE HEART MEDAL POSTHUMOUSLY

Legion Post 60 member, accepted the Purple Heart medal at a ceremony held at the Outagamie Courthouse on November 11 on behalf of his late grandfather, Pvt. George C. Arts.

Pvt. Arts, member of Company I, 127th Infantry Regiment, was wounded August 4, 1918 during the Second Battle of the Marne. The 32nd Division, composed of Wisconsin National Guard and Michigan National Guard Soldiers, had just arrived from the trenches of Alsace, Germany, to be a part of the assault on the heavily fortified town of Fismes. Pvt. Arts was one of thousands of Division Soldiers wounded in the assault by machine gun fire and artillery shells. He suffered a fractured left knee and a bullet wound to his right hip. In August 1920, he was honorably discharged at Ft. Sheridan Illinois with a medical rating of poor.

At that time, the U.S. military did not issue Purple Hearts for battlefield

Mike Muthig, Wisconsin American injuries. Pvt. Arts was authorized to wear the American Expeditionary Force wound chevron to indicate that he was wounded in combat. The Purple Heart was reinstated in 1932. Pvt. Arts continued to suffer from complications of his wounds and died on December 10, 1928 at the age of 35.

> Upon finding out about Pvt. Arts' story, Congressman Mike Gallagher became involved and after contacting the U.S. Army Human Resources Command, was able to confirm Arts' eligibility for the Purple Heart medal.

> Command Sgt. Maj. Ryan Johnson, the current senior enlisted leader of the 2nd Battalion, 127th Infantry Regiment, presented the medal to Muthig at the ceremony. Johnson is also a Purple Heart recipient for wounds suffered during his deployment to Iraq in 2004-05.

> The Fox Valley Veterans Council also presented Pvt. Arts' family with a replica of his wound chevron.

Greetings Legion Family,

February 3, 2024, marks the 81st anniversary of the sinking of the USAT Dorchester that claimed the lives of 674 people to include the four chaplains that were aboard the ship when it sank. These four chaplains are celebrated and remembered each year by many different organizations and groups to include our own organization. For their bravery and the unselfish acts they took

to save lives, only to lose their own on that dreadful night.

Some of you may be doing your very first Four Chaplains service in 2024, and others of you may have been doing them for years. If you plan on performing a Four Chaplains service in February 2024, please follow the following guidelines.

- 1. If you plan to place Bibles and or crosses on your display table, only place them in front of Chaplain George Fox, Chaplain Clark Poling and Chaplain John Washington. These are the three Protestant chaplains.
- A. Do not place a Bible or cross in front of or behind Rabbi Alexander Goode, he is the sole Jewish Chaplain.
- 2. Some alternatives for Rabbi Goode would be a six-point star also known as the Star of David, a copy of the Jewish Prayer Book from World War II. Copies can be found on eBay for sale, or a symbol of the collar brass that he would have worn as a Jewish Chaplain, (The tablet of the Ten Commandments with the star of David on top).

Remember it is about respect. WHY SO STOIC?

I just finished attending Midwinter conference. I had several conversations with or about Veterans who refuse to ask for what they deserve. The usual reasons were heard, there are more deserving or needy Veterans then I,

I have good insurance through work, I don't need any benefits, and the litany continues. This stoicism is a habitual problem that requires added consideration.

I have helped far too many Veterans who have waited decades and family members of Veterans who never filed for their benefits. The amount of added care, not to mention the dollars in the home, that went unrealized is staggering to perceive. I have spoken to Veterans about the benefits for which they qualify and received the answer that they are well enough off, leave it to those who are really in need. I often successfully try to convince them to submit for their due benefits. Thus, I am writing this now. To convince those that have not connected with their local Veterans service office to see what they may have due to them or their family. I am also reaching out to those who have benefits in place that may not be aware that those benefits may deserve an increase. As service-connected disabilities get worse over time, the VA may find you rate a higher compensation amount.

Often, to convince a Veteran to get their due benefits it is with their legacy. I mention their obligation to family or the good of their community. I inform them that every benefit now will help their spouse when they leave this world. If the benefit is for a condition that may cause their demise, having the issue accepted as service-connected prior will make things easier for their spouse to get their own benefit. When I run into Veterans that have set themselves up for success that do not have family, I speak of community. I say that I am happy they do not need the money, give it to your favorite charities. At least then you know the money is being used to better the community for which you care.

I would be remiss in not mentioning VA hospital care. I have discussed in the past how good VA healthcare can be. I implore you to apply. Due to the many law changes in the past several years, if you were denied VA healthcare in the past you may now qualify. If you still don't qualify under the basic application, there are other ways to possibly qualify. Your Veterans service office will have

Whether you are being stoic or have another reason for not investigating and applying for your possibly due benefits, I implore you to think of those you leave behind. Whether it is family or your local community, you could be denying them your assistance with their future.

Anybody ever try to find a member only to discover they transferred? How many times have adjutants or commanders been notified of a transfer? Article VIII, Section 6 of the Department Bylaws addresses membership transfers.

Section $\hat{6}(a)$ states "Membership may be transferred from one local

post to another upon request, giving reason for transfer, and unearned dues remaining with the post of first membership on forms provided for the purpose." Basically, this describes filling out the Member Data Form. If the member has already paid dues for the membership year to the post they are transferring from, the member remains on the previous post's roster for the remaining membership year.

Section $\hat{6}(b)$ states "Any member in good standing in a post moving from the community in which that post is

located shall be entitled to a certificate from their post, stating their membership and duration thereof." This references the Continuous Membership certificate, found on Emblem Sales.

Section 6(c) states "If, within fifteen (15) days after acceptance into membership of a post, any person, who, during the calendar year immediately preceding, was a member of another post, the Post Adjutant shall notify in writing the Post Adjutant of the post to which the person formerly belonged of such acceptance into membership." This is the section that is missing from transfers. If you are using the three-part Member Data Form or filling it out online, one of the parts or a copy of the form needs to be sent to the Adjutant of the member's previous post. This is a courtesy for transparency of the member.

By following the Department Constitution and Bylaws, we can help posts maintain updated records of their members, whether they remain at the post or choose to transfer.





In Memoriam



Janiece M. Fischer August 4, 1930 - November 13, 2023

JANIECE M. FISCHER

Past Department President Janiece M. Fischer died peacefully in her sleep surrounded by loving family on November 13, 2023 at the age of 93.

She met Donald Hendrick at Stevens Point Teachers College in 1948. They married in 1952, pursued careers in teaching, and had five children together (John, Kevin, Mary, Ann, and Lois). Don passed away unexpectedly in 1986. Janiece retired in 1991 after 35 years in the classroom. In 1994, Janiece met Bill Fischer. They married and spent 23 happy years together until Bill passed away in 2017.

Janiece lived life to the fullest – completing her master's degree in education, being actively involved in the Methodist Church in Tomahawk, serving on boards and committees for Central Wisconsin Educators, CESA and WEAC, and traveling to Russia, Africa, Alaska and all over the United States.

Janiece joined Bronstead-Searl Unit 93 in Tomahawk in 1974. Her eligibility was through the service of her husband Donald who served in the Army during WWII, and her father, Emmett Colvin, who served in WWI. Her husband, Bill, served in the U.S. Marine Corps during WWII.

She held many positions at the unit, district and department levels and served as Department President in 1998-1999. Her theme for the year was *Soar Like an Eagle, Be a "Fischer" for Veterans.* For her Testimonial Dinner, she referenced Isaiah 40:31, "They will rise on wings like eagles; they will run and not get weary; they will walk and not grow weak." Janiece Fischer's memory lives on as she soars heavenward.

2024 MIDWINTER RECAP

The American Legion Auxiliary had a great time at the 2024 Midwinter Conference! We had a few guest speakers: VA&R Chairman Bonnie Jakubczyk discussed needs at the VA facilities and how the Auxiliary can help; Adjutant Julie Muhle gave an inspirational speech; President Geiger, Commander Stuvengen, Commander Watry, and Legion Riders Director Doehrmann brought greetings; and Candidate for National Commander Dan Wiley briefly addressed the Auxiliary.

Dan Wiley was extremely impressed by the strong Auxiliary presence and the volume of materials donated for the service projects. He asked how we got such a good response and President Maggie told him, "We simply asked."

Many ALA members also donated pies to a Pie Auction fundraiser.

Department leadership has been visiting the USDVA Medical Centers and WDVA Veterans Homes in Wisconsin, Michigan and Minnesota. In my opinion, things are going well within the system serving our Veterans. While the VA overall still struggles with meeting some of

its missions, the hospitals and clinics in our area are still some of the best the system has to offer. I can report that all USDVA facilities are continuing to expand and fine-tune healthcare to women Veterans. All facilities are expanding community outreach, and working to engage with other providers in their areas to ensure availability of services that our Veterans need, regardless of what those services are or who provides them.

The WDVA Veterans Homes in Chippewa Falls, King and Union Grove are all remarkable facilities, striving to provide the best living environment for Wisconsin Veterans. These facilities offer a wide variety of services and amenities to their residents. All have improved independent living arrangements, to offer a much more home-like atmosphere for Veterans who don't require higher levels of care.

There are a couple of areas of concern we need to address with our elected representatives. Administrators related the effects of financial constraints that prevent them from recruiting and maintaining the very best providers. Another is

Over the last couple of months, your the limits on spending that do not require extra bureaucratic processes. Bidding and higher-level approval are stuck in the 1990s and the costs of goods and services have risen dramatically in the last few years. This makes it difficult to keep projects on schedule, adding months to the completion timeline. While everyone understands the need for financial oversight, the processes providing that oversight need to keep up with reality and not add unnecessary burdens that directly affect the services that can be offered to our Veterans. I ask that you explore these issues and urge our legislators to do the right thing for Wisconsin's Veterans.

> There is one more topic I'd like to address. This is a situation where Veterans can not only help the VA, but also help themselves. There is still a persistent problem with Veterans not enrolling in the VA system. In comparing the estimated total Veteran population to the number of Veterans enrolled, only about one third of that population have signed up with the system. In Wisconsin, of the estimated 317,000 Veterans, only about 104,000 have registered. Whether a Veteran now needs VA healthcare or not is irrelevant. This lack of enrollment will eventually lead to Congress reducing funding to the VA, based on the perceived lack of need. The day will come where almost all Veterans will need something from the VA, and if we don't let our representatives know we are out here, those services will not be available in the future. If you haven't registered, contact our Department Service Office or your County Veterans Service Officer for help.

With respect to Membership, the Detachment is doing very well. As of January 11:

- The Detachment of Wisconsin is ranked fourth in the Nation at 86.7% of our 2024 Membership Goal (3,814 paid members with a goal of 4,398)
- We have 557 more paid members for 2024 than we did at this same time last year for 2023.
 - Of the 3,814 paid members for 2024
 - 376 are new members
 - 3.438 are renewals

If you didn't attend the 2024 American Legion Midwinter, you missed out on some great training and camaraderie. I encourage you to plan on attending next year in January. Also, at Midwinter there were many committee meetings. The Legion Riders are a program that falls under the Americanism Committee, and I reported on our activity from May to October of 2023. Our impact

to the four pillars is as follows: Veterans Affairs & Rehabilitation 3,738 volunteer hours and \$30,233 in donations, National Security 215 volunteer hours and \$9,814 in donations, Americanism 3,795 volunteer hours and \$1,175 in donations, Children and Youth 100 volunteer hours and \$3,500 in donations. This makes for a grand total of 7,848 volunteer hours and \$44,722 in donations. I'll put some context on that by stating that we only had half the districts reporting their work. We have over 700 members across 203 posts in all 12 districts. If you are reading this and you're a Legion Rider, please ensure you are reporting your volunteer work to your district leadership.

The Legion Rider year is just getting started as most districts are in the middle of planning their activities for the year. Now is the time to get involved with them or get them involved with your activity. The planning for the WI Legion Riders - Cruise for a Cause, 'Stu's Cruise-24' is progressing. We will be sending out a mailing to host posts in the next week, this will give them more information for planning and keep the lines of communication open. Plan is to have the website up around March 1 with registration soon after.

During the months of November and December I was invited to visit eight VA facilities in Wisconsin, Iron Mountain, and Minneapolis with Commander Karl. To walk through the facilities was amazing. I had only visited Zablocki Memorial VA in Milwaukee. It was wonderful to see that our Veterans are being treated respectfully

by those around them and the latest medical treatments available at all the facilities. Nursing home and memory care units to those in need are just a few services to help make their lives better.

Our ALA units throughout the state supply so many items to make the lives of those at each facility better! Meeting the ALA representatives and deputies at each facility, listening to them talk about units and its members, always reaching out to make sure Veterans at each facility have what they need, whether it is a blanket, teddy bears, heart pillows, tray favors, articles of clothing, hygiene products or any number of items, brought tears to my eyes. I felt so proud of all of you. I wish all of you would have the opportunity to see what is possible when we stay mission focused - it is mission in action!

Sitting down and visiting with each facility's director, asking them what they need to improve services, and how the Legion Family can assist was very informative. Several of the facilities are in the process of building or renovating their buildings to have clinics, mammograms and other services specifically for women Veterans. Women Veterans are the fastest growing group of Veterans using the VA system.

One overriding concern at the facilities is the lack of Veterans enrolling in the VA Health Care System. The concern is what congress will do if Veteran enrollments continue to decline. Does a lack of enrollment equate to a reduction in funding to our VA facilities?
