Minutes:

Invoices:

A motion to approve invoices was made by Bill Olson and seconded by Steve Harper. With a roll call vote of 4 ayes and 0 nays, the motion to approve invoices passed.

Announcements/communications:

Kathleen has a General Assistance training workshop approaching. T.O.I. Trustees membership is due. A motion to pay this membership fee and cover the payment for the workshop was made by Mike Nolan and seconded by Bill Olson. All were in favor. A Senior Share Fair will be held in April at the White Heath Community Building. There will be vendors with information for Seniors. Kathleen contacted Young's to obtain a cost quote for curbside recycling with no response. Knight reports that newspaper & cardboard is being recycled. Some of the aluminum is sold to a recycle company. Mike prepared a grant application to Illinois Department of Resources in order to receive funding for the land in the park project. Kirby Ambulance Service sent us a bill. Kathleen asked them to come & speak at our March meeting to explain the
