Body contour increases flow of both the lymphatic and circulatory systems, and it also helps with cleaning of the tissues. The main use of body contouring treatment is inch loss, diminishing of cellulite and tightening of the skin.

Typically 6-10 treatments are recommended, spaced 3 days apart for optimal results. Treatment and Results vary by client, for best results follow your before and aftercare.

Natural Touch Contour uses all non-invasive treatments such as Ultrasonic Cavitation, Laser Lipo Pads, RF Skin Tightening, Vacuum Therapy, Sauna Detox Blanket, EMS Sculpting, Vibration Plate & More.

Before and Aftercare

Very Important: Drinking water is a necessary part of the treatment to facilitate the elimination of broken-down cellulite/fat deposits. If you do not drink water you will not obtain results.

- Drink plenty of water, at least 3 liters daily.
- Starting to drink water 2 days prior to your first appointment will aid faster results.
- Cut down Sugars and Sodium Intake.
- Do not drink alcohol on the day of the treatment and within the first 72 hours after.
- Do some light exercise to elevate your heart rate for at least 20 minutes after the treatment to stimulate lymph movement.
- Wearing a Body Shaper/Faja, this helps contour the body.
