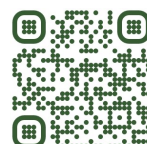

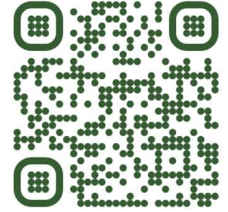

Whether you work in industry, commerce, private practice or the public sector, ADIT can help you enhance your professional profile and credibility.

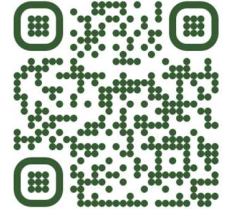

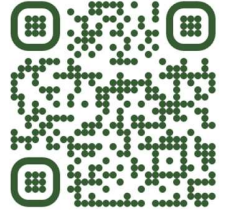
Section 5.00: Not Sure Where to Start? Your Guide

Note sure about which paper to start from?

Think about the following questions: -

1. Do you have previous Transfer Pricing “TP” experience (+2 years at least)?
If yes, then you’ll go for Transfer Pricing training first.
If no, go to next question
 2. Do you have previous International Tax experience (+2 years)?
If yes, then you’ll go for international tax paper first.
If no, go to the next question
 3. Do you have neither International Tax nor Transfer Pricing experience?
If yes, then you need to assess yourself as following: -
 - A. If you have indirect tax experience, then go for international tax training
 - B. If you have corporate tax experience (+4 years), you have two options
Plan 1) Go for International Tax training (preference)
Plan 2) Go for Transfer Pricing training (less preference)
 - C. If you have ‘passion’ and ‘willing’ to learn Transfer Pricing, then go for the training
 4. Do you have both International Tax and Transfer Pricing experience?
If yes, then join both, don’t hesitate to do it.
- If you’re a lawyer or a legal adviser, it is recommended you start with International Tax Training.
 - If you don’t have tax experience, then think about you might need to get a perquisite – we have crash courses for those who want to accelerate their knowledge before attempting ADIT.
