Troy Hunsucker with Wyoming CLASS & Peaks Investment Management spoke about the investment opportunities for public funds.

Department Updates:

- Linda Frye reported she is working on the Safer Grant for the Fire Department that is due March 17th and the Homeland Security Cyber Security Grant due April 3rd. James interjected stating Cyber Security Grants will be awarded in June or July. If awarded, it is 100% money available around October 1st.
- Mayor Lytle reported the Town is pushing through our CCL Street application for \$5.8 million for the June meeting.
- Officer Jay Owren gave a report on Police Department statistics for February. He reported they purged the evidence room. Working with DCI for destruction of evidence. Working with Secret Service to destroy counterfeit currency. Goshen County can no longer keep evidence for Niobrara County, working to pick that up.
- James Santisteven weighed in on the Cyber Security Grant update. He reported he is working on the Mitigation Grant that is renewed every 5 years. Our policy ends June 2024. We are in a ground with Natrona and Converse. Will be scheduling a kickoff meeting, workshops and a public forum. Mayor Lytle shared that Todd is on the Board and is the Town's Representative. James shared that Chantry is the Fire Department and District Representative.
- Desirae LeLeux reported working with USDA and Bond Council finalizing documents for the Interim Financing loan closing. Doug, Todd, Linda and Desirae attended the Local

Government ARPA SLIB meeting last week in Cheyenne and the Town was awarded \$5 million of the \$7 million grant applied for. The Town has requested the remaining \$2 million to be considered in the money approved by Legislation for ARPA Grand Fund increase. The Water/Sewer ARPA Grant Program received an additional \$30 million, and the Local Government ARPA Grant Program received an additional \$15.3 million. Requesting application #2 for the Vac Truck and Sweeper be considered, as well. Started medical insurance renewal for next fiscal year and there is a 9.5% increase. Starting budget process this month. Advertising for a consultant for the Lusk Safe Pathways TAP Project. That selection process will be at the end of March. Bid opening for the Airport Snowplow is March 29th. Details are on our website for both. Interviewing for the Utility Billing Clerk position.

• Todd Skrukrud reported they have been working on ice removal. Contractors are trying to have a meeting this week. Starting back up on the 13th with sewer on Maple/Poplar. Hired Trevor Barner as the Golf Course Superintendent and will be working on inventory and irrigation. He reported the mayor is working with Lisa Shaw on a Conservation District Grant using inmates from the honor farm to help clean up the river between the Golf Course and coming through town.
